Bids will be opened and publicly read aloud immediately after the Bid Closing time and date at Tigard City Hall.

A Non-Mandatory Pre-Bid Conference will be held at 10:00 AM, local time on July 18, 2017 at 12533 SW Main St, Tigard, Oregon, 97223.

The project generally consists of the following:
