opt-out rates in individual schools, and outlined how states would have to handle the 'school quality' indicator in ac-

countability systems," according to the Education Week blog post.

Opponents of the Republican-led rules change said, "that the move was unnecessary, would create confusion in states about whether and to what extent their

ESSA accountability plans comply with the law, and could endanger crucial protections for disadvantaged students."

In the report, researchers with the Leadership Conference Education Fund said that the findings of the "New Edu-

cation Majority" poll, should be a clarion call for advocates and policymakers who must come to terms with the fact that a successful education policy must be re-

sponsive to the needs of Black, Latino and Asian children, who make up a majority of public school students in America.

Researchers recommended opening the de-

cision-making processes around educational policies to Black and Latino families, especially decisions regarding priorities and funding, bias and training.
