propped up cigarette sales and kept millions of Americans smoking. Although the adult smoking rate has fallen to an all-time low of 15 percent, smoking remains the nation's leading preventable cause of death and illness, responsible for about one in five U.S. deaths.

Anti-smoking groups also point to Big Tobacco's history of manipulating public opinion and government efforts against smoking: In 2006, a federal judge ruled that Big Tobacco had lied and deceived the American public about the effects of smoking for more than

50 years. The industry defeated a 2010 proposal by the FDA to add graphic warning labels to cigarette packs. And FDA scrutiny of menthol-flavored cigarettes — used disproportionately by young people and minorities — has been bogged down since 2011, due to legal challenges.

“We're not talking about an industry that is legitimately interested in saving lives here,” said Erika Sward of the American Lung Association.

But some industry observers say this time will be different.

“The environment has changed, the technology has changed, the companies have changed — that is the reality,” said Scott Ballin, a health policy

consultant who previously worked for the American Heart Association.

Under a 2009 law, the FDA gained authority to regulate certain parts

of the tobacco industry, including nicotine in cigarettes, though it cannot remove the ingredient completely. The same law allows the agency to scientifically review

and permit sales of new tobacco products, including e-cigarettes. Little has happened so far. Last year, the agency said it would delay the deadline

for manufacturers to submit their vapor-emitting products until 2022.

REQUEST FOR STATEMENT OF QUALIFICATIONS

Portland Mall Management, Inc. (PMMI) is a not-for-profit public benefit corporation under contract with Tri-County Metropolitan Transportation District of Oregon (TriMet) to provide certain maintenance services, cleaning and security of the Portland Transit Mall (5th and 6th avenues between NW Irving & SW Jackson).

PMMI is seeking Statement of Qualifications (SOQ) from qualified contractors for the following work:

- 1.) Monthly repair & replacement (as needed) of sand-set pavers at intersections on SW 5th & 6th avenues between SW Montgomery & NW Irving streets;
- 2.) Annual repair to concrete track-slab (as needed) on SW 5th & SW 6th avenues between NW Irving Street and SW Jackson Street;
- 3.) Annual repairs for cobblestone and hard-set pavers (as needed) on SW Yamhill & SW Morrison streets, and on NW & SW 1st Avenue;
- 4.) Miscellaneous routine maintenance (as needed) such as: removal and installation or general repairs to Transit Mall trash containers; installation of bike racks; installation and/or removal of Transit Mall benches; relocation of concrete planters; removing or cutting tree grates to size.

One or more qualified contractors will be selected to negotiate a flexible services contract based on specific task orders to be negotiated and issued as needed for inspection and maintenance services. If a contractor enters into a flexible services contract, no guarantee is made that any task orders will be issued. PMMI retains the right, in its sole discretion, to terminate negotiation of the flexible services contract and commence negotiation with another qualified respondent to this request for SOQ or to reject all proposals.

The anticipated services required include the following:

1. Intersection Sand Set Pavers. Participation in monthly inspections of sand-set paver intersections on SW 5th and 6th avenues between SW Montgomery Street and NW Irving Street for defects or maintenance requirements. Inspections scheduled by PMMI with City of Portland and TriMet staff to participate as appropriate. Based on these inspections specific task orders will be issued; task orders may include resanding of paver joints, replacement of damaged pavers, and/or removal of sections of pavers and bedding sand to be replaced with new bedding sand and pavers including sanding joints. Specific work program and methodology for paver maintenance in conjunction with the City of Portland and TriMet shall be maintained. All materials shall be sourced by the contractor and stored at the contractor's warehouse. Pavers will be made available by the City of Portland for purchase & pickup by the contractor. This work also includes obtaining trackway access permits from TriMet, and traffic control and flagging permits from the City of Portland as may be required.
2. Mortar Set Pavers/Cobblestones. Participation in annual inspections of SW/NW 1st Avenue and Yamhill / Morrison Max loop with TriMet, PMMI and City of Portland staff. Based on these inspections specific task orders will be issued which may include demolition, removal and installation of mortar set brick pavers and/or cobblestones. All materials shall be sourced by the contractor and stored at the contractor's warehouse. Pavers will be made available by the City of Portland for purchase & pickup by the contractor. This work also includes obtaining trackway access permits from TriMet, and traffic control and flagging permits from the City of Portland as may be required.
3. Track Slab Repairs. Participation in annual inspections of concrete track-slab on 5th& 6th avenues between NW Irving and SW Jackson. All materials shall be sourced by the contractor and stored at the contractor's warehouse. This work also includes obtaining trackway access per-

mits from TriMet, and traffic control and flagging permits from the City of Portland as may be required.

4. Routine Maintenance / Miscellaneous Repairs. Routine maintenance as needed on the Transit Mall such as: installation / removal of bike racks; installation / removal of trash containers; repair to trash containers; installation / removal of Transit Mall benches; removal or cutting to size tree grates as needed.

Other general maintenance repairs as needed from time to time. Trash containers will be provided by PMMI; contractor shall receive delivery of product and store doors and containers at their warehouse.

Generally, work described above is planned well in advance, however if there are urgent repairs needed the contractor selected shall be able to perform required work within 24 hours of notification from PMMI.

Interested contractors are requested to forward a Statement of Qualifications that includes the following information:

- Name, address, phone number, and a brief description of the firm.
- Identify the work areas from list (items 1-4) above for which you are submitting qualifications; proposers may submit for all work listed above or identify specific sections.
- One page narrative outlining the firm's interest, technical expertise and specific qualifications related to the required work as described on the list (items 1-4).
- A description of previous projects that significantly demonstrate the firm's track record for completing similar work in a downtown urban environment, on time, and on budget; and when required on short notice.
- A description the firm's safety record with similar contacts.
- Insurance coverage certificate demonstrating required coverage as identified on the attached.
- Resumes of key personnel anticipated to be assigned to the project.
- Provide name of company and brief description and role of any proposed subcontractors.
- Name and title of person authorized to negotiate and execute a flexible services contract of behalf of the firm.
- In a separate sealed envelope provide a list of hourly wages and classification of staff expected to be assigned to the project; identify mark-up percentage. Title the separate envelope, WAGES with your company name listed on the outside.

A subcommittee of the Board of Directors of PMMI will evaluate the submittals based on the following criteria:

- Specialized experience or technical expertise of the firm and its personnel in connection with the proposed services.
- Capacity of the firm to accommodate work under intermittent task orders and /or on short notice.
- Familiarity with and experience working in the downtown urban environment conducting similar work.
- Past record of performance on contracts to safely perform the work.
