old longtime Atlanta resident said. "I plan on having them come to my Super Bowl Live event and speak to the crowd and tell their story about police brutality in the city and let people understand that I'm supporting them as much as possible."

Dupri was initially criticized after he partnered with the Super Bowl host committee to produce a series of free concerts at Centennial Olympic Park, located a couple of blocks from where Super Bowl 53 will be held at the Mercedes-Benz Stadium.

The Super Bowl is one of the world's biggest sporting events. But some are looking to boycott the big game after the halftime show has been the topic of a heated debate since Kaepernick, who has not been signed by an NFL team, said he would not stand for the

national anthem in protest of racial discrimination against blacks in the United States. Last summer, the NFL implemented a leaguewide policy that players must stand for the national anthem.

Some, including Rihanna and Pink, have reportedly turned down offers to perform during this year's halftime. Jay-Z alluded to his feelings in a recent song that he declined to perform at the Super Bowl, and Amy Schumer refused to appear in a TV ad during the

Cardi B said she won't take the Super Bowl halftime stage until Kaepernick gets a job, but she will perform at a downtown concert next week.

Maroon 5 will be joined by Atlanta-based rapper Big Boi and Travis Scott during the halftime performance.
