and try to impeach him, he said he would "head to the Supreme Court" for help.

Portraying himself as unjustly persecuted in the aftermath of special counsel Robert Mueller's probe, Trump said his White House would refuse to cooperate with further congressional investigation.

"I thought after two years we'd be finished with it. No, now the House goes and starts subpoenaing," Trump said.

## 2020 Democrats Confronting Debate Over Letting Felons Vote

Democratic presidential contenders are facing a new debate over whether criminals in prison, even notorious ones like the Boston Marathon bomber, should be able to win back their right to vote.

Vermont Sen. Bernie Sanders says that they should and that voting is "inherent to our democracy — yes, even for terrible people." Many of his rivals for the 2020 nomination aren't as sure, and at least one opposes the idea outright. Sanders himself acknowledged that he was essentially writing an attack ad for Republicans to use

against him through his support for the issue.

The question illustrates how Sanders continues to stand to the left of the other candidates as he endorses giving all prisoners, including those convicted of heinous crimes, the right to vote. Prodded by criminal justice activists, Democrats have largely embraced the politically safer cause of winning back access to the ballot box for felons who have served their time.

"Sen. Sanders is taking it one step farther than most campaigns have," said Mark Mauer of The Sentencing Project, a group that advocates letting prisoners vote. "Even if you're sitting in a maximum-security prison, you retain most of the fundamental rights of a U.S. citizen."

## NRA Beset by Infighting

The National Rifle Association is used to battling forces that criticize its fiery and unbending efforts to protect gun rights.

But as the group gathers for its annual convention this week, the NRA may be facing its toughest foe in decades: its own members.

NRA insiders and longtime observers describe an organization at war with itself over a central question: Has it strayed too far from its original mission of gun safety and outdoor shooting sports and become too

political?

It is rare for the NRA to betray any hint of internal turmoil. But it erupted very publicly recently when the NRA sued its longtime public relations firm, Ackerman McQueen, accusing

it of refusing to hand over financial records to account for its billings.
