Boseman ended his heartfelt speech by driving home the impact that Washington made in his

early acting career, saying: "There is no Black Panther without Denzel Washington."

### WASHINGTON PAYS TRIBUTE TO 'REAL LOVE'

After nearly two hours of Hollywood's biggest stars dutifully praising and thanking Washington for his contributions to the entertainment industry and to their lives, Washington took the stage to accept his AFI award and turned the spotlight on to someone else: his wife. He sang

Pauletta Washington's praises as a musician, mother and wife and asked the audience to give her a standing ovation, which they happily did.

"Forty years of sacrifice. Forty years of forgiveness. She taught me about faith, spirituality, love — real love, unwav-

ering love in spite of myself," Washington said. "I would not be alive without Pauletta Washington."

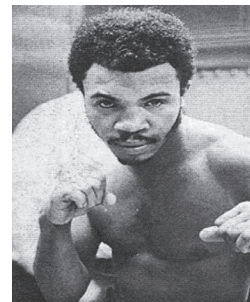
