SOMETHING ABOUT HEALTH.

Pendleton People Unusually Healthy Under Bad Conditions—Reform Needed, However.

The fact has been greatly deplored by some that Pendleton is sadly deficient in the matter of drainage, etc.—that standing pools of water under sidewalks, filth in back yards, and accumulations of debris everywhere, is destined to breed disease and pestilence. While the foregoing gloomy facts may all be too true, it is still a self-evident truth, confirmed by Pendleton's physicians, that the death-rate of the town is surprisingly low. They themselves cannot explain this anomaly, considering the disease-breeding germs that must abound in the many cesspools and filthy places, but they do testify to its being a fact. It is only explained on the hypothesis that there must be an element in the soil or mayhap in the climate, that acts as a disinfectant, and counteracts the effect of disease germs. Another safeguard lies in the loose, gravelly soil, which allows the filth to escape, and in itself makes a fine sewerage system. Anyway, Pendleton's inhabitants need not be alarmed, for if there is anything in statistics, they are on an average remarkably healthy. Still the need for all necessary precautions is evident, and too much attention cannot be paid by the city government to ward off possible danger from the foregoing bad conditions. A "board of health" would be a good step of reform in this direction.

AN INJUNCTION SUIT.

Some Complications Regarding County Property and the New Court House.

A complaint for an injunction suit against the continuance of the sale of the court-yard lots, and of the building of the new court house on College block, was filed to-day in the clerk's office. The suit is brought by the State of Oregon against Umatilla county, and is practically a duplicate of that brought by private parties some time ago, which was "knocked-out" in the courts. The complaint sets forth that when the present Court House block was decided to the county by Moses Goodwin and wife, it was intended to be used in the future for county purposes alone, and that the county court was breaking faith with the grantors by selling the property for the use of private individuals. It is further set forth that College block was decided to the county by the same parties for county educational purposes, and that the erection of the new court house thereon is contrary to all justice, and is practically a breach of promise. The outcome of the matter is yet uncertain, and will be watched with interest. If an order of injunction is served, all work on the court house building must cease until the case is decided.

A Change of Agents.

To-morrow Pendleton loses one of its best and most respected citizens, although another has stepped into the ranks to take his place. Mr. W. C. Allaway, who has been agent for the O. R. & N. in Pendleton since October, when he was transferred from Weston, will leave Pendleton to-morrow for The Dalles, having been promoted to a more remunerative situation at that place by the company. It can be said truthfully of Mr. Allaway that no previous agent at Pendleton has given more satisfaction, or shown more kindness, courtesy and thoughtful consideration to the traveling public. He is universally esteemed as a citizen and as a public servant, and in both capacities he has shown his splendid qualities as a man. His loss will be keenly felt, and The Dalles cannot be too greatly congratulated on its acquisition. Always agreeable to his friends, and courteous to strangers, Mr. Allaway would win the respect and esteem of the people in any locality. The East Oregonian bids a hearty, yet sorrowful farewell to Mr. Allaway, and welcomes the stranger who succeeds him, Mr. H. B. Sibley, of Baker City, for a year or more agent at that place. From all accounts Mr. Sibley is a gentleman in every respect, and he needs no further recommendation.

Northwest Washington.

G. A. Hartman and H. McArthur have returned from their tour of Northwest Washington. Mr. McLeod remaining a day or two longer. The gentlemen thoroughly explored the prospects and advantages of this region, besides enjoying greatly the pleasures of the trip. Mr. Hartman reports that portion of the Territory visited, the Northwest country, as a poor one for investments, property of all kinds being held higher than present outlooks would warrant. Whatcom, the county seat, is in the near neighborhood of two other little towns, and all three can be easily seen from one point. Which one will make the town is a matter of doubt, and all investments are therefore very uncertain. Farming lands in this section are very productive, and an offer of less than \$100 per acre would be an insult to their owners. In marked contrast to the high price of travel on land, was the cheap rate of water passage from Tacoma to Whatcom, the fare being only \$1.00 for 120 miles.

The Great Tent Act.

McMahon's circus gave a startling exhibition at Centerville yesterday, which was not down on the bills. It was the greatest tent act, that structure collapsing completely and falling to the ground, caused probably by a heavy wind at that place. The big show had just concluded, and the concert had commenced when the accident happened. A good many people had remained in the tent, but it luckily fell in such a manner that no one was hurt. The audience got mixed up promiscuously with tent-poles and poles, pulleys, trapezes, crows, etc., but on disentangling the combination it was discovered that not a soul was seriously injured. The wreck was soon cleared up, the audience went home "pleased and satisfied," and the great circus proceeded on its way. It seems almost miraculous that such an accident would happen without loss of life.

Rapid Progress on Hunt's Railroad.

John Lawry, a member of the cross-sectioning party on the advance flank of the Walla Walla branch of Hunt's railroad, has obtained a furlough and is now in town on a two-weeks' visit. He reports that cross-sectioning work on the branch is now completed to Walla Walla. Grading is nearly finished as far as the Touchet, camps of railroaders being scattered all along the line, grading by sections, and work is progressing rapidly. Track is laid twenty miles from Wallula, and the parallel bands of iron are being extended as fast as brain and muscle can do the work. The shriek of the locomotive is now heard on this branch, construction trains being now running on the completed track. From the head engineers down to the lowest laborers, every nerve is strained to finish the road as rapidly as possible, and it is thought that the first train will reach Walla Walla sometime in December. The agreement with the people of Walla Walla calls for the completion of the road by January 1st, and the necessity for its fulfillment occasions the present rapid progress. Nothing definite could be learned of the branch of Hunt's railroad in his direction from Helix. It will not come to Pendleton, however.
