PAGE VS. PAGE.

A B Ief Summary of the Points in an Interesting Divorce Case.

Divorce cases are always interesting, and one is now pending which, owing to the length of the testimony taken, and the prominence of the parties involved, is worthy of a better fate than to be filed away in a pigeon-hole in the clerk's office, to be forgotten by all save the principals. The case of Thomas P. Page vs. Frances Ellen Page is referred to, a brief sketch of which is appended for the edification of the EAST OREGONIAN's readers:

Thomas P. Page, the plaintiff, is a white man of Irish descent, who has long figured prominently in the history of Eastern Oregon. In fact, every one knows "Tom Page." His wife, the defendant, is of mixed white and Indian descent, and can claim good blood from either ancestry. Her father was Joseph Gale, one of the first provisional governors of Oregon and a noted man in his day. He was one of those early explorers who emigrated from the far East under the famous Captain Bonneville. Mrs. Page's mother was a fine descendant of the celebrated Walla Walla chieftain, Peo-Mox-Mox, who was killed about twenty-five years ago at the battle of Walla Walla; so it can be seen that the Indian blood which flows in her veins is of the very best.

By virtue of her Indian descent, Mrs. Page was entitled to take up land on the reservation and did so, and in 1886 she and her husband were living on the farm she had selected, a fine piece of land about three miles from Centerville. It seems, however, that they were not living in the same house during their residence there. There were two residences, in one of which Mrs. Page lived alone. In the other house her husband lived, having for his companion another woman by the name of Grace Darling, who seemed to have captivated him completely. Although Mr. and Mrs. Page did not occupy the same house, Page managed his wife's ranch and superintended the farming operations.

In the latter part of the summer of 1886, the rumor got abroad that Page had formed the design of eloping to Arizona with this Grace Darling, who is described as being a very handsome and fascinating woman. About the time this rumor became in circulation, Page obtained possession of all the wheat harvested from the ranch of his wife, over 20,000 bushels, and had it stored at Adams, off the reservation, where it was outside the jurisdiction of the Indian authorities. After disposing of the wheat, he turned his attention to the stock, running all the horses, to the number of about eighty head, over into Washington Territory. He sold all his real estate, which he owned in various portions of the Inland Empire, and moved himself and Grace Darling and their personal belongings to Centerville.

These circumstances gave credence to the rumor that there was an elopement on foot, and the good people of Centerville were not a little excited over the episode.

When Mrs. Page got wind of this report and discovered that all her property had been shipped from the ranch, she made a trip to Portland and induced the officers of the United States court to take a hand in the proceedings. These officials seized the wheat at Adams and took steps toward bringing back the horses which had been spirited away, interfering considerably with the suspected elopement. An agreement or compromise was then made between Mr. and Mrs. Page by which the wheat was to be applied to the debts of both parties, and the horses, cattle and other property were to be divided equally between the two.

This division of property was made in September last. In the meantime, Mr. Page brought a divorce suit against his wife, charging her with desertion, with interfering with his business relations, with injuring his credit by seizing the wheat, and with cruel, inhuman and personal indignities which made his life burdensome. These indignities, etc., are alleged to have been the calling of him a scoundrel, ruffian, libertine, and the like by his wife.

The divorce suit was brought by Cox & Minor. The defendant employed as her attorneys Col. Wm. Parsons and Ramsey & Wager. She put in as defense to Mr. Page's suit for divorce the allegation that her desertion of the plaintiff consisted simply in her refusal to allow him to keep the woman Grace Darling in the house as a servant girl, when she was in reality occupying a closer relation, and that as soon as Page had removed the servant girl from the house to place her in another residence on the same ranch, the defendant returned to her home and remained there.

The defendant then brought a cross-bill against the plaintiff, charging him with criminal relations with Grace Darling, and the parties have been taking testimony before R. J. Slater, Esq., the referee, since about the first of November, to substantiate their respective claims. Five witnesses have been examined thus far and upwards of a thousand pages of testimony taken, probably the largest amount ever written before in Eastern Oregon in a case of like character. Although much has been done, the work is not yet completed, and owing to the number of witnesses yet to be called the evidence will not be finished in time for the referee to make his report at the approaching session of the circuit court. It will not be disposed of until the May term.

There is but one minor child, a girl about thirteen years old, and each party asks the court for her custody. The defendant also asks the court for several hundred dollars' alimony, and for the support of the minor child.

At the previous session of the court, the judge ordered the plaintiff to pay \$200 to the defendant to assist her in making the defense, which was duly paid. No matter which side is successful before the circuit court, the case is so stubbornly contested that it will probably require a decree of the Supreme court of the State to settle it.

It is estimated that the litigation in which they have become involved will cost the parties interested not less than \$4,000 before the end is reached, for referee's fees, court costs, witnesses' expenses and attorneys' fees.

The principals are both of the highest

standing, and it is to be regretted that the unfortunate affair has brought them into publicity. Page has occupied many positions of trust and responsibility during his long and active career in Oregon and Washington Territory. Mrs. Page and her family have at all times deservedly moved in the highest social circles in Walla Walla and in Oregon.

The above is merely a rough sketch of the now celebrated case and the causes which brought it about. There are many minor phases left unmentioned which would be interesting in the extreme, and indeed an imaginative writer could weave a novel from the material afforded him by a perusal of the thousand pages of testimony and other matter; but this much is all the EAST OREGONIAN is able to give.
