PROVISIONS FOR PURE ELECTIONS.

What the Law of Oregon Will Do to Any Man Who Bribe Voters.

In order that the people may know just what are the penalties for attempting to bribe or unduly influence voters in an election in this state, the following provisions of the statutes are here printed. Their reading will be of interest to all, regardless of party and personal interest in the campaign. The sections of the law referring to this subject are as follows:

Section 1843—If any person shall give, offer, or promise to give any gift, gratuity, valuable consideration, or thing whatever to any voter of this state, or shall promise to do so, or cause to be done any act beneficial to such voter, with intent to influence or induce such voter to vote at any legally authorized election in this state for or against a particular person or candidate, or in a particular way, such person shall be punished by imprisonment in the penitentiary not less than one year nor more than five years, or by imprisonment in the county jail not less than three months nor more than one year.

Section 1844—If any voter of this state shall accept any gift, gratuity, valuable consideration, or thing, or any promise thereof, or any promise to do so, or cause to be done any act beneficial to such voter, with the understanding or agreement, express or implied, that such voter will, at any legally authorized election in this state, give his vote for or against a particular person or candidate, or in a particular way, such voter shall be punished by imprisonment in the penitentiary not less than one year nor more than five years, or by imprisonment in the county jail not less than three months nor more than one year.

Section 1845—If any person shall vote, or offer to vote, at any legally authorized election in this state, knowing himself not entitled by law to vote thereat, or shall vote, or offer to vote, at any poll or in any precinct at any such election, knowing himself not entitled to vote at such poll or in such precinct, such person, upon conviction thereof, shall be punished by imprisonment in the county jail not less than three months nor more than one year, or by fine not less than \$100 nor more than \$500.

Section 1848—Any person who shall by promise of favor, or reward, or otherwise, induce or persuade any person to come into this state, or into any county or precinct within this state, for the purpose and with the intent that such person shall, by so changing his habitation, vote at any general election which may hereafter be held in this state, at any place where such voter or person is not a bona fide resident, shall be deemed guilty of a felony, and upon conviction thereof, shall be punished as hereinafter provided.

Section 1849—Any person shall also be deemed guilty of a felony who shall by promises of favor, or reward, or otherwise, induce or persuade any voter within this state to absent himself from his actual and bona fide place of residence with intent to prevent or hinder such person from voting at such place of residence at any general election in this state.

Section 1850—Any person who shall, in the manner provided in the preceding section, induce or persuade any legal voter to remain away from the polls, and not vote at any general election in this state shall, on conviction, be deemed guilty of a felony.

Section 1851—Any person, upon conviction for a violation of either of the preceding sections shall be imprisoned in the penitentiary not less than one year nor more than three years, or shall be fined not less than \$100 nor more than \$1000, or shall be punished by both such fine and imprisonment, in the discretion of the court, and shall be forever ineligible to hold any office of trust or profit in this state.

Section 1910—It shall be unlawful in this state for any person to barter, sell, give away or in any manner dispose of any intoxicating liquor on the day of any general or special election of state, county or municipal officers, with the state, district, county or corporation in which such election is held.

CENSUS TAKING BEGINS FRIDAY.

People Should Help the Enumerators to Make Census Complete.
On Friday next, June 1, the 1900 census begins all over the United States. Cities must be finished by June 15, the country having until July 1 before the returns are all in. Here in Pendleton, two enumerators, Harold H. Horton and Peter West, will do the work. Pendleton people should assist the enumerators in every manner possible. The securing of complete returns is probably more important than the average person suspects, as will be seen from the following from the supervisor of the census in the second district: The people are to be counted at their places of residence, but as many persons and families will be away from their homes during June, they will not be counted. If they are not counted, the locality in which they live will be misrepresented to that extent, and in some cases this misrepresentation may be enough to affect the representation in congress of the state from which they come. Localities, therefore, should influence all such absentees to take reasonable precautions against being omitted from enumeration in their places of residence. Such omissions are most likely to occur in the large cities, and elsewhere for the summer. The occurrence of the Paris exposition this year is likely to increase the number absent from the country.

In Case You'll Be Away.

In all cases of contemplated absence the head of the family is requested by the census office to communicate with the supervisor of the district in which he lives. He is also requested to leave information regarding his answers to the questions which are to be asked with some responsible neighbor, who will agree to see that it reaches the enumerator on his rounds. Such information might be left as a memorandum in writing, as in that case it is less likely to be overlooked. The questions to which answers are desired apply primarily to the population, but also to all farms and manufacturing establishments. They are be-

QUESTION OF AMATEURS AND MONEY.

Pendleton Team Prefers Medals to Being Made Professionals.

The question has been raised as to the status of an amateur athlete competing for a cash prize, and retaining his standing as an amateur. The raising of the question was due to the offering of cash prizes by the Pendleton-Weston field day sports. The matter was probably overlooked by the management there, for it is not likely that they would willingly induce young men permanently to be taken from the amateur class and made professionals. Should this be done, any of the students competing and in later years going to higher institutions of learning would be forever barred from participation in any of the athletic events.

A case has come up at Eugene, the seat of the University of Oregon which illustrates the trouble caused in other places by the competition of amateurs for cash prizes. A Portland correspondent writes this from Eugene: "It is reported a protest has been entered against the entry of Duke Knox and C. W. Jackson in the intercollegiate athletic contests, to be held at Salem next Saturday. The protest is made by the agricultural colleges at Corvallis, and is based on the ground of alleged professionalism, it being alleged that Knox and Jackson at one time engaged in a contest in Cottage Grove for a money consideration. They both feel confident of their ability to disprove the charge made against them, and will present evidence in defense of their cases."

If your face is of Grecian mold and fair as the Saxon beauties, he will ask if you are black or white. Neither your dress nor your trousers will preclude the question as to your sex. A babe at the breast will not prevent his asking if you are a mother. And so the questions run. Women of more or less antiquity are asked, on government authority, their age, and they disregard the common wisdom of the nation, upon conviction thereof, shall be punished by imprisonment in the penitentiary not less than one year nor more than five years, or by imprisonment in the county jail not less than three months nor more than one year.
