Fred Dubois has an excellent chance of being elected United States senator from Idaho. The fusionists appear to favor him. Dubois is a man of considerable ability and a politician of much skill.

We are getting our foot into a very deep hole filled with a very bad mess in China. We are likely to form an entangling alliance which will plague us for years to come. Our mistakes in the Philippines are beginning to bear fruit. Further we have gone into a bad business worse and worse it has become. Republic or Empire, which?

Charles S. Voorhees, of Spokane, is being strongly urged as the democratic fusion candidate for governor of Washington. At first he said he would not accept the nomination, but now he says he will. His chances of election are brighter, since the adjournment of the Kansas City convention. Voorhees is the son of the late Daniel W. Voorhees, of Indiana, and a man with much of the ability of his illustrious father.

Colonel Emerson H. Lissom, the first American officer to be killed in the fighting in China, was a typical American soldier who had fought in four wars. That the latter statement can be made of a man who volunteered and first saw service in the war of the rebellion may prove rather startling to the thoughtless, but such is the fact. Colonel Lissom was wounded at Gettysburg and at San Juan Hill, he fought in the Philippines and was killed in China, and, even though we are not actually at war with the Chinese government, a state of war certainly exists in the Chinese empire. And he was one of the unfortunate victims of it.

C. E. S. Wood, a prominent attorney of Portland, and a sincere man at all times, will support W. J. Bryan for the presidency on the issue of imperialism and militarism, although he opposed him on the silver issue in 1896. Mr. Wood is not the only gold democrat in Oregon to come back to the fold, but there are many others, who prefer to keep their paws and thus escape the unpleasantness of being pointed out as a prodigal. It is not altogether unreasonable to expect Oregon to give her electoral vote to Bryan and Stevenson, in spite of the result of the June election, when about 12,000 Bryan votes remained away from the polls because of the lack of interest in the issues of that time.

In 1893 the democratic convention of Nebraska endorsed President Cleveland demanding repeal of the purchasing clause of the Sherman act. Thereupon W. J. Bryan, who was a member of the convention, arose and made a speech, in which he said in part: "Gentlemen, I know not what others may do, but duty to country is above duty to party. If the democratic party, after you go home, endorses your action and makes your position its permanent policy, I promise you that I will go out and serve my country and my God under some other name, even if I must go alone." Bryan kept the faith. He went out and the people knew he succeeded beyond his wildest dreams. He proved himself then and there a man of conviction; sincerely interested in the good of his country and its people. Today the party is be-

ing Spain, La Puentz, an Augustinian friar, expressed his opinion of the whole thing when he said: "Against the gain of redeemed souls I place the cost in the loss of armadas, and of the soldiers and of friars sent to the Philippines, and these I count the chief loss, that while mines give silver and forests give lumber, only Spain gives Spaniards, and she shall give many of them that some day she shall be left childless and forced to bring up strangers' children instead of her own."

This heresy of imperialism is the most dangerous that has arisen since the heresy of secession, and it must be fought as vigorously as the heresy of secession. If we admit as citizens any number of millions of people that are not ready for liberty, if we admit them with all the degradation which they must bring into our politics, we must take the consequences.

It is better that we should be just and faithful to our own principle and to the principles of God, and that we should in our laws be no respecters of persons, because if in our laws we are respecters of persons we must go the way of empire, as all empire has gone.

Our danger is illustrated already in Puerto Rico. The tariff discussion in Puerto Rico violently agitated the American people because they instinctively felt it was simply the introduction of the thin edge of the wedge of imperialism, the beginning of the contest between the American government and the American people. It is the introduction of the principle that congress, who is a creature of the constitution, and the present, who is a creature of the constitution, have certain powers that have been delegated by the people that are not given by the constitution, powers claimed to come just as the powers of all despots come, from the hands of providence.

The best way in which the growth of any man or nation has ever promoted has been through self-government, democratically looking after its own affairs. We do not expect that self-government will always be good government. Men learn not by their success, but by mistakes. It is absolutely impossible for any republic to conduct any affairs well except its own.


