PEOPLE WHO ARE HERE FOR A DAY.

G. W. Hunt and his two sons, C. C. Hunt and C. L. Hunt, are at the Hotel Pendleton. Mr. Hunt, as was stated in the East Oregonian sometime ago, has not learned of his son, Charles, who went to the Klondike during the summer of 1897, or who started for the Klondike and was heard from at Skagway, on route to the interior. Mr. Hunt is quite desirous that anyone in other places having information regarding his son, during the fall of 1897 or during 1898 communicate with him. Milton B. Runkle, the fat boy from Walla Walla who boasts that he weighs within five pounds of as much as Dan Shultz, the popular O. R. & N. passenger conductor on the Spokane run, is now a "peanut butter" on the train. He was here Wednesday night. Runkle is monstrous and weighs something more than 250. He was selling peanuts and chewing gum the other day on the same train of which Mr. Shultz was conductor, and so the other trainmen assert, the two attempted to pass each other in the aisle. Just as they made the attempt, the train gave a lurch as it passed over a bad piece of road, and the two got wedged between the seats. A wrecking car extracted them easily, and the two passed on to their respective duties.

T. P. Wagner, an O. R. & N. engineer, is here today, having come to assist in some emergency work at the office of Superintendent C. A. Cameron, of the department of bridges and buildings. Mr. Wagner was one of the engineers who were stationed at Walla Walla during the construction of the Snake river cut off last year, and can tell some tales of nightly holdups and knockdowns that would make excellent material for yellow back novels. At Walla Walla congregated a large number of roughs and toughs who, like vultures gathering in flocks to feed on carrion, came to feed off the working men, who were employed on the construction work along Snake river. The men would work during the week, receive their pay on Saturday night, come to Walla Walla and there spend every dollar and take on "a jag" of substantial proportions. Monday morning they would be loaded onto a hayrack and carted out to the grade and dumped down by the track, where they again would go to work, laboring another six days, only to come again to Walla Walla on Saturday night to repeat the performance and turn over all their money, the savings and a large part of it to the slingers who had there assembled. A night without six holdups was very quiet, and when several men were not knocked down and left on the ground all covered with blood, minus their money, the people living there wondered what was the matter with Walla Walla, and whether or not it hadn't reformed. Guns and swords and pistols of all description were the arsenal used by those toughs, and they did good work, indeed. Now, everything is quiet at Walla Walla, excepting the ordinary disturbances likely to occur in any well ordered community, and the days of the Snake river cut-off building are things of the past.

THE MARKET.

No Export Movement During the Past Week.

The Portland Commercial Review says: The week has passed without any export movement, or flattering prospects of an early active shipping business. Harvesting is progressing in all directions, and perhaps farmers are paying more attention just now to field operations than to marketing. At least, offerings have been very small and receipts at this port light; however, within a fortnight the movement must necessarily increase, as some tonnage will be due. The shipping season ought to be well under way by the middle of September, but, owing to the comparatively small amount of tonnage due to arrive within 60 days, we cannot look for a liberal export movement during the first three or four months of this season, as in former years. From what we can learn, purchases of wheat against tonnage requirements are very fair. No doubt when tonnage is at hand shippers will buy freely, as present offers are not anxious to load up. Many express themselves that wheat will be lower. It is necessary to add that present values will tend to delay active or free selling, and probably sellers will hold off until the last moment before parting with their grain, and it remains to be seen whether the urgency to sell is less or greater than the pressure to buy. In the former case farmers will get full export value; in the latter case, should shippers' necessities become very urgent, competition might become so active that shippers would be forced to sell. But from the fact that there is not likely to be any important need of wheat for 60 days, and that there is always a certain number of holders who sell immediately upon the conclusion of harvest work, it seems more probable that this season the grain will be accomplished more on the lines of actual export values, considering that, with tonnage available only to move one-fifth of the crop, many farmers will not hold too long and profit by past experience. Farmers will get all that the market will bear, and it remains for a legitimate profit for handling and usual risks of shipment.

Boston Wool Market.

Boston, Aug. 1.—Some improvement is noted in the wool market here. Manufacturers are not exactly ready to buy freely, but direct bidding on many lines of wool, and in some instances fair purchases are made. Arrivals of wool from the West, which have been light for some time, are now more frequent.

Better Than Expected.

G. W. Rigby is harvesting his wheat on the reservation a few miles from Pendleton and it is turning out better than he expected, some of the best of it going almost 40 bushels to the acre. That is not the average, but it will raise the average to above 30 bushels. Mr. Rigby is one of the few farmers of Unatilla county who is being agreeably disappointed by having the actual yield greater than the estimate prior to the commencement of harvest.

CARRIED CONCEALED WEAPONS.

Justice Fitz Gerald Thinks the Habit a Pernicious One.

Westley Bliss was arrested by Officer Coffman last night and taken before Justice of the Peace Fitz Gerald this afternoon, where and when he pleaded guilty and was fined \$25. He had the fine and had money left. When arrested, Bliss, who is apparently a boxer, tourist, was loading in the O. R. & N. Co. yards in a suspicious manner. He said he was a junk dealer and took the plan of beating the railroad company out of fare in order to save money. He urged the fact that he was a junk dealer to explain his being in such a position and carrying so much money. The officers were of the opinion that he had recently held up some person, if not in Pendleton, then some other place.

Justice Fitz Gerald thinks the habit of carrying concealed weapons is a pernicious one, and should be frowned upon by the law-abiding citizens of this respectable community, hence the fine. It would be good policy for those carrying concealed weapons in Pendleton not to allow the officers and Justice Fitz Gerald catch them at it.

TRICKY HORSE BUYERS.

This Case Will End in the United States Courts.

Colonel William Parsons has returned from a trip to the Flathead Indian reservation, Montana, where he went in response to a telegram from a great many Indians, including Paul Showaway, Allieott and others well known on the reservation and in Pendleton, asking him to come and assist with his legal knowledge. The trouble was over the delivery of horses to a buyer named Jameson, who had contracted for a certain number and had a bill of sale for them.

The Indians understood that they were to deliver 1000 head of horses from three different bands, but later it was found that the buyer was attempting to make them deliver all the horses of the three different bands. The Indians delivered 1540 and refused to deliver any more. The agent at the Flathead agency stood in with the buyer Jameson, and finally the department had to send out an inspector from Washington, D. C., to look into the matter.

The case will eventually find its way into the federal courts.
