D. B. Watson has 900 acres of wheat this year on the reservation which is yielding 25 bushels to the acre. Mr. Watson was in Pendleton this afternoon on business.

James A. Martin and Mattie R. Roberts were married on Monday by Justice of the Peace Thomas Fitz Gerald, at his office in Association block, in the presence of a few friends.

John Osborne had a breakdown near Warren station today while operating his horsepower threshing machine. He broke the main shaft and had to telegraph for a new one, which will be here on the morning train.

J. L. Barker broke the main shaft of his steam threshing outfit today while at work near the Hawk place, six miles northwest of Pendleton. He came to this city and telegraphed for a new one, which will be here tomorrow morning, so that he will be able to go to work again at once.

Kyle McDonald and Miss Edie Wolfe were united in the holy bonds of matrimony at Athena on Sunday, August 12. The ceremony was performed in the Methodist Episcopal church, Rev. William Derweese, of that denomination, officiating. The couple are favorably known, have many friends, all of whom join in hearty congratulations.

A real estate transaction of considerable magnitude has just been consummated, where the Northern Pacific Railway company has sold to E. Boettcher 6037.47 acres of land near Toakum, the consideration being \$718.84. Mr. Boettcher is the well known dealer in sheep, whose home is in Chicago. He will utilize these lands just acquired as ranges upon which to graze his herds.

Tom Kerr's new threshing outfit at work for Frank Hanna, at Badger spring, 22 miles northwest of Pendleton, had to close operations temporarily on account of the breaking of a derrick fork. Mr. Hanna came to town for the repairs and the machine will start up again tomorrow. He has 275 acres of wheat which he says will go 20 bushels to the acre, and he will be satisfied with that yield, although many estimated that it would go 30 bushels to the acre. He gives the same reason for the low yield as hundreds of other farmers of Umatilla county have given, that the heads are short and there is too heavy a growth of straw.

Supreme Court Opinions.

W. W. Raymond and J. B. Huntington Get a New Trial.

The following opinions have been received by Lee Moorhouse, clerk of the supreme court:

Jesse L. Stamper, respondent, vs. W. W. Raymond and J. B. Huntington, appellants. Appeal from Umatilla county. Hon. Stephen A. Lowell, judge; J. J. Balleray for appellants; Chas. H. Carter, for respondent. Reversed and remanded. Opinion by Wolverson, J.

Nash-Po, appellant, vs. Wa-Win-Ta-La-Yekt, Charles Wilkins, U. S. Indian agent, respondents. Appeal from Umatilla county. Hon. Stephen A. Lowell, judge; A. D. Stillman, for appellant; T. G. Hailey, for respondents. Affirmed. Opinion by Bean, C. J.

Plaintiff is the grandmother and defendant the mother of one George Pearson, deceased, who was deserted by his mother in 1879 when four months old and taken by his grandmother, who raised him. Pearson was allotted 40 acres of land on the reservation and his death his mother claimed to be the heir to the land. His grandmother claimed to be his legal heir because she had adopted him according to the immemorial customs of the tribe. This opinion holds that adoption is a right purely statutory, and unknown to the common law. The mother gets the land.

Mary N. Emison, appellant, vs. the Owyhee Ditch Co., a private corporation, respondent. Appeal from Malheur county. Hon. M. D. Clifford, judge; submitted on briefs; reversed; opinion by Moore, J.

This is an action to recover damages for the loss of crops, alleged to have been caused by the defendant's negligence in permitting water from its ditch to overflow plaintiff's land.

L. W. Tallmadge, appellant, vs. A. B. Hooper, respondents. On petition for rehearing. Per curiam. Petition denied.

The court states: The two questions of fact argued in the petition for rehearing were fully considered by the court before the case was decided. We then concluded that the evidence did not show a subsequent parcel modification of the written contract set out in the complaint, nor a subsequent parcel waiver of the time stipulated for the thousand dollar payment. A re-examination of the records has confirmed us in this view. The petition for rehearing is therefore denied.

Political Notes.

Seattle republicans put a colored man, editor of a paper, in their state delegation, and are said to be having trouble with him, because he declares he will not vote for Frink's nomination for governor. His name is Griffin.

G. F. Faxton, one of the republican candidates for presidential elector, says that his fellow candidates will meet within a few weeks. Three of the four electors are lawyers and they will take the stump. Mr. Faxton states that the campaigning will commence in September.

W. J. Bryan's visit to Chicago has practically resulted in an understanding that he will travel almost as much during the present campaign as he did in 1896. The first inclination on his part was to avoid the making of many speeches this year, but there has been such general pressure that it is understood that he is now inclined to yield and to visit many parts of the country.

Judge John A. Toohy, of Hartford, Conn., has decided to close his law office until late in the fall and devote all his time to stumping this and neighboring states for Bryan. This is the first time he has ever felt it was his duty to make public addresses in a political campaign.

During maneuvers of the French fleet off Cape St. Vincent last night a collision occurred between the first-class battleship Brennus, flying the flag of Vice-Admiral, commander of the fleet, and the torpedo boat destroyer France of 31 tons' displacement. The torpedo boat sank immediately and only 14 of the crew of 56 men were saved. The helmsman misinterpreted an order.

## PEOPLE WHO ARE HERE TODAY.

Asa B. Thompson, representative from Umatilla and Morrow counties, returned last evening from a trip to Idaho, whither he had gone on a cattle deal. While at the Meadows he discovered a man of peculiar ideas, worth more than a passing mention. This man talked with Mr. Thompson on a number of subjects and seemed to be perfectly rational until it came to discussing the late Spanish war. Then it was that he showed his peculiar bias of mind, by giving it as his opinion that there were no lives lost by the blowing up of the Maine in Havana harbor, that the bodies discovered in the wreck were simply dummies, and that the whole transaction was done for the purpose of inflaming the public mind and precipitating a clash of arms between the two countries. He further gave it as his opinion that Queen Victoria has died for 20 years, and that fear of an overthrow of the British government has prevented the fact from being made public. Those statements by this Idaho man led Mr. Thompson to believe that there was a niche in the insane asylum that needed filling, and that the man from Idaho was not in his proper place.

KILLED HIS FRIEND.

Wanted Money on Which to Marry and Resorted to Crime to Get It.

The Associated Press dispatches of Sunday tell of the capture of the murderer of Express Messenger Lane, on the Pennsylvania train from Pittsburg to Columbus, and the robbery of the express car and sale—Charles R. Ferrell, formerly a messenger in the employ of the same company, confessed to the crime. He was engaged to marry a young woman in Columbus, Ohio, and being out of work was without means. He decided to kill his friend Lane and rob the express company. On Friday afternoon he went to Urbana and waited the arrival of the messenger. When the train came in he boarded the express car and asked Lane for a ride, pretending to be without funds. After the train started, and while talking with Lane, he

walked up behind him and shot him to death, then robbed the safe in the car, and stepped off at the next station, when he went to a hotel and spent the night, then returned to Columbus, visited the girl whom he was to marry, and was at her home when arrested. He had given the money taken from the safe in the car to the young woman who returned it to the law officers as soon as she knew of the charge against Ferrell.

STUDIED HIS FELLOWS.

They Were Profane and Vulgar But Many of Them Have Great Mentalty.

Rev. Charles Merriam, of Highland Congregational church, of Lowell, Mass., a Yale graduate and a former editor for the Yale News, in an old suit of clothes and a flannel shirt, with his belongings strapped in a blanket, left his home on May 11 and roughed it for three months, going from Boston to Portland, Me., and from there to Colorado. He has just returned to his pulpit. He mingled with the laboring folks, working as a deckhand on a canal boat and resorting to conventional travel only when he had to. His aim was to study the people.

One of his most interesting experiences was on the canals of New York state. At Troy he shipped on an old-fashioned mule-power canal boat and went 352 miles. He lived in the crew's quarters, took a hand in all the work and learned locking and steering. He says of his associates:

"Strange men I found those people—these off-scourings of the earth. Coarse, profane, even vile, yet under this rough exterior I found often a marvelous amount of mental capacity. Poor fellows. They all want to get away from the life, but they never do."
