Edward Goodnight is in town from his home at Vancouver, Wash., where he has been for the last seven years. He still owes the Goodnight farm in Stage Gulch, which gave a yield this year of over 30 bushels of wheat to the acre.

John Graham and his sons Charles and John, 8 1/2 miles northwest of Pendleton, have 200 acres of wheat this year, averaging 20 to 22 bushels to the acre. Part of it was spring wheat, which only yielded 15 to 17 bushels per acre, thus cutting down the average.

A three-story hotel is being built at Hot Lake, Union county. A portion of the lake has been filled in and the two principal springs of boiling water been enclosed with cement walls and the points of discharge have been raised two and a half feet above the level of the lake.

A young man from Walla Walla was matched against Tom Read, of Weston, for \$150 a side. M. M. Wyrick has finished threshing 400 acres of summer fallow wheat that averaged 28 bushels to the acre. He will commence hauling tomorrow. His place is in Despain gulch 10 miles northwest of Pendleton. He said he had been offered 47 cents per bushel for it, but refused, as he was in no hurry to sell—in fact, would not sell just now, even if he could get 50 cents per bushel.

SHOT QUAIL ON THE RESERVE.

Two Men Recklessly Violate the Game Laws.

H. E. Ramsaur, acting agent on the Umatilla reservation, writes to the East Oregonian that two men were on the reserve Sunday shooting quail, and persisted in doing so, after being warned by an eye witness to desist, in strict violation of the law. Because of the action of these men the acting agent has revoked the privilege of hunting and shooting on the reserve to all, in order that the little bands of quail may be better protected from such marauders. Under the law the quail are protected for ten years hence anyone killing them is subject to punishment. The acting agent closes his letter with the statement that the Indian police have been instructed to arrest all persons found on the reservation hunting for game.

Sheep at Fair Price.

Charles Cunningham today purchased from John Gurdane 2800 head of sheep, property of the late William Gurdane. The sheep are now in the Dark Canyon country and are to be formally delivered where they are now ranging on next Monday. A Wheat Fire.

A telephone message from Helix yesterday afternoon conveyed the news that a wheat fire had occurred between Vansycle and Helix whereby William Dale had lost 1570 sacks of wheat. Mr. Dale resides four miles north of Helix and the W. & C. R. railway runs through his farm. It is said that the fire started by sparks from the locomotive on a train on that road. The wheat was insured.

Of varieties, the following have been found best suited to the conditions of Paris, in preference being given in the order named: Horsechestnut (which is much the best), plane, alantus, locust, Linden and pugnolia.

Rather than embarrass President McKinley by a counter demonstration, the democratic nominee will defer his arrival to the next day, or perhaps two days later. This decision was reached after Mr. Bryan was made acquainted with the program and the part to which he was assigned.
