GENERAL NEWS.

Mrs. Florence Maybrick, the Ameri-
can woman convicted of poisoning her
husband and sentenced to prison eleven
years ago in England, may soon receive
a pardon.

Major John B. Kerr, Tenth cavalry,
has been ordered to Berlin as attaché
of the United States embassy there,
and Captain Slocum, Third cavalry, has
been ordered to like duty at St. Peters-
burg.

W. A. Clark, the wealthy mine
owner of Montana, has purchased a
half interest in the Los Angeles
Terminal railway company. It is
stated the owners of the Terminal
company will begin an extension to
San Bernardino and thence to Salt
Lake City.

During the last few weeks duels have
caused a perfect slaughter in Italy. As
many as four duels were killed last
Saturday. During the last year 2400
duels have been fought in Italy and
480 deaths have resulted. Most of these
combats were between army officers,
and based on the most trivial pretenses.

The harbor commissioners at Belfast,
Ireland, entertained the officers of the
United States cruiser Baltimore at a
public reception. Responding to the
toast to his health, Rear Admiral Wat-
son said he personally rejoiced at the
extreme friendliness between Great
Britain and the United States.

Controller Tracewell, of the treasury,
has rendered a decision in which he
holds that the Hawaiian islands, under
the act of May 16, 1900, constitute a
part of the United States, and there-
fore officers of the navy therein are
serving within the realm of dominion
of the United States, and consequently
are not "beyond seas" within section
13 of the navy personnel act.

Count von Bulow's position as minis-
ter of foreign affairs for the empire
has been so seriously shaken by his
differences with the kaiser over the
China matters, that it has led the em-
peror to take the direction of the
Chinese matters out of the count's
hands and assume personal control
thereof himself. The downfall of the
statesman is regarded as imminent.

PACIFIC NORTHWEST NEWS.

There are two cases of diphtheria at
The Dalles.

Ex-Mayor Horatio N. Belt, of Spo-
kane, died at his home in that city
Wednesday after a lingering illness.

At La Grande 25,000 bushels of
wheat were sold Thursday to the
Pacific Coast Elevator company at a
price not made public.

Good coal, both bituminous and
lignite, has been found in paying
quantities within easy reach of Port-
land, and the only thing needed is a
little capital and energy to place it
upon the market.

William Miller better known as
"Uncle Scotch," an octogenarian of
Salem, married Mary Pearson, aged 60,
of Klamath county. Miller is a well
known member of the Masonic frat-
ernity, and is 85 years of age. He
owns a large amount of real estate
north of Salem.

The assessment of Baker county
made this year shows an increase of
\$120,000. There is not a mine taxed in
the county. Only \$26,710 in money is
assessed. The total value of all prop-
erty in the county is \$2,893,955 and in
Baker City \$1,011,980, over one-third
of the county total.

Astoria business men have secured
control of 6500 acres of land at
Knappa, near Astoria, and last night
declared it a very valuable coal and
petroleum field. A company has been
formed, and it is stated development
will begin immediately.

Three young boys from Utah who
were on their way to China as mascots
of the Second Infantry were reclaimed
by the police at San Francisco. The
youths will be returned to their rela-
tives. The boys are Louis Edgar, aged
13 years; Conrad Holland, aged 12,
and Lawrence Lewallen, aged 10, of
Salt Lake City.

A 5-year-old son of Mr. and Mrs.
John Kiger, who live south of Cor-
vallis, was missed last week by his
mother, who, after a search, found the
child in a watering trough, drowned.

WAITING ON THEIR OARS

The Allied Commanders Want to Know
What to Do Next.

REPORTED RUSSIA DECLARED WAR

But Washington Officials Say No Information
Has Been Received of Any Such Per-
formance on Russia's Part.

London, Aug. 24.—While the com-
manders of the allied forces are wait-
ing for instructions from their respec-
tive governments regarding what to do
next, work of repairing the railroads
beyond Yang Tsun is progressing and
transportation facilities on the Pei Ho
river are improving.

A dispatch from Che Foo says: There
has been further fighting near Tien
Tsin. The Chinese sought to cut our
line of communication but were driven
back with a small loss on that part of
the allied forces.

burned a Japanese Temple.
Washington, Aug. 24.—Consul John-
son, at Amoy, cables that a mob
burned the Japanese temple at that
place today. The marines were landed
to protect the Japanese officials and
are restoring order.

Marines from the French cruiser
Comet cleared the streets of Swatow
and freed the besieged priests who
were held there.

Rumor Russia Declares War.

Washington, Aug. 24.—At the close
of the cabinet session today the mem-
bers were more reticent than usual as
to what transpired. It can be stated,
however, that the government so far
has received no official information
that the Russian government has de-
clared war on China or that it is her
purpose to do so. The subject of an
extra session of congress was not men-
tioned and a number of the cabinet
stated that an extra session was al-
together improbable.

Is Chaffee at Tien Tsin?

Washington, Aug. 24.—The war de-
partment received a cablegram from
General Chaffee, dated Tien Tsin, giv-
ing a list of the casualties there. The
officials here construe this as indicat-
ing that General Chaffee has returned
to Tien Tsin from Pekin. It is stated
that the only reason for thinking that
General Chaffee is at Tien Tsin, is be-
cause the reports are signed by him
and dated at that place. It is said at
the department that nothing else has
been received from Chaffee indicating
that he is at Tien Tsin.

Great Fire in Pekin.
London, Aug. 24.—Fire fighting
and destruction are apparently follow-
ing in the wake of Pekin. The Daily
Mail publishes dispatches from the
Chinese capital, dated as late as
August 17, declaring that a great fire
was then raging in the imperial city.
The Russian commander had declined
to accept the decision of the other gen-
erals not to violate the imperial pre-
cincts and street fighting was going on.

General Chaffee's Position.
Gen. Chaffee, so it is asserted, main-
tained that the Chinese had been
adequately punished already and that
it would be unwise to take the im-
perial palace. This explains the with-
drawal of the Americans after break-
ing the three gates as cabled by the
Associated Press. The Russian gen-
eral, however, maintained that his gov-
ernment had declared war against
China and that therefore there was no
reason to prevent him carrying hostil-
ties to the sacred precincts.

The Principal Buildings Safe.
A Reuter telegram asserts that sen-
tries were placed to prevent looting.
Hence it is presumed that the imperial
buildings although captured will not
be destroyed. The fires appear to be
incendiary and to be caused by the
Chinese themselves.

How Captain Reilly Died.
Pekin, Aug. 15, via Che Foo, Aug.
22.—(Copyrighted 1900 by the As-
sociated Press.)—The American breach-
ed the three gates before the imperial
palace and occupied the approaches to
the east wall. Capt. Reilly, Battery
F, Fifth United States artillery,
and five privates were killed and 16
wounded. During the afternoon
the Americans returned to the camp
pending a conference between the gen-
erals. Thereupon the Russians oc-
cupied the approaches to the palace.

Capt. Reilly was standing on the
wall and directing his battery when a
bullet struck him in the mouth, kill-
ing him instantly. The battery sym-
mered at the gates until they fell.

BRITISH PRISONERS RESCUED.
General Found 140,000 Rounds of Am-
munition Buried.

London, Aug. 24.—The following
was received from Lord Roberts:
"Pretoria.—Baden-Powell rescued one
hundred British prisoners at Warm
Baths, August 22, and captured 21
Boers and several German artillery
officers. Buller's casualties on August
21 were seven killed, Captain Eller-
shaw and twenty-one men wounded
and five missing. General Kitchener,
August 21, had eight casualties."
In Komati valley, General Buller
found 140,000 rounds of ammunition
buried.

Boers Will Settle in Montana.
St. Paul, Aug. 24.—A Helena, Mont.,
special to the Dispatch says: A
Wormer, of Helena, has made ar-
rangements to purchase a large tract of
land in the Yellowstone valley. He
will bring a large number of Boers
from the Transvaal to occupy it.

M'KINLEY GOES TO CHICAGO.
He Will Leave Washington City Sunday
Night.

Chicago, Aug. 24.—The Hamilton
club today received a message from
Secretary Corley, stating that Presi-
dent McKinley will leave Washington
for Chicago Sunday night. This was
in reply to an invitation to attend the
Hamilton club banquet Wednesday
night.

Race War in Texas.
Fort Worth, Texas, Aug. 24.—Great
excitement exists in Summit county
owing to the fears of a race war. The
negroes have posted notices threatening
to kill several prominent white men
and are intimidating women.

SAVED HIS SON'S LIFE.

Heroic Treatment Was Necessary in
This Case.

Sellingrove, Penn., Aug. 24.—John
Rankin, of Hickory Corner, Penn.,
cut off his son's hand with a big knife,
the boy having been bitten by a rattles-
nake and they were far away from
medical assistance.

The father and son were engaged in
picking huckleberries. The boy had
been running about in the bushes,
gathering handfuls of the berries and
bringing them to his father.

Suddenly he came dashing back,
screaming and crying in frantic alarm.
Holding up his hand, the father saw
two small wounds upon it, while the
child gibbered at a huge snake.
Less than ten yards away Rankin
found a great rattlesnake coiled and
ready to strike again. With one blow
of a club he killed the reptile, but he
knew that the deadly poison was at
work in the child's hand.

Certain that every moment meant
life or death for his boy, Rankin
seized the child, and with one blow of
a heavy knife he carried the struck off
the hand at the wrist above the snake
bites.

Stopping the flow of blood with a
cord about the arm, the father carried
the child home, and after several
hours a doctor arrived and dressed
the wound. The medical man says the
little lad will recover rapidly, but he
has no doubt that the father saved
his child's life by his heroic treatment.
Young Rankin is eight years old.

HUNTINGTON'S WILL.

It Was Made Public in New York
To-day.

New York, Aug. 24.—The will of C.
P. Huntington was made public today.
The estate is divided in trust for the
benefit of his family and relatives.
The only bequest outside of this is his
pictures, which, at the death of Archer
M. Huntington, will go to the Metro-
politan museum of Art, New York.

Also \$100,000 to the Hampton Nor-
mal and Agricultural Institute, at
Hampton, Va., and \$5,000 to the
Chapin Home, for the aged and infirm
of New York city.

The petition asking that the instru-
ment be admitted to probate does to
give the value of the estate.

SAMOAN ISLAND NEWS.

Unveiling of a Monument to British and
American Dead.

Apia, Samoan Islands, Aug. 24.—
On July 9 the monument to the British
and American officers and men, who
were killed in the fight with natives,
in April, 1899, was unveiled at
Mullum by the imperial government.
Native revolt against German rule is
threatened as the result of what the
Samoans consider undue harshness of
the Germans. The efforts of Mataafa
to reconcile the Samoans to the new form
of government have failed.

So far no trouble has developed at
the American or British Samoan settle-
ments.

DISEASE, SUFFERING, DEATH

A Terrible Storm Raged at Nome City
on August 7.

LIVES LOST, PROPERTY DESTROYED

Great Suffering Among the Eskimos—Many
Deaths at York and Bodies Lying
Around Unburied.

San Francisco, Aug. 24.—The Even-
ing Bulletin prints the following
special dispatch dated Seattle: A
terrible storm raged at Nome on August
7. The beach is lined with wreckage
and stranded vessels of all descrip-
tions. A number of bodies came
ashore at Topkok, three miles north of
Nome; and eight in front of Nome
camp, three twelve miles below Bluff
City and two below Topkok.

A tale of disease, death and suffer-
ing, among the Eskimos in the north,
almost beggars description.
Guy N. Stocklager has returned
from York and reports the natives
dying by the wholesale, there being
dozens of dead bodies lying around un-
buried.

Thirteen deaths are reported in
Teller City in one day.

Walla Walla, Aug. 2.—The demo-
cratic county convention which assem-
bled here yesterday was called to order
by the chairman of the county central
committee, W. H. Dunphy. Dr. N.

Blalock was unanimously elected and
was escorted to the chair by David
Miller and W. A. Rife amid prolonged
cheering. H. S. Standford was chosen
as secretary of the convention.

HAWAIIAN NEWS.

The Six Per Cent Bonds of the Island
Government Sold.

Honolulu, Aug. 17.—The banking
house of Bishop & Company will take
up the Hawaii island government
six per cent bonds, which constitute
a part of the debt assumed by the
United States, but for which congress
failed to make an appropriation,
through an oversight.

Dr. Charles L. English has sued ex-
Queen Liliuokalani for \$5000 damages,
for an alleged breach of contract.
The labor situation is still a matter
of much discussion and planters await
with interest reports from those who
have gone to the states to investigate
the securing of another labor supply to
take the place of the Japanese.

Electrical Storm.
St. Joseph, Mich., Aug. 24.—The
worst electrical storm of years struck
here today. Ten barns, ten miles south
of here, containing the season's harvest
were struck by lightning and it is re-
ported they were burned to the ground.

Robbed Himself.
As an aftermath to the event of a
couple of weeks since, in which
Walter J. Shelley, at that time night
clerk of the Hotel Eugene, claimed to
have been held up and relieved of \$90,
left in his care by a boarder at the
hotel, Shelley was placed under arrest
by Sheriff Withers, charged with
larceny by bailee, the sum of \$90.
He was placed under \$100 bonds for
his appearance before a justice.—Eugene
Guard.

Shelley was a member of the Second
Oregon volunteers, having served in
Company C, of Eugene, during the
Luzon campaign.
