BACK TO OKLAHOMA.

D. J. McCarty Wanted There for Stealing Cattle.

D. J. McCarty, who has been working for Elmer Snyder, seven miles north of Pendleton, is in jail. He was arrested last Monday by Deputy Sheriff T. H. Taylor.

Mr. McCarty's real name is Simmer. Last spring he was located near Taloga, Oklahoma, and got mixed up in cattle stealing cases; was arrested and lodged in jail; broke out and came to this county and has been working for Mr. Snyder since last August. Sheriff W. E. Hutton, of Taloga, wrote to the sheriff here and T. H. Taylor worked up the case and found his man. Taloga is 45 miles from a telegraph station, Woodward being the nearest point. After the arrest here of McCarty-Simmer the sheriff there was notified by telegraph, and he is expected to arrive in Pendleton by next Monday or Tuesday.

The information from Taloga is to the effect that McCarty was awaiting trial when he concluded to wait no longer, and broke out. Since that time a warrant has been returned against him for grand larceny. To the sheriff here he admits his guilt and identity and says he will go back without requisition papers. As a precaution, however, requisition papers have been asked for, and will be ready upon the arrival of Sheriff Hutton.

REGARDING ROAD LAWS.

A PROVISION OF THE INDIANA LAW GOOD FOR OREGON.

The Road Laws of the State Will Probably Be Amended by the Next Legislature.

Since mention has been made of proposed legislation in Oregon regarding public road law, it has been suggested by a former resident of the state of Indiana, who lives at Salem, that that state has a law governing road improvement which works very satisfactorily and might well be considered by Oregon lawmakers. In many respects the Indiana law governing the management of highways are much like those existing in Oregon. Taxpayers are permitted to pay their taxes in cash or in labor, and many employ a substitute to perform the work. Also, the improvement is made under the supervision of a road supervisor.

How Good Roads Are Made.

There is one chapter of the Indiana law, which, though general in its scope, is intended to apply particularly to permanent improvements of a costly nature. The law is much the same as that governing street improvements in cities. This chapter provides that the county commissioners may lay out, construct or improve by straightening, grading, draining, paving, traveling or macadamizing any road in their counties. The proceedings under this chapter are begun by a petition, signed by not less than five land-owners whose property will be affected, stating the kind of the improvement and the points between which it is asked. The petition must be accompanied by a bond providing that the petitioners will pay the expenses of the preliminary survey should the improvement be denied. The commissioners then appoint three viewers and a surveyor to lay out the road and assess damages to property-owners whose lands are crossed by the road. The viewers and engineer report to the commissioners their findings, and also report an estimate of the expenses of the improvement, and the lots and lands which will be benefited thereby, and ought to be assessed therefor.

How Lands Are Assessed.

It is provided that no lands shall be assessed which do not lie within two miles of the contemplated improvement, and that prior assessments may be taken into consideration in fixing the estimate, as well as the fact that land is situated near two roads, so as to be assessable for both. The report having been made the commissioners assess the improvement and the value of the land on which it is made. When the improvement has been ordered the commissioners appoint an engineer to superintend the work, which is done under a contract let to the lowest responsible bidder. The work is done in sections of not less than a half-mile each. At the same time the improvement is ordered, the commissioners appoint a committee to actually view each tract of land benefited and to apportion the share of the estimated expense each tract should bear. The report of the committee may be approved or modified by a new committee appointed. When the report is approved, the assessment becomes a first lien upon the land.

Bonds May Be Issued.

For the purpose of raising the money necessary to meet the expenses of the improvement, the county commissioners may issue bonds of the county, maturing at intervals of two years and not to exceed eight years, bearing interest and payable semi-annually, which bonds shall not be sold at less than par value. The assessments are made payable at times suitable to meet the payments on the bonds, and the assessments are collected the same as taxes. The money arising from the road assessment can be applied to no other purpose than the payment of the bonds, and the bonds can be issued or the money paid only as fast as the work shall progress. The amount of bonds that may be outstanding at any one time is limited to one and one-half per cent of the value of the taxable property in the county.

What is considered the most commendable feature of this law is that it provides a means by which the parties most interested may secure permanent road improvements; that the work cannot be done unless with a majority of resident land-owners and owners of a majority of the acres across, and that the expense is borne in proportion to the benefits derived. The work cannot be prevented by one or two obstructionists and non-resident owners do not have the same voice in the matter that residents do. The law is framed for the good of the people who use the road.

FOUR WERE ARRESTED.

An Indian Cache Depleted of Its Treasure Near Mission.

Henry Sheldon, Abram Pease, Arthur Pease and Andrew Sherman were arrested, and warrants were issued for Richard Roe and James Poe, from the office of Thomas Fitzgerald, justice of the peace. All the defendants have been engaged recently digging potatoes for U. W. Rigby north of Mission station, six miles east of Pendleton.

The complaining witnesses are Toki Young Simpson, Mary Thomas and J. P. not-in-mil. four Indians. Prior to their departure on their annual hunting trip a couple of months ago they made a cache in the ground near the Mission, never dreaming that it would be discovered and disturbed. One day last week they were horrified to discover that the cache had been broken into and despoiled of something like \$400 in valuables, including head-baskets, bracelets, grinding-stones, elk teeth, beads, skin strips, beaded and rawhide, rawhide tie ropes, beaded skin gun scabbard, beaded knife case, tanned buffalo, elk and deer skins, etc.

The men were working near where the cache had been made, and they were suspected. A search warrant was sworn out, and Constable John M. Bentley and J. D. Brown served it Sunday. None of the missing property was found in possession of the men, or at the house where they were staying. One half of it was found a quarter of a mile away from the house. A horse and buggy were tracked from the house to the place and back again. This was convincing from the fact that there was only one shoe horse on the place, and its tracks were plainly indicated to and from the goods.

The preliminary hearing of the four above mentioned defendants is being held this afternoon before Justice of the Peace Thomas Fitzgerald. They protest their innocence and numerous witnesses have been called. The result of the examination will not be known until late this afternoon, or perhaps until tomorrow morning.

CHARLES DUNN'S CASE.

Round Over at Athena and Bond Fixed at \$1000.

Charles Dunn, Deputy Sheriff of Blakely, District Attorney T. G. Bailey and Charles H. Carter returned Tuesday afternoon from Athena, where the first-named underwent his preliminary examination on the charge of cattle stealing, before J. W. Smith, justice of the peace. He was held to answer to the grand jury at the January term of circuit court and his bond fixed at \$1000, which he was unable to furnish. James Roddy, to whom Dunn sold the cow alleged to have been stolen from Hagen Brothers, related his part in the transaction and told just what had transpired as far as he knew. In regard to Dunn selling the cow to Roddy there is no doubt. Thereafter the facts are in dispute. It is claimed that the hide of the animal had been cut down the back, placed in two sacks and hid in La Brashe's straw-stack, which was set on fire. The identity of the person setting fire to the straw-stack is, of course, important. It is claimed that the cow alleged to have been stolen was killed on Wednesday night, October 31. Mr. Dunn was initiated into the Order of Red Men on that night, which throws a doubt over the charge, as he was in the lodge until 1 o'clock the following morning. He will have his trial at the January term of circuit court. Mr. Roddy waived examination when first arraigned a week ago, charged with buying and receiving property believing it to have been stolen, and was placed under \$500 bond, which he furnished.
