WHEAT AND WOOL MARKET

PRICES LOWER THAN AT THIS TIME
LAST SEASON.

Umatilla Wheat Crop Will Be Short-
er in Boston and London—East-
ern Livestock Quotations.

Pendleton, July 11.—There is little
to be said regarding wheat. This is
the season when prices are made only
to be looked at. The opening price
that will be bid for the new crop, is
something that is agitating farmers.
Last year the price for new wheat at
the time wheat was being harvested
started at about 45c. This year it will
be several cents lower than that.
Local millers are offering 45 cents for
No. 1 club and redchaff today deliv-
ered at the mills. Exporters are away
under that figure. With wheat quoted
at 53 cents in Portland representatives
of exporting firms are not justified in
offering more than 41 to 42c. The crop
of 1900 has been pretty thoroughly
cleaned up and there is practically no
wheat changing hands. The fact that
the wheat crop of Umatilla county
this year will be from 25 to 33 1-3 per
cent short of average has not stimu-
lated the local market perceptibly.
Eastern and foreign markets are
lower. The Liverpool quotation of
Wednesday, July 10, when it was as
low as 5s 4d, is the lowest price quoted
in a year and a half.

Local Wool Market.

Seventy-five per cent of the wool
clip of Oregon for 1901 has been sold,
with the expression this morning of a
prominent dealer in that commodity.
There is a better feeling and a stronger
tone to the market than two weeks ago.
This has not been of such a noticeable
character as to warrant any big in-
crease in the quotations, but it may be
covered by the statement that the
prices all around are up a quarter of a
cent. This is just sufficient to cause
buyers to take wool offered now
which they would have refused to buy
two weeks ago.

Local Produce Market.

Pendleton dealers are paying the fol-
lowing prices for ranch and farm pro-
duce:
Butter, 30c to 35c per roll.
Eggs—20c per doz.
Turkeys—Alive, 12 1/2c per pound.
Geese—12c per pound.
Ducks—14c per dozen.
Chickens—\$3.50 to \$4.50 per dozen.
New potatoes are coming into the
market freely.

Wheat in Portland.

Portland, July 11.—The Commercial
Review in its issue of this week, pub-
lished today, says of the market:
The wheat market continues dull,
the small business done being of a
draggish character, mostly on milling
account, and offerings have been light
and receipts are very small. Prices
are weak and against sellers—54 1/2c to
55 1/2c per bushel for Walla Walla club,
and 2c higher for blue stem. The
principal factor influencing the local
situation is the comparatively strong
tone of tonnage, which is not plen-
tily offered, except at extreme figures.
Exporters are generally doing little
buying for new crop loading, the evi-
dent intention being to provide the
necessary tonnage first to meet the
market when the season opens at its
export value. From what we can
learn, purchases against tonnage
requirements are thus far ex-
tremely small, but there is plenty of
wheat at tidewater here for six ships
and at Tacoma for three or four more.
Nearly due tonnage has been amply
provided for, and whatever exporters
purchase now is for September loading,
and by that time new wheat will have
begun to move. At the close the mar-
ket is weaker and probably lower in
sympathy with the weakness developed
in other markets.

Wheat in San Francisco.

San Francisco, July 11.—Receipts
for the week have been light. In so
far as the market here is concerned,
there has been very little doing in ap-
proach, and this is especially true
with reference to the latter part of the
week, as the exchange adjourned from
Wednesday afternoon until last Mon-
day. No doubt shippers are busy con-
tracting for wheat in the interior, but
the surface of the local market is quiet
and without a ripple of excitement.
Harvesting is in full blast throughout
the state, and all reports received,
and they are authentic, indicate clearly
that the quality of the grain is bet-
ter than was at first anticipated,
and that the total yield will be beyond
earlier expectations. A well known
firm says it is rather strange to com-
ment, but it is nevertheless true
that the recent development of the oil
industries in this state will, to some
extent, affect the price of wheat.
Choice old California milling wheat at
\$1.02 1/2 to \$1.03 1/2; No. 1 California
shipping, new and old alongside ship,
95 to 97c; Oregon, wheat, 95c to \$1.

Wool in Boston.

Boston, July 11.—Prices a trifle
firmer for all grades. Sales of terri-
tory wools continue strong. Fine me-
dium and fine secured, staple, is sell-
ing at 40 to 42c, while the staple
article is quoted at 44 to 45c. Quota-
tions:

fine medium and fine, 13 to 14c;
secured, 40 to 42c; staple, 14 to 15c;
secured, 44 to 45c; Utah, Wyoming
and Idaho, fine medium and fine, 13

secured basis, spot prices, combing
superfine, 71 to 72c; good, 68 to 70c;
average, 66 to 67c.

Wool in London.

London, July 11.—The offerings at
the auction sales this week numbered
14,613 bales. A superior selection was
put forward and active competition
was the rule. The continent was a
strong buyer and Americans secured
several parcels of suitable grades.
Superior merinos and cross-breeds were
in small supply and sold at firm rates.
Secureds sold rapidly. Superior Tas-
manian greasies were in good supply
and sold at top prices.

MRS. SMITH WON HER CASE

R. J. Slater Was the Attorney for the
Successful Plaintiff.

In the case of Philomene Smith, a
full-blooded Indian woman, against
He-yu-tse-mil-kin, to settle a dispute
over the allotment of lands on the
Umatilla Indian reservation, Judge
Callender at Portland on Wednesday
morning decided the case in favor of
the plaintiff.
Philomene Smith married a white
man. She belongs to the Walla Walla
tribe of Indians. When congress
passed the act to make a selection
of lands, she and her husband
took a plot and expended \$700 in im-
provements thereon. Then came the
allotment of 1891, but as Philomene
Smith had been absent from the reser-
vation at the time the first census was
taken and did not have her name for-
warded to Washington until a later
date, it was declared by the commis-
sioners that she did not have a right
to any land. The matter was taken
before the department of the interior,
where it was decided that she had a
right to land, and another piece of
land, not as good as the first, was given
to her which she accepted. In the
meantime, prejudicing her own rights.
Judge Bellinger stated that as the
department had itself decided that she
was entitled to land, and as the act of
congress declared that she could make
her own selection, he could not see
why she should be deprived of it.

Testimony Was Taken in Pendleton.
R. J. Slater was attorney for the
plaintiff, while John H. Hall, of Port-
land, represented the United States
and the defendant. The testimony of
witnesses was taken in Pendleton by
Charles H. Carter, special United States
examiner. Having taken the testi-
mony of the witnesses, Judge Bellinger
with his conclusions, to Judge Bel-
linger, who by this ruling affirms
them. Mr. Slater handled the case
skillfully and won his point contrary
to general opinion.

with their farm help caused by drunk-
enness. This year the matter was
taken up early and petitions were
prepared asking for Sunday closing.
The petitions were freely signed, and
presented to the county prosecutor.

to mourn a beloved daughter, wife and
mother. The funeral train left the
family residence and proceeded to the

afternoon at the Athena cemetery.
