WATER TRANSPORTATION.

The East Oregonian reprints an editorial suggestion made by the Weston Leader on the subject of the improvement of the Columbia river. It will bear careful reading, and should especially be perused by the people who control the action of Portland's commercial bodies. Lately the Portland Chamber of Commerce decided to take up several matters of public import, and among them is the improvement of the Columbia river above The Dalles. It seems likely that the demand made by the Weston Leader will be complied with to the extent of Portland's ability to accomplish it. The attitude of Portland is one of sincere desire to secure this improvement and it will not be wise nor will it be just to impute aught but genuineness to the metropolis in its present movement.

Portland is confronted with opposition by Seattle and Tacoma and, unfortunate as it is to the remainder of Oregon, is not in hearty accord with Astoria on the subject of river improvements.

Hence, Portland must exhibit liberality towards the eastern part of the state, else she will engender hostility hereabouts. This will be deplorable and to prevent it, Portland certainly will advocate earnestly and effectively the appropriation by the general government of money sufficient to place the upper river in navigable condition.

That Portland business men will appreciate the force of this argument, the East Oregonian doubts not. It is obvious that the situation is as herein set forth.

Let it be said further that eastern Oregon is not in sympathy with a quarrel between Portland and Astoria. It amounts to dividing the state, and setting against each other the various sections that must work together, if anything is to be accomplished for the good of the whole state. Oregon is just now at the parting of the ways. This remark has frequently been made by the East Oregonian, and it is again offered as a suggestion to the people of the state. At this time, Oregon is aspiring to become more important among the Pacific coast states, and deserves to make progress during the coming four years, prior to the Lewis and Clark Centennial, such as will place the state in the position its resources and location warrant. If this progress be not made during the next four years, it will retard legitimate growth and leave Oregon where it has stood already too long—in the tail end of the coast procession.

The objects sought may be attained only by co-operation. Division will nullify the state's influence. Quarrels will give us a divided house, and a divided house cannot stand. These observations are commended to the consideration of Oregonians. And also the East Oregonian suggests these for the citizenship of the state to ponder over:

Oregon's next governor must be a man who is capable of, and who desires to see, effectual efforts to secure the proper recognition of the upper Columbia river valley.

Oregon's next elected United States senator must be a man who appreciates the importance of the improvement of the upper Columbia river.

Oregon's congressmen must be men who want and who will strive for federal appropriations for the improvement of the upper Columbia river.

This is eastern Oregon's interest in the coming elections. This interest transcends in importance the claims of any particular political party. It is paramount to questions as to tariffs, paramount to the handling of any issue of national character. In fact, it is vital that Oregon just now have in both state and federal and congressional offices men who will formulate a plan for the complete building up of the commercial system and providing the facilities whereby the commerce may be built up.

It is with these things in mind, that the East Oregonian has advocated the election of eastern Oregon men to state offices, and also urged upon the dominant party of the state that it select for the United States senator a man who, with the present in-
