WERE CONSOLIDATED.

Incorporation Articles Filed in Baker City on Monday-Capital \$3,000,-

The Concord and Red Boy mining companies have been consolidated, is a result of the recent negotiations that have been going on between the Godfreys, Tabers and the owners of the Concord, among them James A. Howard and J. H. Robbins, who appear in the new officiary of the Consolidated. Mr. Howard, secretary of the new concern, makes the following authoritative statement to the East Oregonian: 7th.

"The articles of incorporation of the Consolidated Gold Mines Company were filed in Baker City on Monday. They had previously been filed in Charleston, W. Va. The capital of the company is \$3,000,000. It was formed to take over the properties of the Concord and Red Boy companies, consisting of quartz claims and mines, timber tracts, water rights, mining machinery, tools and a large quantity of personal property besides the realty included in the transfers.

"The stockholders of the new company met on Monday and elected the following directors, who are also officers as indicated in each instance.

"Clark Taber, president; E. J. Godfrey, vice-president; James A. Howard. secretary; J. H. Robbins, treasurer; C.

Although Mr. Howard dld not say anything upon this phase of the deal, it is understood from a reliable source ward the move for erecting them, that the owners of stock in either of plainly showed the great interest selves a home, they say that the idea the former corporations are at liberty

or cash in full for their entire holdings. It is also understood that most, if not all, of the former stockholders in both companies have elected to take stock on the Consolidated, and thus express their faith in the strength of the company that is now formed from both the others.

Regarding the amount of stock held in the Concord in Pendleton, it is true that the majority is owned here, but, as to the exact quantities held in individual instances, no correct statement has ever been published, and it is likely that none will be given out. Guesses may be made by one as well as another, therefore guesses by a newspaper writer have no value. There is no likelihood that the precise amount held in the new company's stock by Pendleton people will be told to the public, since it is not usually the custom of business men to tell their affairs to the world. It is knownhowever, that there is a fine profit accruing to several Pendletonians, from the Red Boy-Concord consolidation, the hundreds of thousands.




