Articles of incorporation of the Lit-Walla Walla River Irrigation Union, was filed with the county clerk at the court house Friday after-The incorporators are J. C. Pritchard, G. A. Hobbs and F. E. Williams. The purpose of the corporation is to purchase, lease, manage, regulate, control the water rights, irrigation and systems now existing and put in dams, reservoirs, canals, purposes, such as controlling the water of the Little Walla Walla river of \$2000, divided into 2000 shares, at a par value of \$1 each.

A Jap section hand, working under Section Foreman F. Robinson, on the O. R. & N. railroad, was brought to town this afternoon suffering with a gunshot wound in the foot. There was no eyewitnesses to the shooting and the Jap's story is hard to get at, but it seems that he was walking up C. P. Strain, of Milton, and Scott the railroad track at mile post 216, 15 miles west of here and a boy about 12 or 14 years of age stepped out from the brush near the track, with a shotcun in his hand. The boy spoke to the Jap and the Jap returned the salute. 


