## IN CIRCUIT COURT

### IRA ROSE RECEIVES SENTENCE OF EIGHTEEN MONTHS

Frank Morris receives a sentence to correspond with that meted out to his confederates, six years—County Road Case From Athena Now Being Tried.

Ira Rose, who rode a hired horse away from Weston and forgot to return, until captured by Constable Lieualten at Thorn Hollow, several days after, has been sentenced to serve 18 months in the penitentiary.

William Hess, a bartender at the Golden Rule basement, who was arraigned yesterday evening on the charge of selling liquor to minors, entered a plea of not guilty this afternoon, and his trial was set for Monday. James A. Fee is his attorney.

Pat Rahe, who was arrested on the charge of selling liquor to minors, was sentenced to pay a fine of \$75, which he will serve out in jail.

Dr. W. H. Learn, a dentist of Athena, pleaded guilty to practicing his profession without a license, and was fined \$50. W. H. Peterson conducted the case for the defendant.

Frank Morris, the Helix safe-blower, was sentenced to six years in the penitentiary. He made a statement to the court before sentence was passed, asserting his innocence and claiming his ability to prove an alibi, if allowed more time in which to prepare his defense. He also stated that he has been a resident of Pendleton since 1879, and that this is the first accusation that has ever been lodged against him. The court reminded him that the evidence was plainly against him in this case, and that a jury of his countrymen had found it sufficiently strong to warrant a verdict of guilty, within a very short time after the case was given into their hands. Mr. Collier, the attorney for Morris, asked for leniency in the sentence.

Judge Ellis reminded the accused that it is the custom of courts, in a great many instances, to impose a more severe sentence on a man who stands trial and is found guilty of a crime, than upon those who plead guilty to the same charge, that he would not recognize this custom in this instance, but would make his term of confinement equal to that of his confederates, who have preceded him to the penitentiary.

### JOHN RUSKIN.

#### His Political Views Have a Greater Influence Than His Art Views.

John Ruskin said the world recognized him as an art critic, but that he was a political economist. The people who knew much less of art than he declared him an art critic, while those who knew much less of political economy declared him not an economist at all. Do you see why? His ability as an art critic did not endanger the lot the thieves had stolen while his political views did. And you touch the financial part of a man and he at once spews out all the venom in his being to protect his booty. #### Lincoln the Pioneer Suffragist.

Abraham Lincoln was the pioneer advocate of woman's ballot among the public men of America. Twelve years before the first equal rights convention was held, in a letter to the electors of Sangamon county, dated June 13, 1836, and printed in the Sangamon County Journal, published at New Salem, Ill., Lincoln wrote: "I go for all sharing the privileges of the government who assist in bearing its burdens; consequently I go for admitting all whites to the right of suffrage who pay taxes or bear arms, by no means excluding females."

#### Wanted, Two Witnesses.

In Wyoming, women have had the full ballot for 34 years. For the last 15 years, the advocates of equal suffrage have had a standing challenge, inviting its opponents to find two respectable men in all Wyoming who assert over their own names and addresses that it has had any bad results whatever. The opponents have thus far failed to respond. "The proof of the pudding is in the eating." The men who have had the longest experience of equal suffrage are the best pleased with it.—Progress

### YOUNG GIRL GOES TO PRISON.

Officers Contribute to Buy Her Clothing.

Moscow, Idaho, Jan. 21.—Traveling Guard Meacham left Tuesday for Boise in charge of Ida Laherty, the 15-year-old girl recently sentenced to the penitentiary for one year, having been convicted of horse-stealing. Before leaving the officers and deputies about the courthouse united in providing funds with which the girl purchased underclothing and Guard Meacham and Deputy Sheriff Lieualten joined in the buying of an entire suit. Considerable sympathy has been awakened over the girl's condition, and strong efforts will be made to have her pardoned, or her sentence commuted so that she can be released on parole. Letters have been written to the warden from the sheriff's office urging that he provide her with quarters outside the penitentiary until her case can be brought before the state board of pardons. The girl, whose crime consisted in hiring a buggy and team from a stable here, which she drove into the Big Bend country, is mentally no more developed than many girls of 10 years old. Her parents are poor people and the girl has been raised in ignorance. She has never had school advantages even of the most meager kind, and can do no more than read.
