

The honor came to her after the late King Humbert had heard her sing the role of Azucena in "Il Trovatore" at La Scala in Milan. His majesty, like the remainder of the audience, was

held spellbound by the dramatic force and realism of the young mezzo-so-prano's impersonation of the vengeful gypsy who abducted the child Man-rico. Humbert commanded that she appear in the small theater attached

to the palace in Rome. Miss Shay obeyed, and appeared alone before the entire court. She gave scenes from "Il Trovatore," "Cavalleria Rusticapa," "I Pagliacci", and "Aida." When she had ended and the royal applaves had enset the total the royal applause had spent itself she was received by Queen Marghareta herself. While such honor was frequently given by Queen Victoria to foreign singers, it was quite unheard of in exacting and music-loving Italy until the advent of the beautiful American prima dorna., Miss Shay alweays ears this locket hidden under her plcturesque sypsy garb when she ap-pears in "Il Trovatore" having the undoubtedly the greatest Azecuna since Schalchi. 
