The leaders of the movement who are already here ex-plain that their purpose is not to inplain that their purpose is not to interfere with the work of the commission now investigating the cause of the anthracite coal strike, but to inquire into the conditions which are becoming so alarming throughout the country, and to devise, if possible, some means of relief. Another purpose in holding the convention in Washington is to bring the opinions of a representative body of men be-tore the federal government and con-gress. By doing this it is hoped the federal authorities will be induced to take the necessary action for "the welfare of the people," instead of listening to the claims of the mine operators and distributors, who are more interested in getting exhorbitant prices, it is urged, than they are in supplying the actual necessities "of a freezing humanity."


