ST. CYR ON TRIAL

"HAIR OIL PETE" SHOT HIS MAN THREE TIMES.

Finn Girl Sole Witness to Shooting—Row Over a Horse Brought on the Killing—Hearing Set for July 20.

Idaho City, June 23.—The preliminary examination of H. M. St. Cyr, the mining man, who is charged with the murder of Archie Emmonds, of Lardo, was completed for the time being yesterday. After the evidence for the prosecution had been taken the hearing was postponed until July 20 to give the defense an opportunity to make any showing it may desire. It is believed, however, the defense will not introduce any evidence and the opinion is quite general that the case is closed so far as the preliminary hearing is concerned, the formal finding of the committing magistrate being the only action necessary to close it. There is no doubt St. Cyr will be held for trial. An effort will be made to get him admitted to bail.

The principal testimony was given by Hilia Kofki, the Finn girl who was an eye witness of the tragedy. She said she saw Emmonds rise up to the St. Cyr place, tie his horse and go into the stable. He came out leading the two horses, possession of which formed the basis of the dispute between the two men. Emmonds had not proceeded far with the animals before St. Cyr appeared on the scene and shot him with a rifle, according to the witness. She ran into the house, hearing two more shots after she gained the inside.

St. Cyr is reported to have said that Emmonds fired three shots at him from a revolver before he fired. A revolver was found at the spot where Emmonds first fell, lying beside his hat. Four chambers were empty. The theory of the prosecution is that St. Cyr placed the revolver there after firing shots which lodged in a shed in line with where he was standing.

The evidence disclosed that two bullets found lodged in Emmonds' body. The first struck him in the right jaw, ranging around and severing his jugular. Emmonds went about 10 feet and fell. He arose and went 40 or 50 feet farther, his course being traced by the blood. It is claimed St. Cyr shot him again back of the right ear, the shot lodging above the left ear just under the skin. Nothing was brought out in the evidence to substantiate the statement that there were powder marks on the victim's head.

COAL ON JOHN DAY

SUMPTER SYNDICATE WILL OPEN UP THE FIELDS.

Lack of Transportation Facilities the Only Obstacle to the Early Development of the Mines—Lies 75 Miles Below Canyon City.

A Sumpter syndicate, composed of W. E. Saunders, C. S. Miller, Lewis Walker, Anthony Mohr, J. M. McPhee and C. E. Peterson, has been organized to exploit the coal fields of the John Day valley. The syndicate has, through options, leases and purchases, secured control of 1108 acres of land lying on the John Day river, 75 miles below Canyon City. This land lies in what is considered the very heart of the coal fields, as exposed by the outcrops of the coal seams. Samples taken from representative points gave the following interesting results: Sample No. 1—Moisture, 5.45; volatile matter, 15.30; fixed carbon, 44.70; ash, 26.10. Sample No. 2—Moisture, 12.05; volatile matter, 29.45; fixed carbon, 41.40; ash, 34.54. Sample No. 3—Moisture, 3.50; volatile matter, 39.25; fixed carbon, 27.40; ash, 29.45. Sample No. 4—Moisture, 4.24; volatile matter, 34.85; fixed carbon, 53.26; ash, 7.65.

From the foregoing it will readily be seen that the coal is a good grade of coking coal, and that it is in sufficient quantities to be of commercial value is evidenced by the fact that the seams are from 8 to 40 feet wide.

The coal occurs several miles back from the river, at an elevation of from 600 to 700 feet above its level.

There is a rapidly growing demand locally for even an inferior grade of coking coal, caused by the building of the Sumpter smelter, and the projection of other smelting plants in this district. One drawback to the commercial value of the John Day coal is the fact that it is at present isolated from transportation lines.
