LIFE SKETCH OF C. B. BELLINGER

Records Many Years of Great Activity in Law, Politics and Public Affairs.

AN OREGONIAN FOR

FIFTY-EIGHT YEARS.

Admitted to the Bar in 1863, But at Various Times Engaged in the Newspaper Business and in Mercantile Pursuits—Was a Soldier in the Modoc War—Was a Lifelong Democrat, and as a Federal Judge Was an Appointee of President Cleveland—As a Candidate He Followed Democratic Fortunes.

Portland, May 13.—Judge C. B. Bellinger, United States district judge, died at his home in this city at 4:15 last evening, after 19 days illness with the grip.

Charles B. Bellinger was born in Macon, Knox county, Ill., November 21, 1839, and at the age of 8 years came to Oregon with his parents and grandparents. After receiving a common school education, supplemented with two years at Willamette university, he began to read law at Salem in the office of B. F. Bonham, afterward United States consul at Calcutta.

He was admitted to the bar at the September term of the supreme court in 1863. Immediately thereafter he engaged in the practice of law at Salem in partnership with J. C. Cartwright, who was afterward district attorney and commissioner of internal revenue for Oregon.

The firm rapidly acquired a good business and Mr. Bellinger became actively interested in politics. He gave up the practice of law to become editor of the Arena, a new democratic paper that was founded by Joseph S. Smith and others. After an editorship that was successful Mr. Bellinger's health became impaired and he retired from editorial work in 1866 and with another engaged in the mercantile business at Monroe, in Benton county, until 1869, serving in the meantime, in 1868, a term in the legislature as representative from Benton county.

Becomes Editor.

In 1869 he moved to Albany, Linn county, to practice law with N. H. Cranor of that place and at the same time to take the editorship of the State Rights Democrat, a newspaper. He afterward sold out his interest in the paper to his partner and in the fall of 1870 removed to Portland, where he has resided continuously since.

In 1871 he was appointed by Governor Grover to the office of prosecuting attorney for the fourth judicial district of the state. In 1872 he was nominated on the democratic ticket for the office of prosecuting attorney, but with other democratic candidates was defeated, though he ran ahead of the ticket.

In the Modoc War.

In 1872 he went to the Modoc war with General John P. Miller, in the capacity of aide and with the rank of colonel. He remained until peace was established. He participated in the battle of the Lava Beds, January 17, in which the United States troops under General Wheaton, the Oregon volunteers, were defeated by Captain Jack with heavy loss. He was upon General Wheaton's staff during the engagement and received honorable mention for his services in that officer's report of the battle.

In 1874 he was appointed clerk of the supreme court of the state and was ex-officio reporter of its decisions. While holding that position he served as chairman of the democratic state central committee during 1876 and 1877, covering the exciting period of the Tilden presidential campaign.

Appointed Judge.

In the fall of 1878 he resigned the clerkship to accept the circuit court judgeship for the fourth judicial district, then comprising the counties of Multnomah, Clackamas, Washington, Clatsop and Columbia. At the general election in 1880 Judge Bellinger was the democratic candidate for circuit judge, but with the ticket was defeated.

On his retirement from the bench he resumed the practice of law in partnership with John M. Gearin and continued until the fall of 1888, when

he became a member of the firm of Dolph, Bellinger, Mallory & Simon. He was married early in life to Miss Margery S. Johnson of Linn county. Four sons and three daughters were born.

In 1893 he was appointed by President Cleveland to the federal judgeship, which position he held until his death.

TO PARDON WOODSON GRAY.

Union County Man Presents Very Strong Petitions.

Salem, May 13.—Woodson T. Gray was yesterday received at the penitentiary from Union county to serve a sentence of five years for manslaughter. No sooner had he been placed in the custody of the prison officials than Governor Chamberlain was presented with strong petitions asking that he be granted a pardon. Governor Chamberlain has taken the matter under advisement, but the petition is so strong and the circumstances of the case so extenuating that there is a strong probability of its being granted.

Gray, who is a man 57 years of age, is convicted of manslaughter for the killing of A. M. Hallgarth, on March 20, 1903.

The Union county petition is supplemented and strengthened by a petition from Frankfort, Ky., bearing the names of 45 of the members of the legislature and other prominent public men and officials and accompanied by personal letters from Governor Beckham, Attorney General Hays and Secretary of State H. V. McChesney of Kentucky.

All of these testify to the good character and standing of Gray, when a citizen of that state and Tennessee, where he was born and also set forth that his people are of the best of the blue grass country.

Gray is known in Oregon and was convicted under the name of Woodson T. Gray, but all of the letters and the petition from Kentucky refer to him as N. W. Gray.

Another Body Identified.

Harrisburg, May 13.—The body of another victim of the Pennsylvania wreck was identified today as that of William H. Holmes, of Philadelphia. Five unidentified bodies will be buried this afternoon.

CROKER'S SON WAS DOPE FIEND

CHINAMAN WHO RUNS A

HOP JOINT ARRESTED.

Negro Porter Probably Innocent of Any Intention to Get Croker Into Trouble—Kansas City Chief of Police Does Not Believe Croker Was Robbed or Drugged, But That Death Was Caused by Too Much Smoking—Croker Senior Indifferent.

Kansas City, Mo., May 13.—A warrant was issued today for Ah Lee, the Chinaman in whose den Herbert V. Croker is said to have smoked opium previous to his death. Charles Wilson, the negro porter who piloted young Croker to Lee's den, is held, but will probably be released, as the police believe he tells a straight story. Chief of Police Hayes said this morning he believed Croker's death due to overdosing in opium, and that he was not drugged or robbed.

Croker Smoked Opium.

Kansas City, Mo., May 13.—Ah Lee was arrested this afternoon and admitted he sold Croker the drug, and that Croker got Gee Kee, another Chinaman, to cook the pill for him. He said Croker smoked "very much like China boy does."

Narcotic Poisoning.

Newton, Kan., May 13.—The verdict of the coroner's jury in the case of Herbert Croker's death, is that death resulted from narcotic poisoning administered in Kansas City in an unknown manner. The remains are held pending the arrival of his brother, Richard Croker, Jr., who is expected Sunday. There are no marks of violence on the body. The coroner states it is such a plain case of narcotic poisoning that no autopsy is necessary.

Will Not Attend Funeral.

London, May 13.—Richard Croker has wired from Sandford that he will not go to America to attend his son's funeral.

GENERAL STRIKE BEEN

DECLARED IN KHARKOFF.

Bomb Factory Disclosed in Sailors' Quarters at Odessa, and Bombs Found on the Premises—Sensational Story of French Origin About an Attempt to Sould the Russian Heir Apparent by Its Nurse—Rescued by the Czarina—Vice Admiral Assassinated at St. Petersburg.

St. Petersburg, May 13.—A dispatch from Sergaite, in the government of Nizhni, Novgorod, says the peasants are in revolt and set fire to several properties. The fires are preventing all work in the fields.

Will Strike at Kharkoff. Kharkoff, May 13.—Workmen here have proclaimed a general strike for tomorrow. Special precautions are being taken to preserve order.

Bomb Factory Uncovered. Odessa, May 13.—A bomb factory has been discovered at a sailors' headquarters. Six bombs were found on the premises.

Exodus From Moscow. Moscow, May 13.—There is a great exodus of people from the city of the population alarmed by reported impending trouble. Serious disturbances are reported in the districts of Smolensk, Tomsk and Nesselaraba.

Tried to Sould the Heir. Paris, May 13.—The Petit Journal prints a story from St. Petersburg, which alleges that a nurse at Tsariko Selo was caught by the emperor in the act of putting the infant heir to the Russian throne into a bath of boiling water. The dispatch adds that all domestic servants of the household were dismissed.

Vice-Admiral Assassinated. St. Petersburg, May 13.—Vice-Admiral Nasitoff was shot and killed by an orderly in his room today. The orderly fired three shots from a revolver. The crime is attributed to the anger of the orderly at dismissal from his duty as orderly, and being ordered to proceed to the front.

Warships Sighted. Hongkong, May 13.—Seventeen warships were sighted Wednesday night 12 miles off Three Kings, the large rocks off the entrance of Konkape bay. A number of transports were also seen at Knappe Pass, 70 miles north of Kamranh bay.

CHARLES G. REED APPOINTED. Succeeds Matthews as Marshal for Oregon.

Washington, May 13.—The president today appointed Charles G. Reed United States marshal for Oregon, vice Walter F. Matthews. The removal of Marshal Matthews has created a great sensation here. Matthews was for many years a local boss of the republican machine, and closely affiliated with Senator Mitchell, through whom he was appointed. The removal is a result of the land fraud investigations.

Nan is at Home. Washington, May 13.—A crowd of 2500 people greeted Nan Patterson when she arrived at the Pennsylvania station at 7:30 this morning. Nan's brother was the only member of the family at the station to welcome the actress home. The crowd cheered as the Patterson-Smith party walked through the station, and took a carriage for the Howard avenue home, where the sorrowing mother is waiting for her daughter.

Twenty-two Miners Killed. Budapest, May 13.—Twenty-two miners were killed today by a premature explosion during blasting operations in the Almas coal mine at Resicza.

ULTIMATUM BY TEAM OWNERS

As it is Received Will Determine the Outcome of the Teamsters' Union Strike.

EITHER BE ABANDONED

OR GREATLY AMPLIFIED.

Union Leaders Declare They Will Not Allow Delivery of Goods to Strike-bound Houses—The Eighth Death to Result From Strike Causes Took Place Today—The More Violent Phases of the Strike Are Subiding, and the Police Force Is Being Greatly Reduced.

Chicago, May 13.—Two hundred additional wagons were put into service this morning by the employers. Because of the subsiding of violence, the police force on duty as a result of the teamsters' strike, has been reduced by 100 men.

The unions this morning distributed 5000 buttons with a black border, inscribed, "We mourn the loss of a dead brother." The caption is supposed to refer to the death of George Prince, the union teamster killed by Deputy Sheriff Waldron.

Team Owners' Ultimatum.

The Team Owners' association held a special meeting at noon today to consider their position in the teamsters' strike, and decided to deliver to the strikers' committee tonight their ultimatum, that the association will insist on their contracts with them being struck. Unless the labor men at Sunday's meeting recede from their position that the Team Owners' association remain "neutral" in the present trouble, this action means one of two things: spread of the strike, or its practical abandonment.

Eighth Death Occurs.

President Shea, of the Teamsters' Union, said this afternoon the unions will never comply with the requests of the employers that union drivers be allowed to deliver to strikebound houses, and that "any concern that wants a lookout of its teamsters can have it by delivering goods to these firms."

The death of Harry Grady at Provident hospital today makes the eighth victim of the teamsters' strike.

Roosevelt Will Push the Button. Norfolk, May 13.—It is announced this morning the president will formally open the Lewis and Clark exposition June 1, by pressing a key in his office in the White House. Also that Vice President Fairbanks will travel personally to Portland to be the president's representative on the occasion.

Lieutenant Truxton Dead. Norfolk, May 13.—Lieutenant Commander William Truxton, U. S. N., died here this morning of beriberi, contracted in the Philippines. He was 44 years of age and a son of Commodore W. E. Truxton.

All Bids Rejected.

This forenoon the county commissioners rejected all bids for the construction of the two bridges in the north end of the county, one of which was to replace the John Day bridge, and the other the North Fork bridge. It is said that the plans for the bridges will be altered somewhat before the next bids are called for.

Killed a Bear.

Jimmy Hackett is swelled up to twice his natural size over killing a savage brown bear about as large as a small sheep. It is on exhibition in front of the Empire meat market. Jimmy will tell you all about it.

Inspections for Scabbies. The total number of inspections of cattle for scabbies during the fiscal year was 1,124,321; the total number of dippings was 157,757, of which 59,788 were re-dippings. The number of cars cleaned and disinfected on account of this disease was 532. The number of horses inspected from January 1 to June 3, 1904, was 752, of which 453 were found to be scabby; 139 infected were dipped in lime and sulphur.

\$13,950 FOR THE PLAINTIFF.

Defendant Held an Option on Miss Edith Gibney.

Pittsburg, Pa., May 13.—The jury in the Steiner-Gibney \$50,000 breach of promise case this morning returned a verdict awarding \$13,950 to the plaintiff, Miss Edith Gibney of St. Louis. Claus J. Steiner, defendant, is a civil engineer, and a member of a prominent Pittsburg family. According to the evidence the engagement was in the form of an option on Miss Gibney, and the suit is known as the "human option" case.

ONE HUNDRED TEN BODIES.

Cloudburst Follows the Oklahoma Cyclone.

Snyder, Okla., May 13.—One hundred ten bodies of cyclone victims have been brought in altogether. Three more were found during the night.

Yesterday's cloudburst submerged the entire valley in which the town lies, and water is neck-deep in places. The relief committee sent out an additional call for supplies today. Another relief train from Hobart arrived this morning.

FIGHT IN CASPER MOUNTAINS.

Sheriff's Posse Overtook Bandits Who Broke Jail.

Casper, Wyo., May 13.—The sheriff's posse overtook the three prisoners who overpowered the guards and escaped from jail last night. A desperate battle was fought in the Casper mountains, but the outcome is not learned. Two more posesses were sent in pursuit of the bandits.

DECLAMATORY CONTEST.

Baseball Decided in the Ninth Inning—The Total Point Record in the Field Meet Was 59 for Whitman, 33 by Pendleton, 19 by Baker City, 5 by Union and 1 by La Grande—Below Is Given a Complete Record of All the Events With the Exception of the Few Published in East Oregonian Yesterday.

Walla Walla, May 13, 1 p. m.—(Special to the East Oregonian.)—By the close score of 9 to 8, Whitman college won from Pendleton high school in the game of baseball played here this forenoon. The run which finally placed Whitman in the lead was made by them in the ninth inning. It was either side's game almost to the last. Strand pitched the entire game for Pendleton, and Rigby for Whitman.

Miss Edgerton Won. The declamatory contest held at Whitman chapel last night, was won by Miss Edgerton of Whitman academy. Second place was won by Miss Naomi Williamson, of La Grande, and third place by Miss Lorene Parr, of Baker City. Fourth place was won by David Hill, of Pendleton, his score being but one point behind Miss Parr. The declamation by Hill was splendidly delivered, and it was generally expected that he would be given a place at least, if not the winning one.

A large crowd attended the contest in Whitman chapel, and the various speakers were each loudly cheered by their respective delegations. Whitman Academy Won. In the track meet held here yesterday afternoon, the day was won by Whitman academy, 59 points being taken by them; 33 by Pendleton high school, 19 by Baker City high school; 5 by Union, and 1 by La Grande. The star place taker of the meet was Cox, of Whitman, who had four first places, and won a total of 23 points for his school.
