## WESTON NORMAL IS IN NO DANGER

WILL LIVE AND BECOME  
A PERMANENT SCHOOL.

Superintendent Ackerman Says the Normal is in No Danger From the Tie-Up of the State Appropriation and the Referendum—Is Needed in Eastern Oregon to Prepare Teachers for the Public Schools—It is a Vital and Far-Reaching Task to Teach Teachers.

"I have no fears whatever for the Weston Normal school," said State Superintendent J. H. Ackerman to the East Oregonian this morning.

"The Weston Normal is not in any danger, in my estimation, and will remain one of the permanent institutions of Eastern Oregon. It is needed in this section to educate teachers, and prepare them to conduct the public schools along right lines. If we believe in public schools we must believe in training public school teachers so as to make the public schools right.

"The influence of one well trained teacher is not confined to her own immediate circle, but let us suppose a case: Say we graduate a first-class normal teacher at Weston, Monmouth or from some other normal school, and this teacher enters the public schools as a teacher. The public that grow up under guidance and training imbibe her principles, take unto themselves her methods and manners and so as these pupils come to the graduation period and go, themselves, to become teachers in the public schools, they carry with them to put into actual practice the training their old teacher received from the Normal, and in return gave them.

"It is a far-reaching and vital thing to teach teachers."

### SAVINGS BANK REPORT.

Excellent Showing Made by Pendleton Bank by Its Last Financial Statement.

The last financial statement made by the Pendleton Savings Bank and published in the East Oregonian today, shows a healthy condition in that institution.

The deposits as given in this report are \$1,015,107.46, the cash on hand amounts to \$292,493.18, the loans and discounts \$886,092.67. The buildings and property of the bank are valued at \$30,000 and the surplus and capital stock amount to \$100,000.

### Development at Irrigon.

F. B. Holbrook, superintendent of the Oregon Land & Water company irrigation project at Irrigon, left for home this morning after attending the Good Roads convention here yesterday and last night. Over 200,000 fruit and shade trees will be planted at Irrigon within the next year. Already over 100,000 have been planted for wind breaks to prevent the sand from drifting. Mr. Holbrook made a practical talk on road building in the sandy districts, before the convention yesterday, and declared that the residents of Irrigon would be willing to bear a tax of \$20 per acre to build permanent good roads.

## IN CIRCUIT COURT

GROVER MARTIN TRIAL  
SET FOR MONDAY NEXT.

Trial of Moses Taylor for Alleged Plotting of Arson, Set for June 20—Four Gamblers Pleaded Guilty and Were Fined—Jury Chose in Damage Case Against O. R. & N., and Trial Is in Progress, Several Witnesses Being Examined Today.

In the circuit court this morning the trial of Grover Martin was set for next Monday forenoon, and that of Moses Taylor for attempted arson, for the Thursday following that date. The demurrer filed by the defense in the Taylor case, and which was argued by the attorneys yesterday, was overruled by Judge Ellis.

The following gamblers or owners of saloons in which games were allowed entered pleas of guilty, and were fined the amounts stated: J. A. Ogg, \$75; J. E. Russell, \$50; Frank O'Hara, \$75, and Tex Langiver, \$50. Those fined \$75 had been before the court before.

Following the above cases that of T. J. Price vs. the O. R. & N. company for the recovery of \$2000 damages, was taken up, and a jury chosen and the trial proceeded with. The above sum is sought by Price for damages alleged to have occurred to his farm property as the result of a fill made by the company adjoining his place, and through which an insufficient opening was left for the passage of water. As a consequence of the above the water was dammed during a heavy storm, inflicting the injury. The railroad company is being defended by A. C. Spencer and Carter & Raley, while Halley & Lowell appear for the plaintiff.

This forenoon T. J. Price, J. H. Price and A. H. Kees were placed upon the stand to give evidence in the case.

### INDIANS IN MICHIGAN.

Umatilla Are Greeted by a Flood and Wade Three Miles in Water Before Reaching Grand Rapids.

A letter from Fred Parr, head of the band of Umatilla Indians now in Grand Rapids, Mich., says that the company reached that city just following the great floods that swept that district last week and they were compelled to travel through water for five miles in reaching the town.

When the water subsides and the baseball park appears above the floods, the Indians will move into their summer quarters near the city, where they will prepare to ride wild horses and conduct a wild west show under the direction of Daniels & Co., of Grand Rapids.

Mr. Parr says the Indians do not like the country just now, very well, and intimates that they may be seen on the reservation in this county, unexpectedly, any day.

### Autos Reach Oregon.

The racers in the transcontinental automobile race reached Ontario today and start across the interior of Oregon by way of Burns, Prineville and Salem, to Portland, where they expect to arrive about June 19. Until yesterday the autos were 300 miles apart, one having fallen behind in the race coming through Nebraska. The leading auto, however, waited at Boise for the delayed partner and both entered Oregon at the same instant and are now on the home stretch across the state. A prize of \$1000 awaits the winner of this race of 2000 miles, at Portland.

### Removing to Topeka.

Mrs. Charles F. Brown will leave tomorrow for Topeka, Kan., where she will make her future home. Since coming to Pendleton some five or six years ago, Mrs. Brown has made numerous friends who regret seeing her go. The body of her husband, Conductor Charles F. Brown, will be removed from Olney cemetery, this city, and will be placed in one of the beautiful cemeteries of Topeka.

The funeral of J. S. Holmes, who died at the hospital yesterday from the effects of injuries received by having a tree fall upon him near Ukiah, last Friday, was held today at Pilot Rock. Rev. Robert Warner, of the Thompson Street Methodist church, conducted the service.

Your committee on resolutions respectfully submit the following:

Be it resolved, That the citizens of Pendleton and community fully appreciate the courtesy and honor conferred on them by the officers of the National Good Roads association in the selection of this city as the place for holding a National Good Roads association convention, and the able efforts of the officers of the association in presenting the cause of good roads to our people; be it further

Resolved, That the thanks of this convention be especially extended to the Hon. Martin Dodge, director of the office of public road inquiries, agricultural department of the United States government, for his presence at this convention and his valuable and interesting address upon the subjects under consideration; be it further

Resolved, That this convention extend its hearty thanks to the Commercial association, the city council, the mayor and other citizens of the city and county in arranging for and carrying out the details of this convention; be it further

Resolved, That we heartily thank the railway companies of the west for the assistance they have already given in the good roads movement, and we realize and appreciate their disposition to co-operate with us in the promotion of the cause of good roads upon which we are now entering; be it further

Resolved, That the citizens of Pendleton and Umatilla county represented in this convention fully appreciate the value and importance of good roads to the moral, educational and material progress of our people; that while the time may not yet be ripe for the general adoption of a policy of construction of hard roads throughout this county, nevertheless, this convention fully endorses the idea of good roads and of the education of the people to the importance of good roads as rapidly as the means of our people will permit; be it further

Resolved, That we believe that any experimental work carried on in this state by practical demonstration will be of primary and substantial value in the improvement of the highways of this state and will consequently enhance the value of all our property, rural and urban alike. To this end we most earnestly request Hon. W. H. Moore of the National Good Roads association to send to Pendleton as early a date as possible the association's construction train with expert road builders and road machinery to construct a model section of permanent road, suitable to the conditions of our city and county; be it further

Resolved, That we recommend to the careful attention of the city council of Pendleton, the board of county commissioners of Umatilla county, and to the county road supervisors, the suggestions made in this convention as to the purchase and use of heavy steam rollers in the construction of roads, and the building of bridges and culverts of more substantial and permanent type; be it further

Resolved, That it is the sense of this convention that the city of Pendleton and Umatilla county should be represented at the National Good Roads convention to be held in Portland, Ore., June 22, 23 and 24 next, and to that end we recommend that the Umatilla County Good Roads association appoint three delegates, and that the Commercial association appoint three delegates, and that the expenses of these delegates so far as practicable be borne by these organizations; be it further

Resolved, That the thanks of the convention be extended to the various speakers who have addressed the convention. Respectfully submitted.
