GENERAL NEWS.

Lee Furman and John O'Brien were hanged at Lancaster, Pa., for the murder of Samuel Ressler, an aged tollgate keeper during July, 1904.

The authorities of Ecuador have declared a quarantine against all vessels from Panama, alleging that bubonic plague prevails on the isthmus.

Max Wiley, of Rochester, N. Y., threw Demitral (the Terrible Greek) in five minutes of actual wrestling. The Greek contracted to throw Wiley three times in one hour.

J. T. Cooper, Thomas Hilson, James Jackson and J. Longley, all of the 24th coast artillery, are under arrest at Honolulu, charged with counterfeiting and passing bogus coin.

The unionized newboys of San Francisco are boycotting the Bulletin of that city because of the bitter fight it is making on Mayor Schmitz. Many fights and small riots have occurred.

The new management of the Equitable Assurance society, as a measure of economy, has discontinued the retainer of Senator Dewey at \$20,000 a year and of ex-Governor David B. Hill at \$5000 a year.

Richard A. McCurdy, president of the Mutual Life Insurance company, of New York, demands an official examination of the company's affairs. It has been ordered, and will be made by Insurance Commissioner Hendricks.

The Russian Black Sea fleet consists of nine battleships, three cruisers and several miscellaneous and smaller vessels, all confined to the waters of the Black Sea by treaty agreement dating from the Russo-Turkish war.

The Pittsburg Steel company has just closed with the United States Steel corporation a \$25,000,000 contract—for 1,000,000 tons of Bessemer and open hearth steel billets. This is the largest transaction of the kind in the history of the world.

NORTHWEST NEWS.

The Valencia has arrived at Seattle with \$500,000 in gold from the Tanana district.

Forest fires are raging in eastern Alaska and adjacent portions of the Northwest Territory.

Portland led the world for lumber shipments during the year 1904. The total for the year was 132,000,000 feet.

The Seattle bank clearings on June 28 amounted to \$356,172. On the same date one year ago, they were \$748,551.

Since January 1, 1905, nearly 100,000,000 feet of lumber has been shipped from Portland, breaking the half year record.

All the principal towns of British Columbia on July 1 celebrated the 38th anniversary of the Canadian confederation.

Seattle is to have a new \$500,000 steel plant. Of the amount named \$50,000 must be raised in Seattle with which to secure a site.

Johann Grumstad, a laborer, was run down and crushed to death by a street car in Seattle. The employees of the company were exonerated from all blame.

T. J. Denton, a Missoula man, was treed all night by a cinnamon bear. He was rescued in the morning by his 15-year-old daughter, who shot and killed the bear.

The government wireless telegraphy system between Nome and St. Michael is complete and work on the section between Valdez and Cape Flattery, 1700 miles apart, is progressing rapidly.

McMANUS' REPUTATION.

**Dark Secrets Cannot Be Revealed by Partner in Crime.**

For some reason or other the dark secret of the life of the editor of the Pilot Rock Record is in demand in Pilot Rock and to the man who can furnish it there is a sack of gold, says the Pilot Rock Record. A. J. Sturtevant, who is not a millionaire, but a very rich man for a town the size of Pilot Rock, evidently intends to write a book in which he will figure as the Sherlock Holmes or the Bob Pinkerton, with the eyes that never sleeps. The editor of the Record, it is evidently intended by Mr. Sturtevant, shall be the Jean Valjean, the ticket-of-leave man; hence the great interest taken in learning something concerning the early life of the editor. Sitting in his water-ditch irrigated temple, he writes the following letter to James W. Connell, the well known newspaper man of Baker City: Pilot Rock, Ore., June 22, 1905.—Editor Sumpter Miner: I was referred to you to find out the reputation of one John McManus, editor of the Pilot Rock Record. The fact of the business is, Mack and myself stole horses, robbed stages and graves and—worse of all, run a newspaper—together down in the Black Hills.

**Summers Was Convicted.**  
"Guiltily as charged," was the verdict agreed to by the jury in the Summers case in five minutes this morning. From the hearing of John Crate's story as to the shooting and corroborating evidence of seven or eight witnesses against four for the defense, it was evident which way the case would go, the defense seeming to have no case at all. Summers seemed to take it in a philosophical manner, having little to say as to the result. ALASKAN STAMPEDE DUE.

Tanana District Will Yield \$1,000,000 in Gold This Year.

C. R. Corbuser, in charge of the government mails along the Yukon river for the Northwestern Commercial company, returned to this city Thursday morning on the steamer Valencia, and registered at the Stevens, says the Seattle Star. When seen by a Star reporter Corbuser said: "The Tanana district this season will be one of the liveliest in the north. There will undoubtedly be the largest amount of gold brought out of that section of the north in the country's history. It is estimated by well known miners that the Tanana output will be over \$1,000,000. "The steamship business on the upper rivers this season will be more extensive than it has ever been before. Our company has begun the construction of a new river boat for the Yukon. Before the season closes this year there is going to be a stampede up the Yoyokuk river. In that section of the north there have been some wonderful strikes of late bound to draw the attention of thousands of miners.

Water fillings on tributaries of Rogue river, in Jackson county, have been made by the Gold Hill Canal company. Seventy-six miles of mains are projected.
