

# AMONG THE EXCHANGES OF THE INLAND EMPIRE

**Suicide at Twin Falls.**  
Without giving a hint of his intention or a shred of reason for his action, George Johnson, the proprietor of a small restaurant on Twelfth avenue, behind the Jones building, shot himself through the head with a rifle on Thursday evening and died instantly, says the Twin Falls News. L. B. Hale and the wife of the suicide were eye-witnesses of the tragedy. Hale and Johnson were sitting in a room conversing. Johnson appeared to be in low spirits. He wrote a letter to his mother and read it to Hale.

Picking up his rifle, which stood against the wall near by, Johnson remarked that it was a good weapon. Before his intent could be detected, he placed the muzzle of the weapon beneath his right ear and pulled the trigger. The bullet passed through his head coming out above and behind the left ear. Death was instantaneous.

Mrs. Johnson stepped into an adjoining room to put the children to bed just as her husband grasped the rifle. She heard the shot and rushed into the room where her husband was, in time to see him topple over.

**Increasing Water Supply.**  
The water company has developed the fact that there is more artesian water in Hull's gulch than had been supposed. At the time of the flood in June one of the wells in that gulch was washed out. This well supplied about 160,000 gallons of water daily. It took a long time to dig out the wrecked top and put the well in order again. This work satisfied the company there was more water there and a new 6-inch well has been sunk, it and the old well emptying into a 7-inch pipe. The joint flow of the two is some 450,000 gallons, indicating nearly 300,000 gallons of added daily supply. The plan is to put down still another well of greater size.—Boise Statesman.

**Close Call by a Rattlesnake.**  
While Harvey O. Barnes, who resides on the Coffield place, Monday afternoon was sitting on some bed springs which he carelessly neglected to cover with a spread as usual, with his little daughter Velma, sitting between his knees, whom he was feeding, he suddenly became aware of the presence of a rattlesnake in the springs, just beneath his thighs and about three inches from the infant's feet. Knowing their traits quite well, his movements were cautious to avoid angering the reptile. He first moved

the babe from its perch and then "went straight up." He beheaded the reptile with a pair of pruning shears. It had eight rattles and a button—Goldendale Sentinel.

**Shot by Child.**  
While Mr. and Mrs. Daniels of Cleveland were in Leland last Saturday one of their children was shot by a little 7-year-old brother with a 22-caliber rifle, the ball going through the shoulder, and inflicting an ugly wound. It seems that the children were left at home and they got to playing with the guns that were in the house with the above result. Dr. Lysle of Peck, happened to be in a cherry orchard nearby when the accident occurred and he was hastily summoned and dressed the wound. It is thought that the wound, while serious, is not necessarily fatal.—Leland Sentinel.

**Panther in Lost Valley.**  
A. B. Stanley, who came in from Lone Rock yesterday evening, reports that the people of Lost Valley, six miles from Lone Rock, are greatly stirred up over the presence of a large panther that is roaming at will through that neighborhood and that many settlers have temporarily abandoned their homes. Many calves and sheep of the neighborhood have been slain by the ferocious animal. The panther is said to be a very large one and nobody seems willing to attempt his capture.—Heppner Times.

**Stubblefield Will Case Appealed.**  
The case entitled C. M. Rader et al vs. Cassann Stubblefield, was yesterday appealed by Mrs. Stubblefield to the supreme court by her attorneys, C. E. Cochran, of Union, T. H. Crawford of La Grande, and Happy & Hindman of Spokane. The case is an attempt to break the will of the late Joseph Stubblefield, as it particularly relates to the maintenance of the Stubblefield home in this city.—Walla Walla Union.

**Boise River Falling.**  
The water has been going down rapidly in the river for the past week and it has now assumed the proportions of a decided shortage, because the companies near the head have taken up all the water. The people of this section cannot hope for relief soon, as Judge Stewart is quite sick and cannot, without endangering his life, render a decision. It is hoped the judge may soon recover.—Caldwell News.

Very Little Public Interest is Manifested.

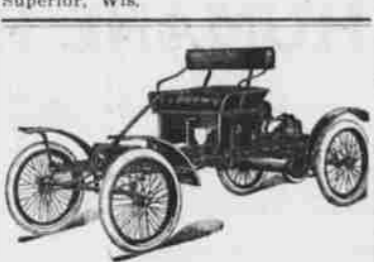
