

AMONG THE EXCHANGES OF THE INLAND EMPIRE

Will Irrigate 4000 Acres.
H. L. Powers, manager of the Lewiston & Sweetwater Irrigation company, left yesterday for a business visit in Portland. Mr. Powers states the work on the ditch is progressing most satisfactorily and will be completed within the contract time.

The company has recently awarded the contract for hauling 500 barrels of cement and a large quantity of sand to the reservoir site on the reservation beyond the Stevens ranch where preliminary work has been commenced on the dam for the reservoir. The company will soon award the contract for moving 750,000 cubic yards of earth, which will enter into this construction and specifications of the work are now being completed.

It is estimated that at least two and one-half years will be required to complete the construction work now planned by the company and by which 4000 acres of the most productive land of the Lewiston flat country will be placed under irrigation. The first work on the reservoir will provide storage room for sufficient water to irrigate 1000 acres and this work will be completed in time to catch the surplus water of the spring freshets.—Lewiston Tribune.

Deep Snows in Klamath.
The snow in Swan lake valley was so deep for some weeks that people living on the north side could only get out on snow shoes. H. J. O'Brien and Charles Linky had one of the hardest rides of their lives getting some horses out of the snow near the shingle mill.

Five dead horses were recently found in a bunch in Hungry Hollow. The snow was so deep they could not travel, and the poor brutes starved to death. No doubt this will be the fate of hundreds of horses in the Sprague river region before the deep snow is gone.

The Hibbard brothers report that the heavy snow of three weeks ago broke down the roof of their shingle mill on Edgewood, breaking and injuring some of the machinery. See Pond's sheep stable roof also broke down from the same cause. There were 20 head of sheep under it at the time, but fortunately none of them were hurt.—Klamath Falls Express.

Batch of Yakima Sentences.
Judge Rice this afternoon sentenced Joseph Whitley, the negro, who killed a fellow workman at Tappanish last summer, to 20 years in the penitentiary.

Joseph Anderson, for burglary, was given 14 years. Anderson stole a horse here some months ago and was sent to the reform school. He was too old to be kept there, and was returned to North Yakima. Judge Rice sentenced him to 14 years.

British Unemployed for Canada.

London, Feb. 13.—Fifty of the 200 families which Lord Rothschild proposes to colonize in his own expense in Canada, to relieve the situation among the large number of unemployed in Great Britain, sailed today for their destination. The emigrants received clothes and food, the cost of passage and will find situations awaiting them upon their arrival in Canada, with sufficient sums of money to guard them against emergencies. The total cost for each adult is placed at \$50, which must be repaid in installments. It is expected that when the allotted fund has been repaid, 200 additional families will be sent to Canada under the same conditions. Agents who have made an investigation by order of Lord Rothschild, report that there are openings in Canada for 10,000 respectable persons.

Parr, of the Eastern Oregon Land company, when in the city this morning, "and a number of our best Sherman county people, together with some of yours, are investing as heavily as they can. I have secured over 8000 acres and others have gone deeper." And then when questioned as to the foundation for their faith in the richness of the soil, he said: "Farming there is diversified; you can raise almost anything you like and depend on a sufficient crop to market." There has been an exodus to that state from all parts of the country recently, and the best land is rapidly being bought up.—The Dallas Chronicle.

Major Davidson has received a letter from Lieutenant Edwin G. Davis, to the effect that the lieutenant is about to resign his present military position as assistant instructor of law at the West Point military academy and return to Idaho. The letter also says that Lieutenant Davis has announced his candidacy for the national legislature from Idaho.

Lieutenant Davis is a native of Idaho, his old home being at Malad. He graduated from the West Point military academy and served in the Philippine United States Infantry in the Philippines under Major Davidson. His military career was brilliant.—Boise Statesman.

Affairs on New Plymouth Bench.

More than 200,000 head of sheep are being fed on the New Plymouth bench this winter. The sheep with their feed and equipment amount to more than \$1,000,000. This has been an exceptionally fine winter for feeding and the sheep will go on the range in the spring in good condition. It is thought there is plenty of feed on hand to carry the bands through the remainder of the winter.

The irrigation ditches on the bench were thoroughly cleaned out last fall and will be in better condition to turn water in this spring than they ever were before. Last year ditch breakages caused several thousands of dollars expense and an effort will be made this year to prevent a recurrence of such loss.—Boise Statesman (New Plymouth cor.)
