NEW RIFLES ISSUED

COMPANY L TO RECEIVE
SPRINGFIELDS TONIGHT.

Khaki Uniforms to Be Issued for Summer Season—Company L is Planning Summer Marches and a Camp Near Oliver Place—Drilling Will Be Done to Prepare the Boys for American Lake Encampment.

There will be something doing at the Armory tonight for the members of company L are to be issued the new Springfield rifles and the service uniforms and equipment will also be again issued for use during the spring and summer.

When the company was fitted out with the dress uniforms last fall the khaki suits were stored away for the winter and for the past few months the blue has been worn. Now that summer will soon be here and extended order drill taken up the service equipment will again be brought forth. However, the men will also retain the dress uniforms and they will be used in cool weather and for dress occasions.

In order to fit the company for the work it will have to do at American Lake this summer much extended order drilling will be given this spring. This can be taken up to some extent on the streets and later the company will be taken on Sunday "hikes" during which the entire time will be given to extended order drills, outpost work and other things in which instruction is needed.

After the weather becomes warm a brief encampment will probably be held as was done at the Oliver place last spring.

As the guns and service equipment are to be issued tonight all members of the company in the city are ordered to be present. A business meeting of the company will also be held and the drill will be short in order to permit time for the other work.

MAKE PAPER OF WHITE FIR PULP

NEW INDUSTRY FOR BLUE
MOUNTAIN REGION.

Forest Supervisor J. H. Schmitz Sees Opportunity for Vast New Enterprises in All the Mountain Section of the Inland Empire Where White Fir Is Plentiful.

Forest Supervisor J. H. Schmitz of the Wenaha National forest reserve, yesterday received a glacial letter, together with a sample of white fir pulp, from the head office of the forestry department at Washington, D. C., outlining the possibilities of the paper industry in California and Oregon by the commercial use of white fir in making pulp, says a Walla Walla paper.

In view of the fact of the small commercial value of the white fir from a lumber standpoint, the department advocates its use in the tests show that its value in this industry is much above that in the lumber trade.

There are in the forests of Oregon California and Washington large areas of white fir forests which have remained untouched by the lumbermen of the country because of their comparative small value with red fir and other timbers. As a consequence of this discrimination, the valuable timber forests are fast disappearing while the white fir areas are increasing proportionately.

Some months ago the forestry department at Washington gathered samples of this wood and made chemical laboratory tests of its value for paper purposes. The results of these indicate that the white fir is of great commercial value when used for pulp as the waste is small and the grade of paper made from it is good.

Will Become Leader.

Mr. Schmitz, in speaking of the probable commercial use of the white fir for pulp purposes, last night at Walla Walla, said that he thought it was only a question of time until this wood will be generally used for the manufacture of paper pulp and its value increased accordingly.

In the Blue mountains, east and south of Walla Walla are large quantities of this timber and in the event that the movement advocated by the forestry department gains favor among the paper manufacturers of the country it is merely a question of a few years until Walla Walla and the surrounding country will be supplied with home manufactured paper for all purposes.

Such an enterprise would not only add many thousands of dollars annually to the country's income, but would materially cheapen the commodity in the local markets.

Insane Suspect From Weston.

George Phelps, suspected of being demented, was brought down from Weston last evening by Deputy Sheriff Joe Blakeley. The man is apparently weak-minded and had suffered from exposure incurred in walking from Seattle to Weston. However, he is not regarded as insane and is being cared for temporarily by the county. In hopes that his condition will improve.

Wasco Has Few Delinquents.

Only about \$20,000 still remains upon the tax roll of Wasco county. This is the smallest delinquent tax roll recorded for many years, and speaks well for the prosperity of the people at large. Wasco, being essentially an agricultural section, the abundant crops of last year produce the money for this remarkable condition of the tax roll as it now appears.—The Dalles Chronicle.

A cranberry field of about 30 acres will be started near Eugene on what has always been a non-productive marsh. L. B. Canfield is the promoter of the scheme and believes that cranberries can be successfully grown in that section of Oregon.
