IN DEFENSE OF WOMAN.
Rev. Stanton C. Lapham of the Second Baptist church of Portland in a most unusually bitter sermon last

Sunday evening, branded women as the promoters, advocates and chief supporters of the silly isms which are running rampant through the religious thought of the country at this time. In the first place how can Rev. Lapham brand the new ideas and advanced systems of thought and worship as silly and sinful? He is but a human and must view these things from his human view point, which is necessarily narrow and prejudiced. What right has he to denounce all departures from the beaten track as silly and dangerous?
There are just as good people in the religious lines of thought as he. Because a man stands stationary for half a century in his tracks is no sign that he is wholly right and everybody else wholly wrong. There are just as sincere men and women in spiritualism, Christian Science, New Thought and other advanced religious systems as he or any of his followers. There are good people in every movement and there are bad people, dead weights, obstacles to progress, in every movement.
In the second place, women are not the chief promoters or supporters of the "sinful cults" as Mr. Lapham calls them. Free love is hated by the majority of women it is repulsive, abhorrent to them as is also polygamy. There are 10 men to every one woman advocating the nauseating doctrine of no-marriage, and if Mr. Lapham had taken observations from a high view point he would have noticed this fact.
There are hundreds of men following the lecture platform on free love, holy rollerism, anarchy and other cracked brained fads to where there is one woman. Because Emma Goldman recently visited Portland Rev. Lapham has decided that woman is to blame for all the nonsensical rot of the world. Emma Goldman is but one woman, while dozens, scores of men are out publicly, constantly proclaiming her doctrines for a living, just as Mr. Lapham preaches his doctrine.
One swallow does not make a summer; neither should one woman lecturer condemn the entire sex. And what may seem fads to Mr. Lapham may seem good religion to others just as intelligent as he.
DEMOCRACY APPLIED.
Henry Watterson of the Courier Journal, says that no man or set of

men have a right to say that another man or set of men shall or shall not drink what they want at any time, under any circumstances, on any condition. He declares that "personal liberty" is the essence of democracy and that a man cannot be a democrat and a prohibitionist.
Very well. The world is growing away from democracy if this is a definition of the doctrine. The best judgment of the civilized world today is that every citizen is responsible for the uplift of society; that no man or set of men have a right to maintain an institution in society which is not for the common good, no matter what their personal liberty may be. The rights of society are greater than the rights of any one man or set of men.
The best judgment of the best citizens of the United States is today that no man has a right to make a hog of himself and impose his brutality on his family or his neighbor. It declares that society is entitled to protection from individualism such as Mr. Watterson advocates.
If a sewer should empty near the window of Mr. Watterson's office and should contaminate his entire building with its stench and disease-breeding germs, would he sit still with folded hands afraid to interfere with the "personal liberty" of the man who dumped the filth under his nose?
Or would he go out on the warpath and declare that the rights and safety of his office force were greater than the rights of the garbage man, and abolish the nuisance? Democracy of this sort sounds all right from the lecture platform, but when you apply it to life and government it falls.
Every sane man is responsible for the protection and uplift of society and the rights of the many are greater than the rights of one.
THE OKLAHOMA WAY.
The following report on an Oklahoma bank failure shows the way they do things in that new commonwealth: The International Bank of Colgate was reported to the bank commissioner by one of his examiners a few days ago for violating the banking law of the state, particularly in its managing officers borrowing from the depositors' money.
The bank commissioner at once visited the bank in person and found that the total deposits were about \$37,000, of which the president, L. A. Connors, owed over \$6000, and the

cashier, L. Elzy, owed over \$4000—in other words, about 20 per cent of the deposits had been borrowed by the two managing officers. The bank commissioner demanded that they immediately replace the money. They failed to do so.
He closed the bank at 2:15 Thursday evening; telephoned the state banking board; received instructions to immediately proceed to pay all approved deposits. In 42 minutes from the closing of the bank the bank commissioner was ready to pay approved deposits. By Friday evening 60 per cent of the depositors had appeared, proved their claims and received their money.
By the end of the second day 90 per cent of all deposits had been paid. A few depositors who lived in the country don't seem to be in any hurry about drawing their deposits.
ONE FARMER IS REPORTED AS ANSWERING OVER THE RURAL TELEPHONE THAT HE IS TOO BUSY TO COME AFTER HIS MONEY, BUT WILL WANT IT IN A WEEK OR SO.
In the meantime both the president and the cashier have been arrested for the violation of the state banking law, and are held under heavy bond.
"There will probably be no loss to the state guaranty fund, and no assessment required on other banks. Liquidation will likely reimburse the state fund within 30 days. The loss

will probably not exceed the capital stock."
IT'S THE PEOPLE'S MONEY.
The county court is justified in appropriating \$1000 of the people's money for the people's district fair. This is not a personal matter with Pendleton Commercial association, the district fair board or the county court, but it is a part of the county's business, a part of the educational progress of the country and the taxpayers want a good fair and in order to get it are more than willing to give county funds to help collect a display. Pendleton has prepared the way for the best permanent fair in eastern Oregon. The citizens subscribed \$4000 in gold coin for the pavilion and expenses of the first fair and now that it is over the county must have pride enough to keep it going.
It is the county's business. Pendleton is but a small part of the county. Her citizens are but a handful of the population of the county and the county court must look to the broader interests of the county in deciding this matter.
Let us have the \$1000 appropriation early, so arrangements can be made to collect an elegant display and make a good showing. The district fair must not be allowed to stand still. It must go ahead.
