"SPANISH" RANCH SOLD FOR MILLION DOLLARS

Sheep in Southeastern Oregon Do Not Bring as High Prices As in This Section, Says Dr. Lytle—Lambs for \$1.80 Per Head—30,000 Ewes for \$87,000.

In the extreme southeastern part of the state and in Nevada sheep do not bring the good prices that are paid here. Dr. Lytle, who returned yesterday from that section, says that recently 20,000 head of lambs were sold for \$1.80, while 30,000 old ewes were sold in one lot for the sum of \$87,000. The sheep were small merinos and were owned by a sheepman named Yates.

A ranch deal of no slight consequence, was made in that section not long ago. It was the sale of the big "Spanish Ranch, formerly owned by the Altuba brothers, who are Spaniards. The ranch is 70 miles square and it sold for a million dollars.

The big ranch is used for running sheep, cattle and horses. At the present time 20,000 head of sheep are being run upon the range, 20,000 head of cattle and 10,000 head of horses.

"To Hell With the Law."

It will soon be determined whether it is a case of to hell with the law or 30 days in jail for those whose contempt for the law is proverbial. It is generally known that the local option law is being shamefully violated in Pendleton, Echo and Pilot Rock. The conditions may be exaggerated, but where there is so much smoke there must be some fire. It is said that boys of tender age can go into many drug stores of the county and buy whiskey and that many of the near beer joints have become so em-

boldened that whiskey is sold over the bar by the drink without fear of detection or prosecution and that private gambling rooms are being conducted as of yore by those who frankly confess their inability to make an honest living. Of course it requires labor, muscular effort directed to some useful end, to make an honest living, but this is what the liquor traffic and its attendant evils discourages.

If reports be true, and they seem to be well founded, there will be something doing after the grand jury meets. To those who have been saying, "to hell with the law," it might be well to call their attention to the fact that where two cases against an individual who has been making a practice of violating the local option law is proven it means a jail sentence. The court has no discretion in the matter when the second offense is committed, but is compelled under the law to commit to jail for at least 10 days. A few heavy sentences by the court will not only be productive of a wholesome respect for the law, but it will at once and for all settle what now seems a mooted question, namely, is the sentiment of the people in favor of or against the enforcement of the local option law? By a majority of 700 the saloon was voted out of business in this county, but its enforcement depends upon the efforts of the prosecuting attorney and the sheriff of this county. There are very few who doubt the sincerity of the prosecuting attorney, but unless the sheriff is willing to do his duty it may be expected that the law will continue to be violated. But this will simply delay, and not defeat the will of the majority. More effective than all other forces combined in the crystallization of anti-saloon sentiment is evidence on all sides of disposition to shamefully disregard the law. It will greatly strengthen the local option vote and the official who fails to do his duty will have to look to the minority for support at the next election.—Pilot Rock Record.

TIMBER TAX FIGHT.

Klamath County to Go After Timber Interests.

Klamath Falls, Ore., Sept. 9.—The county court of Klamath county for several days considered the matter of a compromise in the Hunter Land company tax case, which has been in litigation for some time. The Hunter company owns about 60,000 acres of timber in this county, which was originally a portion of the military road grant, extending across the southern portion of Oregon. The lands of this company were assessed without a cruise being made, the assessor using his judgment in fixing the value of the timber owned by the company. The total tax for the year 1907 amounted to \$5,947.33, but the corporation refused to pay, making the claim that the tax was excessive and unjust. Instead of paying the full amount the sheriff was tendered \$1120, which he accepted, and gave a receipt for partial payment.

No other payment was made and in accordance with the law the lands were advertised to be sold under the hammer. The date of the sale was set for February 28, but a few days before the company secured a restraining order and the sheriff was enjoined from making the sale. There were no further developments until the past week, when a representative of the company appeared before the county court and made a number of propositions to effect a compromise. Instead of paying the county the cash they offered to turn in cruiser's estimates on their lands. Some of the lawyers that had been retained by the county advised a compromise, but the district attorney and Judge Thomas Drake, also retained by the county, advised against such a procedure. Most of the lawyers in the city are interested in the case, and as the county has rejected all propositions a hard legal battle is pending.

Steps will be taken at once to proceed to collect the taxes, or else to sell the lands to satisfy the county's claims.

DR. HOUSE HEARS A SPIRIT VOICE

SPOKANE MINISTER STARTLES HIS HEARERS

Congregational Minister Well Known in Pendleton Declares From His Pulpit That He Received a Spirit Message from Murdered Y. M. C. A. Leader—Interest Is Added Because Dr. House Is Not a Spiritualist, But a Congregationalist.

Rev. E. L. House, formerly of the leading Congregational church of Portland and well known in Pendleton, where he has preached and attended Congregational conventions many times in the past, has startled Spokane, where he is now located, by announcing from his pulpit that he had received a communication by means of a spiritualist medium from Reno Hutchinson, the Y. M. C. A. leader who was mysteriously murdered in Spokane last September.

An item from Spokane gives Dr. House's story as follows:

Rev. Dr. Edwin L. House, pastor of Westminster Congregational church of Spokane, created a sensation in the course of a sermon in describing a spirit conversation with Reno Hutchinson, secretary of the Young Men's Christian association of Spokane, who was mysteriously murdered in the residential district while on his way home one evening in September.

The words were transmitted through a medium, who declared that the spirit of her dead brother was the means of introducing her to the ghost of the murdered man and assisted her in receiving messages from the other world. Among the statements attributed to Hutchinson's spirit are the following:

"I do not know who was my murderer.

"I am busy here with religious work—busier than on earth, but able to do more good than in my body.

"My message to the men of Spokane is: Be more earnest than ever in Christian work and open more of your homes to homeless young men.

"If my family were to be told that my spirit had come back to earth and was communicating with friends they would be skeptical. I am perfectly happy and I am watching my family and know they are happy."

Dr. House said that while the conversation was not entirely satisfactory he does not believe the medium acted with any intention of fraud. He has known her for years and says she is a woman of refinement and that her family is one of the oldest and best known in the northwest.

SAVED BY STAGE DRIVER.

Nine Persons and Entire Stage Held on Edge of Cliff.

Chico, Cal., Sept. 9.—Nine persons were hurt, but all were saved from death by the heroic action of Dan Jones, the driver, when the Richardson springs stage coach turned over on a steep grade today.

The accident was caused by a wheel becoming detached from the axle. The stage suddenly lurched and was toppling over when Jones, with lightning activity, jumped from his seat and put his shoulder under the axle.

In this manner he supported the stage until the most dangerous part of the precipice had been passed, but no sooner was the immediate danger of death to all in the coach overcome, than he collapsed and the coach went over.

Jones was badly crushed under one of the horses, and while the extent of his injuries is not known, yet it is feared he may not recover from the terrific strain.

The passengers in the coach were badly shaken up and thrown about, all receiving severe bruises.

The whole accident, with the heroic work of the driver, took but a few seconds. Reports received here say that the wheel slipped off at a place where there would have been little hope for anyone in the coach if Jones had not met the emergency.

Miners' Row Ends in Death.

Redding, Calif., Sept. 9.—Deputies are searching today for J. A. Reid, who caused the death of J. B. Wilson by stabbing him with a miners' candlestick. The wound was inflicted last Wednesday in the Gladstone mine, in a fight over the disappearance of a shovel.

Wilson was apparently not seriously hurt, but Sunday night he suffered a relapse, which resulted in his death. Reid was not arrested at the time of the duel in the mine, as it was generally understood he acted in self-defense.
