



INTERURBAN IS NOT AFFECTED

Though Mayor Tausick Vetoed Franchise, Traction Company Has Another.

WALLA WALLA EXECUTIVE DISLIKES REVISED FRANCHISE

But Gilbert Hunt Says Action Was Expected and That Company Will Use Former Franchise and Construct Line as Soon as Capital Is Secured—Proposition Now Up to Financial Backers and Affairs Are Progressing Favorably.

Though Mayor Tausick of Walla Walla, has vetoed the new franchise that was granted the Oregon & Washington company by the Walla Walla council, his act will have no effect whatever upon the building of the interurban line.

At the Walla Walla council meeting last night Mayor Tausick returned the franchise ordinance with his veto and in a message set forth his reasons for disapproving of the measure. His act apparently means that the franchise will not be granted as the council will not pass it over the objection of the mayor.

Already Had Franchise.

But that the refusal of the mayor to approve the franchise will have really no effect whatever upon the proposed interurban line was declared over the phone this morning by Gilbert Hunt. According to Mr. Hunt the company already held a franchise for Walla Walla and the refusal of the council to grant the pending one does not shut them out of the city. The members of the company regard the original franchise as unsatisfactory in some respects and asked for another more favorable to them. That the mayor would veto the franchise ordinance was anticipated by the members of the company and so they were not surprised at his action last night.

Now After Money.

Regarding the interurban road Mr. Hunt said that up to the present time no definite time has been set for the beginning of construction work, but that the preliminary work is moving along satisfactorily. The project is now up to the eastern men who are to back it and as soon as it has been financed work will be undertaken. Mr. Hunt says that the money for the road will be forthcoming and that the people of Pendleton will not regret the action of the council in voting the road a franchise.

Reasons for Veto.

In his veto message the Walla Walla mayor set forth five reasons why the new franchise should not be granted. His first objection was that the company would be allowed to hold its right to use the streets for 25 years after building, but a single mile of track in the city.

Secondly he objected because the proposed franchise granted the company the right to build two parallel tracks on each street, thereby making it possible to have four tracks on some streets.

His third objection was to the feature concerning fares and transfers within the city.

His fourth objection was that the franchise did not properly secure the city and save it harmless in cases of accidents.

The fifth objection was that under the franchise the mayor of the city could grant the company the right to operate freight cars through the city in the day time. He held the power should rest with the council.

Hurled to Death.

Seattle, Sept. 16.—John D. Haller was hurled 40 feet from the Maynard avenue trestle last evening when struck by a rapidly approaching car which the unfortunate man failed to heed. He was picked up in an unconscious state and died in the hospital this morning as the result of the severe injuries received.

CAMPAIGN IS ON IN PENNSYLVANIA

REPUBLICANS OPEN FIGHT TONIGHT AT WILKES-BARRE

Marching Clubs Parade City Streets All Day in Anticipation of Monster Parade This Evening—Party Leaders Present at Meeting of League of Republican Clubs—Delegates Will Go to Cincinnati.

Wilkes-Barre, Pa., Sept. 16.—A great parade of Taft and Sherman clubs, a business session and a public mass meeting this evening, at which men of national prominence will speak, comprises today's program for the Pennsylvania League of Republican clubs, formally opening the republican campaign in this state.

Republican marching clubs from nearly every city and town of the state paraded through the streets of Wilkes-Barre today, carrying banners and with many bands playing. At tonight's meeting it is expected that addresses will be made by Representative Sherman, candidate for vice-president; Congressman Nicholas Longworth of Ohio, son-in-law of the president; Senators Penrose and Knox, Governor Stuart and other republicans of prominence.

The succeeding days of the convention will be interspersed with outings to places near here, including a trip to Bear Lake, the summer home of Albert Lewis, the lumber king.

Delegates will be selected to represent Pennsylvania at the convention of the National League of Republican clubs in Cincinnati next week. Politicians here today declare Pennsylvania will roll up its usual big republican majority for Taft and Sherman.

DEATH REFERRED TO "HOME AND MOTHER"

Oakland, Sept. 16.—In an effort to save the health of his suffering wife F. B. Jages, a telegraph operator arranged this morning to send her back to the home of her mother in Nebraska. Within a few minutes after the despondent woman, who was but 19 years of age, committed suicide by drinking carbolic acid. "GOD HAVE MERCY ON JOE CANNON"

Union Labor Takes Hand in Minnesota Campaign and Shows Great Power.

CONGRESSMAN BEDE FEARS DEFEAT OF THE SPEAKER.

Minnesota Follower of "Uncle Joe" Defeated in Primary Contests—Labor Vote Overwhelmingly Shows Under Former Wit of House—Gompers Led Attack on Minnesota Man, Charging Neglect of Constituents and Favor to Trusts.

Duluth, Minn., Sept. 16.—"May God have mercy on Joe Cannon's soul," declared Congressman Adam Bede today when he learned that owing to the fight waged on him on account of his support of "Uncle Joe" he had been overwhelmingly snowed under by his opponent in the eighth district primaries yesterday.

Bede's only other comment was, "They got me. I must now go way back to my country paper." He appears to be worried by the fear that the speaker will be defeated by Gompers and his labor supporters.

Adam Bede, known as the "wit of the house," was no less well known as a close friend and warm supporter of "Uncle Joe" in his arbitrary rule of the house. For this reason Samuel Gompers in person led the fight against the Minnesota man with the result that Clarence B. Miller, his opponent, won the nomination in a walk. It was charged against Bede that he had endorsed Cannon's policy, favored the paper trusts and other monopolies and neglected his district and its interests.

LOCOMOTIVE ENGINEERS CONVEY IN SAVANNAH

Savannah, Ga., Sept. 16.—One of the largest gatherings of union labor ever held in the southeast marked the opening here today of the session of the Brotherhood of Locomotive Engineers and the Ladies Auxiliary of that organization.

Every state east of the Mississippi, and several states west of that river, are represented by delegates. In addition to business sessions, excursions will be run for the benefit of visitors to Tybee Island and other points of interest in the vicinity of Savannah.

Officials of the union state that it is in a prosperous condition and that there is every evidence that a season of renewed prosperity for all railroad employees is now beginning.

GRASPS LIVE WIRE TO PREVENT ITS SPARKING.

Alameda, Cal., Sept. 16.—Grasping a telephone wire which had crossed the high power lead wire of the municipal lighting plant in order to prevent the danger he fancied might come from the sparks it was emitting, Sir Edward Packenham, British lord, was electrocuted last night. Sir Edward grasped the wire and pulled it to the ground with him, when the current knocked him over. He died immediately.

PREFERS DEATH TO ARREST BY POLICE.

Redding, Cal., Sept. 16.—Rather than submit to arrest on a charge of disorderly conduct, Charles Johnson chose death. The man escaped the officers, made his way to the river bank and plunged into the Sacramento river. Hampered as he was by his clothing, Johnson managed to swim 200 yards before he was overcome and drowned. The man was a blacksmith aged 30 years.

LITIGATION SETTLED IN MINING CASES.

Fairbanks, Alaska, Sept. 16.—Negotiations terminated today whereby long litigation over claims 1, 3 and 4 on the first tier of benches at the right limit of Dome creek was ended. Miller, DeJournal, Detering, Johnson West, Ben Crawford and other owners sold to Barnett, Cook, Ridenour, McGinn, Sullivan. The consideration was unannounced, but is known to be over \$115,000 paid in cash. Mining men estimate that the property will produce over \$2,000,000.

Charge Embezzlement.

Chicago, Sept. 16.—Thos. Kearns, reputed millionaire mining man from Rawhide, Nev., was today arrested by detectives upon a charge of embezzling \$8500 belonging to Kearns No. 2 Gold Mine company. Kearns was at the Palmer House when arrested and immediately gave bonds for his appearance to answer the charge brought by the stockholders in his property. He claims that the money was voted to him at a meeting of the directors of the concern recently.

Vote is Unanimous for Present Lieutenant-Governor to Oppose Hughes.

JUDGE PARKER PLAYS ROOSEVELT ADMINISTRATION

Declares Roosevelt Has Added 99,000 Federal Office Holders to Public Payroll—Charges Republican Party and Protective Tariff With Responsibility for Growth of Trusts—Slurs for Anti-Trust Crusade.

Rochester, N. Y., Sept. 16.—Lewis Stuyvesant Chandler, present lieutenant governor of the state of New York, was unanimously nominated to lead the democratic forces against Governor Hughes in a convention this morning that was remarkable for its harmony.

Subordinating all personal animosities and heeding the earnest plea of the national chairman for harmony in the interests of success for the presidential ticket at the polls in November, the warring factions of the New York state democracy agreed to pull together and all chance of friction in the state convention has been swept away.

Parker Arraigns Roosevelt.

Rochester, N. Y., Sept. 16.—Sneers and slurs for Roosevelt were conspicuous this morning in the speech of Judge Alton B. Parker, who was so decisively defeated by the president four years ago, in his address to the democrats of New York.

Judge Parker directly charged the president with burdening the country with an additional 99,000 federal office holders at an annual cost, he declared, to the public of \$70,000,000. The judge hinted that this formed the backbone of Roosevelt's power and influence in the nomination of Judge Taft.

That the republican party had made possible and had built up the trusts was a second charge of Judge Parker and he declared that these same concerns were furnishing the welcome funds for the Taft campaign.

Chiefest of Judge Taft's slurs at the administration was his sneering statement that "it may have been purely coincidence but it was certainly odd that the president's crusade against predatory wealth burst upon the people only at a time when their attention had been focused upon the corrupt relations between the republican party and the moneyed interests."

It is not too much to say that the highest duty of the hour is to make the continuance of those relations impossible.

RIOT THREATENED WALLAWA OPENING

La Grande, Sept. 16.—There was an element of violence in front of the United States land office yesterday morning when the doors were opened for filing on a section of land in Wallawa county, for which a score or more of people for days waited patiently on the sidewalks to make filings. During the day over 40 filings were made.

The first intimation of violence took place when a group of people from Wallawa county formed an opposition line. There is an ordinance, the wording of which is immaterial, but the purpose of which is to keep loafers off the streets after 2 o'clock a. m., which was enforced when policemen broke up the second line, the members of it having not procured a permit from the mayor to remain in line over night.

Unquestionably there were men among the new crowd that are bona fide squatters, and contest cases will be the order of the day from now on. It is alleged by those in the regular line that the bona fide squatter stood back and waited until the line had filed, knowing he would be recognized when he filed, as he has 90 days preference right.

The lands filed on were considered very valuable for farming purposes.

MANIACS ARE PURSUED BY AROUSED PEASANTS

Lisbon, Sept. 16.—Portugal's 14,000 maniacs, or at least those living in the rural districts, are being hunted like so many wild and dangerous animals, by an ignorant and aroused peasantry. The pursuit of the unfortunates is absolutely fanatical, and although the soldiery has been issued orders to stop the slaughter, the situation is still desperate. In spite of the vast number of maniacal unfortunates in this country the government has no alystums and no way of procuring proper care. The result of this neglect is the present alarming situation.

STATE FAIR HAS A RECORD BREAKING DAY.

Salem, Sept. 16.—"Salem day" made a record for attendance at the state fair today, over 22,000 people passing through the gates. Tomorrow 30,000 people are expected to celebrate "Portland day." The highest previous attendance was 16,000 on "Portland day" last year. The fair continues to maintain its excellent standard. Racing is very good today, the track being quite fast.

ADRIFT FOUR DAYS BUT RESCUED AT LAST.

Bellingham, Sept. 16.—Famished and half dead from exposure, after drifting helplessly four days and three nights in a water logged launch among the turbulent tides of the Gulf of Georgia, James Staples was picked up today by Captain J. Cookson of the tugboat Nellie. The man had not tasted food since Saturday and was in pitiful condition. Staples left for Bellingham Saturday morning and had not gone a mile before the engine broke and he was carried to sea, since when he has drifted.

Balloon Wrecked.

Berlin, Sept. 16.—Emperor William will get to inspect the remnants of the great dirigible balloon "Parseval," but nothing more. While en route to Potsdam for inspection the big air engine was wrecked by the breaking of a rod which ripped a hole in the gas bag. The balloon quickly collapsed and landed on the roof of a villa in Grunwald forest.

BARD TO LEAVE WALLA WALLA

EPISCOPAL RECTOR WILL STUDY IN GERMANY.

After Visiting Father in Faderland and Attending Heidelberg University, Popular Minister Will Return to America to Work in New York or San Francisco—Plans to Produce Poetic Drama.

Walla Walla, Sept. 16.—Rev. Andreas Bard, for 16 years rector of St. Paul's Episcopal church in this city, filed his resignation with the vestry last night, the date of its taking effect being October 1, if possible, and not later than October 15.

Reasons given in the resignation are that he has been in Walla Walla 19 years, that he has built the church and school here, and that his work is completed, and that he desires to go to a larger field.

Rev. Andreas Bard, with his wife and daughter, will first go to Germany and will stop for a while at Schwerin, Germany, where Mr. Bard's father, the Rt. Rev. Paul Bard, bishop of Northern Germany, is now stationed. Later he will attend Heidelberg university to take a course of lectures, and in the spring Rev. Bard will return to America, locating either in New York city or San Francisco, in both of which cities he has been offered churches. When he is settled his family will join him.

While in Germany Rev. Mr. Bard will confer with dramatists regarding the staging of his play, "Glafar," a production in blank verse which was published last year. To make a stage production more characters will be introduced and the play made longer.

Miner Falls Down Shaft.

Ely, Nev., Sept. 16.—The Groux Consolidated mine, in which three men were entombed for 42 days last winter, was the scene of a frightful accident last night when Tom Nichols, a miner, fell out of the bucket, falling several hundred feet to the bottom of the shaft. Nichols was instantly killed, the body being mangled horribly.

PREFER BALD HEADS TO MERRY WIDOWS

Seattle, Sept. 16.—"He dead—she glad" hats have no standing with Rev. J. P. D. Lloyd, pastor of the fashionable St. Mark's Episcopal church of this city. DAIRY ORDINANCE WAS "CHURNED"

Committee Conference Held Last Night Was Long and Thorough.

MAIN FEATURES STILL STAND AS THEY WERE.

Objections Were Raised to Ordinance by Town Milk Sellers and Alterations Were Made Last Night—Requirement for Tuberculosis Test Stands and Likewise Sanitary Regulation of Dairies—Ordinance Up for Passage Tonight.

At a meeting of the council ordinance committee last night the dairy ordinance introduced at the instance of City Physician Cole was thoroughly "churned" and a few changes proposed by interested parties present, were made. None of them, however, effect the merits of the ordinance, and it will doubtless be passed by the council tonight.

The meeting last night was held in the office of City Attorney Raley and it proved almost as large a conference as that held when the interurban franchise people were here. Mayor Murphy, Councilmen Knight, Strain, Mumm and Stroble and City Attorney Raley were present in behalf of the city, while the dairy interests were represented by Messrs. Harper, Morgan and Powers. Another interested attendant was John Halley, Jr.

The most serious objection raised against the ordinance as originally drafted by Messrs. Cole and McClure was that by its provisions it practically barred local householders from selling milk to their neighbors. The measure provided that no dairyman, or any party selling milk, should store milk within 200 feet of any place where manure is piled and it required that before delivery milk be cooled to a temperature of not higher than 50 degrees Fahrenheit.

Last night the ordinance was changed so that it now permits the delivery of new milk without any cooling process and the provision regarding manure piles applies only where milk is retained for four hours or longer. If milk is not delivered within three hours' time it must be cooled. The restrictions as to the grade of milk and cream to be sold were not changed.

Will Fight Tuberculosis.

The provision requiring dairy cows to be tested for tuberculosis by far the most important section of the ordinance, remains as it was excepting that the council reserves the right to approve the parties whom the city physician shall select to make the tests. It is the intention of Dr. Cole to ask Dr. McClure and his deputies to make the tests and they have already received permission from Washington to serve, free of cost to the city.

The penalty for a violation of the ordinance was changed slightly. It formerly imposed a fine of not less than \$25 nor more than \$100. It now specifies that the fine shall merely not exceed \$100, thus allowing the recorder to impose a fine of less than \$25 should he see fit to do so.

The conference last night lasted until 11 o'clock.

OAKLAND TO HAVE FIRST MARATHON RACE.

Oakland, Sept. 16.—Oakland is to have the first Marathon race ever run in the west. The course will be about 22 miles and the contestants will be started from Fruitvale and will take the mountain trail through Joaquin Miller's home. The race will be held on Thanksgiving day under the auspices of the Century Athletic club, which made the announcement today.
