PIONEER WOMAN TAKEN BY DEATH

MRS. J. E. BEAN SUCCEUMBS TO ILLNESS OF YEARS.

Had Resided in Umatilla County for Over 40 Years and in Pendleton for the Last 30 Years—Was Very Prominent in Club and Church Work in This City—Funeral Services Tuesday at Church of the Redeemer.

Mrs. Sophia Helen Bean, wife of J. E. Bean, died at the family residence, 607 Willow street, at 8 o'clock Sunday evening. Death was the result of a complication of diseases with which the deceased had been suffering since the first of June.

Mrs. Bean was born at Cascades, Wash., August 18, 1853, and was therefore 55 years old at the time of her death. Her maiden name was Bishop and she accompanied her parents to the town of Umatilla in 1866, since which time she has been a resident of Umatilla county.

In 1871 she was married to J. E. Bean and in 1878 they moved to Pendleton, where they have since resided. During her 30 years residence in this city Mrs. Bean has been prominent in church and club work and is one of the best known pioneer women of the county.

The deceased is survived by her husband and two daughters, Mrs. B. B. Guernsey of North Yakima, who

has been here several days, and Mrs. H. E. Cramer of Pendleton.

She is also survived by a sister and brother, Mrs. Thorpe Roberts of Prosser, Wash., who has been at her bedside for the past month, and E. R. Bishop of Kerman, Cal.

Funeral services will be conducted at the Church of the Redeemer tomorrow morning at 10 o'clock by the Rev. Charles E. Quinney, and the interment will be in Olney cemetery immediately following.

PILOT ROCK EXCURSION.

Special Train Will Bring Crowds From Southern End of County to Fair.

Final arrangements have been made for the excursion train from Pilot Rock on Friday, October 2, which is to be known as Pilot Rock and Educational day. The train, which is to consist of six coaches and a buffet, will leave Pilot Rock at 9 o'clock in the morning and returning will leave Pendleton at about 11 o'clock at night or after the fair has closed for the day.

GUS LA FONTAINE TO OPEN "THE QUAILS"

"The Quails" is to be the name of a well eating house, soon to be opened up in this city.

For several days Gus La Fontaine has had the old Senate saloon building in the hands of carpenters and soon after they and the decorators have finished with it, one of the swiftest little places outside of Portland will be thrown open to the public.

La Fontaine is the pioneer restaurant man of this city and his popularity is not confined to Pendleton alone, for he is known throughout the northwest. He says "The Quails" is to be a restaurant and oyster house, modeled after "The Quails" in Portland, and that oysters, fish, crawfish, and everything in that line the market affords will be served on the tables of the new house. Everything about the place is to be strictly modern and first class. In addition to the cozy dining room, capable of seating a large number, there will be a row of boxes along one side.

Arguing an Appeal.

A packed house greeted "The Royal Chef" Saturday night at the formal opening of the new Oregon theater, under the management of C. J. Mitchell, and the play was well enjoyed. The opening of the theater was enjoyed by all for it was the first time in many months that a good road attraction has been here and in addition to this fact the theater itself never shown before as it did Saturday night.

By installing a new non-advertising curtain, new draperies and by thoroughly cleaning the old playhouse, the management made as big a hit as did the show itself. The improvements in the theater were appreciated by those who gathered within the playhouse Saturday night and favorable comments were heard on every hand. The entrance to the lower floor is now through the double door near the boxoffice and carpet now covers the former bare floor in the hallway and on the steps. According to Manager Mitchell, still further improvements will be made in the theater and one of them will be the installation of more lights upon the stage.

PENDLETON WILL GROW IF PUSHED

HINKLE SEES GREAT CHANCE FOR DEVELOPMENT

Prominent Attorney Compares Surrounding Country With That of Spokane—Only Transportation Facilities Needed to Increase Population—Diversified Farming Possible in Rainfall Section Would Make Pendleton City of 20,000.

"Pendleton has not reached its limit," declared Attorney J. T. Hinkle, who has just returned from an extended visit to Grangeville, Idaho and Spokane, Washington. "This can easily be made a city of 20,000 inhabitants within 10 years," he added and then he proceeded to give his reasons for thinking that Pendleton was only just beginning to come into her own.

During his stay in Spokane Hinkle had occasion to go over the acreage tracts being sold about Spokane and along the various electric car lines. He says the land is far inferior to that around Pendleton and that five and 10-acre tracts are being sold by the hundred at from \$250 to \$1000 per acre.

He says this land is without any water rights and that it will not produce any more than will the hill land east of Pendleton and not nearly so much as the river bottom land.

"The extension of the car lines has developed the country adjacent to Spokane and the same could be done for Pendleton," said Mr. Hinkle.

"The most important thing for this city at the present time is electric railways. There should be extended into the country east, north and south of Pendleton, where diversified farming can be carried on without irrigation as well as into the Echo and Hermiston country, where irrigation prevails.

"With these electric lines a city of 20,000 within ten years would be no longer a dream. It would be an actuality.

"Much of the wheat land surrounding Pendleton is too valuable for wheat and when electric lines are built out into the country these large farms can no longer be held together. In the fact of the high values that will prevail and five-acre tracts will be found capable of sustaining a family in easy circumstances.

Suit to Collect \$930.34.

Suit to collect the sum of \$930.34 has been brought in the circuit court by the First National bank and the defendants named are Conrad Platzoeder and A. Kunkel. It is alleged that a note for the above amount was given to Mr. Kunkel by Platzoeder and the former disposed of the same to the bank with a guaranty that the same would be paid. Carter & Smythe are attorneys for the bank.

DAIRY INDUSTRY IS DEVELOPING

EFFORTS OF CREAMERY FINALLY BRING SUCCESS.

Olivers Import Herd of Blooded Milk Cows for River Ranch While Other Farmers in Vicinity of Pendleton Are to Follow Example Set—Price of Cattle Goes Skyward and Local Establishment Grows.

At last the efforts of the Pendleton creamery to develop the dairying industry in the vicinity of Pendleton are about to be crowned with success. Dairying has always been carried on in a small way but from this time on it bids fair to become a well developed industry.

Attorney Roland N. Oliver shipped in the first herd of real dairy cows Saturday evening. These have been placed on the Oliver ranch just west of town and it is understood that other ranchers, both above and below town on the river, as well as on Birch, McKay and Wild Horse creeks, are going to follow suit.

The cattle shipped in Saturday were purchased in the Milton and Free-water country and are full blood Durham and grade Jerseys. The price of dairy cows is now high and still going up so that within a few weeks it is believed that it will be impossible to buy good dairy cows at what has al-

ways been considered reasonable prices.

The milk from the Oliver and other dairies is being sold to the Pendleton creamery which as a result is developing into a large milk depot as well as butter manufacturing establishment. All the milk sold in the city is pasteurized upon its arrival at the creamery and then sealed in air-tight bottles before being delivered to the customers.

The development of this industry will mean a great deal for Pendleton and vicinity in more ways than one.

STOLYPIN TAKES HAND IN CHOLERA CRUSADE.

St. Petersburg, Sept. 21.—Premier Stolypin, alarmed at the cholera situation, today assumed personal charge of the crusade against the dread disease. His first act was the removal of incompetent authorities, and the creation of new sanitary districts. Ordinary patients have been turned out of the hospitals to make room for cholera victims.

The conditions are awful. There are 4000 cases in the city of St. Petersburg alone. Deaths occur in the streets hourly. Thousands are leaving the city.

The municipality today voted to expend \$250,000 in new hospitals.

FOREST FIRE THREATENS FIVE WISCONSIN TOWNS.

Milwaukee, Sept. 21.—Two engines with three thousand feet of hose and one company of firemen, were sent to Rhineland today in response to an urgent appeal for help in fighting the forest fires menacing that town. One engine has been fighting the fire for hours. The towns of Curtis, Moon and Ladysmith are also threatened.
