WILL PLACER GOLD COIN MINE

PENDLETON MAN PLANS
NEW OPERATIVE MODE.

Mining Property in Which Local People Are Interested Will Be Handled in New Way—History Is Record of Sensational Trouble—Mill Was Burned Following Long Litigation Over Water—Can Be Placed.

Baker City, Oct. 2.—The Gold Coin mine is to be operated again. That is the statement given out by T. W. Ayers of Pendleton, who is heavily interested in the property. Mr. Ayers was in Baker last evening attending to details regarding work that is being done.

The Gold Coin is one of those mining properties which has been inflated up to the present time. Located and developed as a quartz mine, a mill was erected and in a six-days run \$1200 was taken from the plates. Then came the trouble. A rancher by the name of Brown had some farm land a distance below the mill and he claimed that the muddy water and tailings injured his premises. He accordingly enjoined the Gold Coin people and tied them up. The case went to the circuit court and Brown was beaten, but the supreme court reversed the lower court's finding and Brown was on top.

Then the mine owners conceived the idea of building sluice dams, which they did and began operation again. Shortly after this the mill burned, greatly to the surprise of the owners. Naturally the Gold Coin people turned first one way and then the other, scarcely knowing how to start or what to do. The ledge carrying the values is a decomposed granite formation and a final investigation proved that it could be washed down and placed instead of milling it. This was tried and proved satisfactory. Water has been secured for the operation. A 12-mile ditch is about one-third completed and contracts have been let for the remainder of the work.

A PIONEER VISITOR.

Second Sheriff of Umatilla County Is Attending the Fair.

O. F. Thompson, the well known pioneer Butter creek rancher, is among the enthusiastic visitors at the district fair. Having been elected sheriff of Umatilla county in 1867 when the town of Umatilla was the county seat and the principal asset of the county was sage brush and blue grass, he naturally takes great delight in wandering through the pavilion and has the wonders which have been wrought impressed vividly upon his mind. During his second term as sheriff and while Judge Bailey, father of Attorney D. B. Bailey, was county judge the county seat was moved from Umatilla to Pendleton. To Sheriff Thompson fell the honor and responsibility of moving the county records.

Fair Speakers Arrive.

All the speakers who took part in the afternoon program for this, as educational day, arrived this morning on the early train. Governor Chamberlain and Colonel E. Rate Hearing Is On.

San Francisco, Oct. 2.—If their demurrer is overruled by the United States court the court may examine into the railroad's contention that the low rate fixed by the commission is confiscatory, which will result in a final hearing. Teal's argument today was a caustic arraignment of what he termed the illegal methods of the Southern Pacific. He attacked the allegations in the railroad's bill that the company was being deprived of its property without due process of law. No attempt will be made by the railroad to get the commission to change the rates.

Death Ends Litigation.

Vancouver, B. C., Oct. 2.—Mrs. John Dunsmuir, mother of Lieutenant Governor James Dunsmuir, died this morning, aged 63 years, according to a special dispatch received from Victoria. Mrs. Dunsmuir had just started another suit for her share in the \$30,000,000 estate of the family which is represented by coal mines, railways and valuable timber on Vancouver island now held in James Dunsmuir's name, who claimed that she had forfeited all rights for \$400,000 cash.

Coast Gets Golf Tourney.

Portland, Oct. 2.—November 14 has been selected as the date for the greatest gathering of golf experts ever seen on the Pacific coast, being the first annual northwest tournament on Waverly links for a \$500 challenge trophy. Each visiting club is represented by eight players. The out of town clubs represented are Tacoma, Seattle, Spokane and Vancouver, B. C.

Say He Set Fires.

Portland, Oct. 2.—Louis R. Webb, a hunter and trapper, who is interested in mines in southern Oregon, is held in the county jail in Portland accused of setting fire to a big tract of government timber in northern California. He says the arrest is purely spite work. Webb is held on \$5000 bail. He will fight the attempt to take him to San Francisco to stand trial.

Annapolis Bi-Centenary.

Annapolis, Md., Oct. 2.—Old Annapolis will celebrate its 200th birthday next month and arrangements have already been made for a three-day period of festivities to commemorate the bi-centenary. The exercises will begin Sunday, November 22, and continue through the two following days.

Bankers Will Elect.

Denver, Oct. 2.—It is practically certain that George M. Reynolds of Chicago, and Lewis E. Pierson will be elected president and vice president, respectively, of the American Bankers' association. The chief interest of today's session centered in the address of Alexander Gilbert, president of the New York clearing house.
