# NAGEL MAKES **ANNUAL REPORT**

Labor Would Widen Scope of Bureau of Corporations.

RECOMMENDS BROADER LAWS FOR CURBING WHITE SLAVERY

Suggests That Corporation Bureau be Developed in an Agency With Country-wide Scope-Federal Authori-Successful White Slave Traffic-Nearly Million Allens Enter Country During Year.

Washington, Dec. 13 .- The report of commerce and labor, made public today recommends development of the bureau of corporations into an agency to perform for the whole country what it has been doing in specific instances. Secretary Nagel's recommendations suggest an agency to of all interstate corporations must be reported. The need of properly safeguarding business secrets is recognized and would be provided for. The secretary declares the comparison that the commercial and financial life of the nation has become nationalized and suggests that it is now in order to nationalize its corporate life.

Another important recommendation made by Secretary Nabel is for broader laws to stamp out the white slave traffic. While the present statutes prohibit the importation of women for immoral purposes," there is no law against transporting them from one state to another. The secretary says it- must be realized that the white slave trade is an organized business. and that tighter laws are needed to enable federal authorities to fight it

successfully. Secretary Nagel recommends the further development of the bureau of corporations. At the end of the fiscal year the department still has on hand investigations of the lumber and steel industries; the International



Torn Throat of Dead Man and Bloody Muzzle of Dog Tells Story of Tragedy.

SHUT IN A ROOM ' MAN FIGHTS FOR LIFE


New York Man Meets Horrible Death from Teeth of Vicious Bulldog-Animal Belonged to His Sister and Had Intense Hatred of Man-Body Found in Pool of Blood and Room Indicated Terrible Struggle.

New York, Dec. 13 .- The horrible story of a battle to death between a man and a huge buildog in which the man was killed and left lying in a pool of his own blood, was told today at the coroner's inquest into the death of Carl Limpert. The dog that figured in the unique tragedy was the property of Limbert's sister and had developed an intense hatred for Limpert and had on several occasions attacked him savagely,

Despite Limpert's advice, his sister refused to part with her pet, and early yesterday when Limpert entered her flat he found the dog in sole possession. Flercely the brute flung himself upon the man and for nearly half an hour they fought and rolled about on the floor in a deadly struggle. Limpert seemed unable to gain the door. Later in the day his dead body was found lying on the floor, beside an overturned table. His throat was torn into shreds and his shoulders lay in a fast drying pool of blood. . The dog, his muzzle stained a darkening red and his head and body bleeding from gashes received when he was huried against the furniture by his human antagonist, lay cowering in a corner.

In all during the fiscal year 944 .-235 allens entered the country and 67 lieved that 23 per cent of them were assisted to reach this country.

In one portion of his report Secretary Nagel takes up the "white slave" traffic.

The department's investigations show that the traffic in immoral women is an established and extensive business, by no means confined to trading in imported women. It includes alien women who have entered the country in a regular way and American women as well. The present federal law merely prohibits the bringing of women into the country for immoral purposes.

In addition to these there are two big damage suits to be tried. The first on the docket is that of Joseph Bowlin against the O. R. & N. company. He is suing for \$15,000 damages as the result of injuries received at Gibbon while working as a brakeman for the company. The other is that of John Bergevin against J. R. Sponogle in which a father is suing for \$15,000 damages for the alleged degregation of his daughter. A date has not been set for either of these.

#### Second Morse Trial.

Still another important case is the second trial on the charge of horse stealing against Clarence Morse Harry Morse, John Pambrun and Roy Ellsworth. It will be remembered that these four men were tried last fall for the larceny of four horses and that the jury was unable to agree upon any kind of a verdict with respect to either of the four defendants.

#### Morrow County Case.

Not the least interesting case on the docket is that of the State of Oregon versus L. G. Earnhart. This case was transferred from Morrow county, Earhart being the ex-convict who shot up the town of Ione, last spring, caused a reign of terror for several hours and was directly responsible for the serious wounding of an innocent bystander.

Several civil cases are also on the docket and there are a few men in the county jail awaiting the action of the grand jury. Some of these are sure to be indicted and tried at this term of court,
