TRAIN CRASHES INTO AN AUTO

Two Women Killed and Two Seriously Injured in North Yakima Accident.

DRIVER ONLY ONE TO ESCAPE UNINJURED

Northern Pacific Passenger Train Runs Into Big Automobile Carrying Four Women Besides Driver—Two Killed Outright and One of Others May Die—Chauffeur Thrown Quite a Distance But Unhurt—Now Under Arrest.

Injured May Recover.

North Yakima, June 14.—The inquest over the bodies of Miss Hope Davis of this city, and Miss Lena Buckmaster of Naches City, killed yesterday afternoon when a locomotive struck an auto, will be held this afternoon. Mrs. Clarence Brown may recover. Mrs. William Kincaid, wife of county road supervisor will recover.

North Yakima, Wash., June 14.—Two women were killed outright here yesterday afternoon and two others seriously injured, one probably fatally, in a horrible collision between eastbound Northern Pacific passenger train No. 4 and an automobile carrying five people. Four of the passengers were well known women of North Yakima, the fifth was L. I. Strangeway, driver of the car. Strangeway escaped without a scratch although thrown father from the car than the other occupants. He is under arrest, awaiting the coroner's inquest. The engine driver was not arrested.

The dead: Miss Hope Davis, North Yakima. Miss Lena Buckmaster, Naches City, Wash.

The injured: Mrs. Clarence Brown, wife of a well known stockbuyer of North Yakima, left foot cut off, right foot crushed, skull badly fractured and internally injured. Probably fatally. Mrs. Jennie Kincaid, wife of William Kincaid, county road supervisor of North Yakima, arm and leg broken, scalp cut. Will recover.

The accident occurred at the intersection of the railroad track and "D" street. On the side from which the train approached the track is concealed from the street by several long strings of freight cars.

Strangeway, it is stated, drove his automobile onto the track so close in front of the train, that although he reversed his machine, there was not time to back clear of the track.

The locomotive struck the automobile near the front, slinging it almost clear around, and grinding the car under the drivers. Miss Davis, Miss Muckmaster and Mrs. Kincaid occupied the rear seat of the machine. Strangeway was placed under arrest and will be held until after the coroner's inquest which will probably take place tomorrow. Engineer E. S. Jones of the passenger train, after making a statement in which he disavows responsibility for the collision was allowed to go on with his train. His home is in Seattle.

Japs Ordered to Leave.

Warrington, Wash., June 13.—A mob of 100 white men today ordered all the Japanese laborers employed in the plant of the United States Lumber company to leave town, and after giving the foreigners time to get together their effects accompanied them to the station and saw them board a Seattle-bound train. The exodus of the Japanese was made with little disorder. Thirty Japanese were employed in the mills here.

MORE INDIAN LAND PASSES INTO WHITE MAN'S HANDS

Another 120 acres of Indian reservation land has passed from Indian to white ownership and will go toward increasing the tax roll of the county. John Crow secured 80 acres of it at \$76 per acre, while L. L. Mann purchased 40 acres at \$55 per acre. This was also heirship land, the two pieces purchased by Crow having been allotted to Ta-min-mi and Agnes Craig, sisters. The land adjoins the Crow farm on the west.

SAYS PEOPLE DO NOT WANT CONSERVATION

St. Paul, Minn., June 14.—Denying the people at large wish conservation as proclaimed by Pinchot, Louis Hill, president of the Great Northern, asserted today that Pinchot had not converted him to the conservation idea. "Pinchot announced he had converted me, I deny it," said Hill. "Pinchot has been meeting clubs and organizations formed for the express purpose of promoting conservation. I have been meeting the people and they do not want conservation."

MIKE RYAN MUST GO TO PENITENTIARY

SUPREME COURT DENIES PETITION FOR REHEARING

Convicted of Killing Edward Dixon Year and Half Ago, Must Serve Seven Years in Prison and Pay Fine of \$2,000.

Mike Ryan must serve his sentence in the penitentiary and pay his fine. The state supreme court today denied the petition for a rehearing and the convicted man will now be taken to Salem.

Ryan was found guilty of manslaughter in the circuit court for Umatilla county for the killing of Edward Dixon near the Ryan farm in the north end of the county more than 18 months ago. He was sentenced to serve a term of seven years in the penitentiary and pay a fine of \$2,000. His attorneys appealed the case and he was admitted to bail in the sum of \$10,000 pending the result of the appeal.

On May 24, the supreme court affirmed the decision of the lower court. The attorneys for the convicted man then availed themselves of the ten days allowed for filing a petition for a rehearing. This was filed last week and the petition was denied at noon today.

Ryan must now surrender himself to the sheriff.

REPORT THAT INSURGENTS HAVE LOST ANOTHER HOLD

Olon, June 14.—Today's Advice state that Cape Gracias, the only port the insurgents held besides Bluefields, has been captured by the Madriz troops. The port is on the Honduras border, and it is asserted Honduras troops assisted in the capture. Madriz sent a protest to President Taft against the attitude of the American navy in which he intimated it was not in harmony with the international neutrality law.

May Withdraw Suit.

Carson, Nev., June 13.—Mrs. Gladys Emery Aoki, daughter of Archbishop Emery of the Episcopal church in California, who married Guniro Aoki, a Japanese servant working at her home, is quoted in an interview today that she would withdraw her suit for divorce. Mrs. Aoki, whose marriage to the Japanese caused a sensation about a year ago, came to Nevada recently and instituted preliminary proceedings for divorce. The couple were married in Seattle and there was a child born to them. Aoki has been here for about a week and during that time has been a constant visitor with his wife and child.

O. A. C. Jubilee.

Oregon Agricultural College, Corvallis, Ore.—The big jubilee at O. A. C. is under way. Sunday 5000 people sat in the mammoth armory and listened to Rev. Dr. E. W. Champet, rector of Trinity church, deliver the baccalaureate sermon and again preach at the evening service. Dr. Champet's sermon was scholarly and his theme emphasizing uselessness of college education unless backed by character was masterful and impressive. He said the greatest weakness of American youth is in its lack of reverence and America's greatest need is intellect backed by character.

Seattle Boys Arrested.

Phoenix, Ariz., June 13.—Will and Sam Humphreys, brothers, whose home is said to be in Seattle were arrested today in connection with the holdup of a Phoenix street railway car last night. Both boys, formerly west in the employ of the railway and the conductor, who was relieved of \$20, said he recognized them by colloquialisms which they had used frequently in addressing their fellow men. The boys declare they can prove an alibi.

Will Investigate Affair.

Seattle, June 4.—Klugiro Hasashi, Japanese vice consul refused to discuss the driving of thirty Japanese laborers from Darrington by whites. He said, however, he would investigate and file a protest with his government.

SLAYER SLAIN IN CALIFORNIA

Jealous Man Kills Former Wife and is Killed by Alleged Consort.

SHOOTS WOMAN IN STREET AND SEEKS TO KILL MAN

Antone Williams, Scion of Wealthy Family, Meets Death After Committing One Murder and Attempting Another—Was Divorced Few Months After Marriage But Still Kept Company With Woman—Made Repeated Threats to Kill Her.

Concord, Calif., June 14.—Antone Williams, son of a wealthy Martinez rancher, shot and killed his divorced wife Laura, and shot and seriously wounded Philip Roach, whom he accused of intimacy with his former wife, and was then shot and killed by Roach here today. Roach was arrested and sent to the Martinez jail. Williams had been married only a few months when he was divorced. They have been separated for two years. Afterward they went together and he threatened to kill her several times. Williams met her on the street with her sister, and shot her through the breast without a word, and then went to a jewelry store which Roach owns and shot him in the left arm. Then Roach fired with fatal accuracy.

MANY HIGH PERSONAGES WILL GREET ROOSEVELT

Washington, June 14.—The capital will be deserted Saturday when Roosevelt returns to America. Many leading officials are preparing to go to the New York welcome. Among them are Secretary of the Navy, Meyer, Secretary of Agriculture, Wilson, Captain Butt, who has been appointed by president Taft to officially welcome Roosevelt. Controller of Currency Murray, Commissioner of Immigration O'Keefe and Labor Commissioner Neill will also be there. The president will not be there. He will speak at Villa Nova, Pennsylvania.

SENATE HEARS REPORT ON RAILROAD BILL

Washington, June 14.—Senator Ekins presented to the senate today the conference report on the administration railroad bill. The report contains the house provisions on the long and short haul clause, and the senate provision empowering the interstate commerce commission to suspend rates for ten months pending an investigation of the proposed schedules.

ROUGHRIDERS EN ROUTE TO WELCOME FORMER CHIEF

St. Louis, June 14.—Three hundred rough riders are assembled here today from the south and southwestern parts of the country. They will go in a special car to New York to welcome Roosevelt, their old commander. They will form a part of his escort in the parade.

GREEK CHURCH MEMBERS WILL COLONIZE TRACT

El Paso, June 14.—Archbishop Villatte, of the Greek church in America, is here to close a deal for the purchase of fifty thousand acres near Chandelaria, Mexico, where a colony of his church members will be formed. Hundreds of colonists are preparing to settle the land.

GOHL ENTERS PIER TO SERVE LIFE TERM

Walla Walla, Wash., June 14.—William Gohl, a former sailor agent, convicted of the murder of Charles Halberg at Aberdeen, arrived at the penitentiary today to begin a life sentence. He seemed cheerful.

BIG TRUST MAY MOVE TO CHINA

Noted Englishman Says Rates of Exchange With Orient May Thus Result.

COAL, LABOR AND IRON ARE CHEAP IN CHINA

Moreton Frewen, Authority on Money Questions, States He is in Position to Know That American Steel Trust May Close Up Shop and Move to Land of the Chinks—Blames Current Rates of Exchange.

Vancouver, B. C., June 14.—That the American steel "trust" will shut up its rolling mills in this country and manufacture its products in China where coal and labor and iron are cheap, should the rates of exchange with the orient continue its present low level, is the inference drawn from the statement made by Moreton Frewen, the great English authority on money questions who is visiting here in a written article he said: "I am in a position to state that the steel companies will make this move as I have talked it over with Corey and Judge Gary of the United States steel trust. If it should become evident that the prevalent rates of silver are going to remain anything like the rates of today it will be the first duty to shareholders of this great corporation to manufacture both steel and pig iron in China."

AERONAUT HAS BATTLE WITH THE WINDS

New York, June 14.—Frank Owens, an aeronaut, had a wild ride today when he attempted to pilot a dirigible over this city in a gale. He lost control and the dirigible was dashed against various buildings. A hundred thousand persons watched his fight or life, until he landed finally in a tangle of electric wires in Brooklyn. He started from Belleville, N. J., passed over Jersey City, then descended and struck the top of sky scrapers near the city hall. The machine's engines broke and it became a plaything of the winds and bumped through the city and crossed to Brooklyn, narrowly missing the Brooklyn bridge.

MOST OF STRIKEBREAKERS JOIN WITH THE STRIKERS

Portland, June 14.—Six of the thirty-six strikebreakers from San Francisco went to work on transfer wagons today. The remaining joined the ranks of the teamsters who are fighting for a wage increase. Mayor Simon says he will enforce order if he has to double the police force, and will give every man a chance to work with protection. He frowns on the importation of strikebreakers, however, as it is feared their presence will cause trouble.

HAMILTON SAYS HE WILL MAKE REAL FLIGHT

New York, June 14.—Disparaging his bi-plane flight from New York to Philadelphia and almost return, Hamilton announced today he expects to make a real flight. He intimated he would undertake a record-smashing aerial journey. Hamilton plans to enter the contest from New York to St. Louis which carries \$25,000 in prizes. Today he will fly over New York.

Beef Hits High Mark.

New York, N. Y., June 14.—The price of beef is higher today than in a generation. The wholesale price of dressed beef has advanced from 12 and 12 1/2 to 13 cents, and the retail price increased proportionately.

FREEWATER VOTES FOR "DRY" TOWN

ELECTION GIVES MAJORITY OF 31 FOR REFORM

Billiard Halls, Pool Rooms and Card Rooms Will Now Be Closed—Election One of Most Bitterly Contested in History of Town.

Freewater, Ore., June 14.—After one of the most bitterly contested campaigns in the history of this little city, the "dry" forces yesterday won what is considered a sweeping victory by deciding that the common council may, by ordinance, close all near-beer saloons, billiard halls, pool rooms and card rooms. There was a total of 114 votes cast—just twice as many as was ever known here and the "dry" won by just 31.

Judges of the election were Edward Bortoff, William Johnson and G. W. Crabtree. Clerks who officiated were John Crimmins and L. W. Mitchell.

LIEUTENANT IS IN THE DUNGEON

Nogales, Ariz., June 13.—Lieutenant Juan Hermosillo, who was in charge of the guard when Louis Fleischer, an American banker and land owner made his sensational escape from the Mexican prison, across the border, Thursday, was thrown into a dungeon tonight, to begin punishment for having allowed the American to get away. Fleischer is on his way to San Francisco and his family will follow immediately.

Fleischer was president of the American Clothing company, doing business across the border in Nogales, Mexico. He was imprisoned on the charge of smuggling. After his escape he was arrested on this side at the request of the American authorities, who at once instituted extradition proceedings. Judge Doan of the district court at Tombstone, gave the American his freedom.

JACK DOWN TO WEIGHT WILL ACQUIRE SPEED

San Francisco, June 14.—From now on Jack Johnson will train for speed only. The champion announced today he is down to weight, 212 pounds, and is satisfied with his condition. Boxing is to be the major part of his daily routine.

Gilliam Farmers Organize.

Condon, Ore.—The Gilliam county farmers' union was organized here Saturday. Delegates were present from Olex, Arlington, Mayville and Condon locals. The meeting was open to the public in the forenoon. In the afternoon the farmers went into executive session and elected a full corps of officers. C. S. Worley was elected county president and P. H. Stephenson secretary. State President F. A. Sikes of Milton, presided, and reported the progress of the work over the state. Time set for the next county meeting was July 1, at Condon.

Great Flood in Germany.

Berlin, June 14.—Military authorities have issued orders to proceed to the Ahr valley to rescue scores of persons marooned on islands by the flood. Alarming but unconfirmed reports that 200 were drowned were current. The largest number of fatalities is reported from Suhl where 50 were drowned. All communication is prostrated.

MAY HAVE BEEN DOUBLE MURDER

American Ambassador at Milan Believes Charlton Was Murdered Also.

SAYS ROBBERY WAS MOTIVE OF TRAGEDY

Ambassadors Caughy and Leishman at Scene of Italian Murder—Former Declares Husband of Dead Woman is at Bottom of Lake—Country Folk Tell strange Tales of Midnight Dances—Murder Like That of Miss Reid.

Como, June 14.—The police are no nearer a solution of the murder of Mrs. Charlton. They spent the night sifting Ispoloff who did not become confused. A prominent Milan detective, working on the case, declared Mrs. Charlton was insane due to physical malformation. He said when the crime is solved it would be proved it was the product of a diseased mind. The American consul, Caughy of Milan who is here today said Charlton has been murdered too. The coat found yesterday was not Charlton's.

American Ambassador Leishman is here also investigating. Caughy said, "It is a plain case of robbery and murder. The money valuables of the Charltons have disappeared. The report that Charlton sent a message to various persons following the discovery of his wife's body is untrue and Charlton's body is doubtless in the lake." The country folk tell tales of midnight dances in which Mrs. Charlton was partly dressed, and danced with her husband on the lawn accompanying the dance with weird songs.

Is it Work of Black Hand?

Milan, June 14.—The unusual interest in the Charlton murder being taken by Ambassador Leishman and the disappearance of her husband, led to the report today that the United States is seeking to ascertain whether a society formed for the purpose of blackmailing American women in Italy exists. Milan and Rome police recently held a conference regarding the murder of Miss Estella Reid whose murdered body was found in Rome. She had wealthy relatives, and it was believed blackmailing was attempted in the hope that relatives would buy off the tormentors. The murder of Mrs. Charlton and Miss Reid are similar.

Sheep Shearing in Wallowa.

Wallowa, Ore.—Forty-two cars of sheep were shipped from this county Friday by Oxman of Durkee. He will also drive about 4500 over the mountains, making a total of 15,000 sheep for which he will pay Wallowa county growers more than \$105,000.
