SELL AT \$6 WHICH RAISES TOP NOTCH

One Lot Goes at the High Mark at North Portland; Few Cattle Come and Situation Is Very Firm.

Portland Union Stockyards, North Portland, Or., July 13 .- Lambs sold up to \$6 today and thereby broke all previous records for this time of the vear.

There was only a small showing of supplies today-a handful of cattle, a small run of hogs and a very mod-

erate supply of sheep and lambs. Trade conditions all through the livestock market are showing not only a continuation of the previous good character but in most lines there is a strengthening of values.

Hogs are holding extremely firm with a number of sales of good stock at \$10.25, the recent high mark. So few cattle came forward today

IS GRAVEYARD OF SHIPS.

Many Have Perished on Coast of Vancouver Island. Victoria, B. C.-Ten days spent ca-

being over the graveyard of many ships was the unique holiday spent by Captain C. V. J. Miller and wife of this city, who have just returned from the west coast of Vancouver island. They went to Glo-oose and from there by canoe up and down the

island coast, visiting the scene of any wrecks.

From the cove now known to the 'oast Indians at Valenci cave, Capain Miller brought many relics of the un Valencia, the Pacific coast timewhich drove ashore with the result that 140 lives were lost. Pieces of crass, panelling, doors, etc., were reovered by Captain Miller. He saw

the remains of a number of other. erocks: The Iron huil of the old Janet Cow-

n, bent and broken, lies below the cater, not far from Pachent and the roken engines of the Valencia, now oppled over and heaped in debris ver the boiler, can still be seen at ow water on the reef where the liner let her fate. He says the wreck of the Skagit

and anchors and chains of the Vesta and Uncle Sam, small sailing vessels, which had stood on the shore for ome years. The hulls have now brok-It up and only the anchors and chains remain to mark where they ended heir careers.

The holler of the old Michigan, hich was wrecked close to where the Valencia met disaster, nearly a score d years ago, was seen and also scant willes of other wreeks.

"It is not only a graveyard of ships his section of the Vancouver Island coast," said Captain Miller, "but It also is a graveyard for human beings. There are scattered along the shore between Darling creek and the mouth of the Kalewah river some 20 more graves, nearly all shallow mounds, where the bodies of victims of wrecks, most of them from the Valencia, still lie interred."


