(2) Whenever the Council shall deem it expedient or necessary to improve any street or streets or any part or parts thereof, within The City of Pendleton, it shall require from the City Surveyor plans and specifications for an appropriate improvement and estimates of the work to be done and the probable cost thereof, together with a statement of the lots, parts of lots and parcels of land to be benefited by such proposed improvement, and the percentage of the total cost of improvement
