Section 4. The term "Improve" and "Improvement," as used in this Act in reference to screets, shall be construed to include all grading or egrading, paying or repaying, macadimizing or remacadamizing, graveling or regraveling, and all manner of oridge-work and roadway improvement or repair and all manner of onstructing sidewarks crosswarks, ewers, gutters and curbs within any of the streets in The City of Pendleon, or any part of any such street, and such improvements may be made in the following manner:

(1) The Council, whenever it may seem it expedient, is hereby authorzed and empowered to order the whole or any past of the streets of the city to be improved, to determine he character, kind and extent of such Improvement, to levy and collect an essessment upon all lots and parcels of land specially benefited by such improvement, to defray the whole or any portion of the cost and expense thereof, and to determine what lands are specially benefited by such improvement and the amount to which each parcel or tract of land is benefited

(2) Whenever the Council shall deem it expedient or necessary to improve any street or streets or any part or parts thereof, within The City of Pendleton, it shall require from the City Surveyor plans and specifications for an appropriate inprovement and estimates of the work to be done and the probable cost hereof, together with a statement of the lots, parts of lots and parcels of land to be benefited by such proposed improvement, and the percentage of the total cost of improvement which each of such lots, parts of lots
