

ROUND-UP GETS GOOD PUBLICITY

Pendleton is beginning to "spruce up" for the Round-up and the big eastern Oregon celebration promises to be more of a success this year than ever before, says the Oregon Journal.

The railroads have already taken hold of the advertising feature of the celebration and the advertising department of the Oregon-Washington Railroad & Navigation company is busy getting out special folders and posters for use throughout the country.

"Let 'er buck," has been adopted as the slogan of the Round-up and the big posters being prepared by the railroad show a typical cow pony on the point of "blowing up." The folders will show pictures of the Round-up of last year and will contain the program for the three days of the big event—September 14-15-16. Saturday, September 16, is to be Portland day and it is probable two special trains will be operated over the O-W. R. & N. railway to take Portland people to the show.

Special trains will be run daily from Spokane and excursions are scheduled from Walla Walla, Yakima and other points.

"The Round-up will be a national affair this year," said General Passenger Agent William McMurray, today. "I know personally of people who are coming from San Francisco and from Chicago and other eastern points. Pendleton and Cheyenne are the last two places where the easterner can get a glimpse of the old west and of the real western spirit and people are going to attend from far and near."

"There can be no possibility of failure. William Hanley of Harney county told me the other day every boy on his ranch will be at the Round-up to take part in the proceedings, and that means that every other puncher in eastern Oregon will attend."

FAILS OVER LOADED GUN; DIES

Woman Trips Over Rifle and is Fatally Shot.

La Crosse, Wis.—Mrs. Charles J. McClellan, aged 35, wife of the chairman of the town of Bergen, was shot and accidentally killed at her home near Stoddard today. She fell over a gun which her husband had loaded for crows and it discharged, killing her instantly. Returning home from the inquest over Mrs. McClellan's body, the coroner found the dead body of a stranger lying in the road. The cause of the second death is being investigated.

OVER SEA IN THREE HOURS

Invention of Gyroscope-Monoplane Has Great Visions.

Pittsburg, Pa.—"New York to London via the air in three hours." Ralph E. Bissell insists it will be possible with his gyroscope-monoplane device, provided, of course, that the human frame that guides the instrument through space over the seas can endure such frightful speed. Bissell is a thick skinned fellow and accepts incredulity and gibes like a good fellow.

In a huge shed on his back yard on the North Side, Bissell has his great machine. Powerful engines will be installed this week. He insists that the newest bird of the air will travel as fast as human lungs and eyesight can withstand the pace.

He declares that the secret of his success and the speed which he says will be possible lies in the way he combines the two forces of the gyroscope and the monoplane.

"A thousand miles an hour" is his modest claim. Continuing he says: "Get a pair of lungs and eyes that will stand it and I'll furnish the machine."

WHEAT TO BREAD, 30 MINUTES.

Grain, Cut, Threshed, Ground and Baked in Half an Hour.

Beloit, Kan.—Pileuts ready to eat made from wheat that was standing in the field just 30 minutes before, is the record made by W. S. Gable, a farmer living here.

The header was driven into the wheat field at 3:15 o'clock. One minute later the wheat in the straw was at the separator. A quantity was threshed, loaded into the farmer's automobile, and at 3:23 was at the mill. Six minutes saw the wheat come out as flour and a minute later the automobile was distributing flour at a downtown bakery. Fourteen minutes later at 3:44 o'clock, the biscuits were removed from the oven, baked and ready to be eaten.

WILLS \$3,500 TO HIS PARROT.

Oklahoma City, Ok.—Thomas Billingsby, a capitalist, has had a will drawn and witnessed in which \$3,500 is left for the support and maintenance of his pet parrot, which he has owned many years. The parrot is now 23 years old. It must outlive its master to be a beneficiary.

Three men are named in the will as trustees of the fund to be expended in the care of the pet. They are to take turns keeping the parrot, and should it outlive them, are to appoint other trustees to carry on the trust. The fund may not be expended for any other purpose during the life of the bird.

Billingsby was a sailor years ago, and came into possession of the parrot in the South Sea Islands. He carried it with him inland, and, through the years he has owned the bird, has become much attached to it.

The will provides liberally for the members of the capitalist's family.

MANIAC WHO KILLED FATHER BREAKS JAIL.

Woman Prisoner Is Charged With Aiding in Escape of Wealthy Pennsylvania Man.

Uniontown, Pa.—J. B. Frank Smith, who killed his father, Porter Smith, and his brother-in-law, Evan Mason, at Smithfield eighteen months ago and was recently acquitted on grounds of insanity, escaped from the county jail today. He was accompanied by two young negro boys.

Late today Alexander McBeth, county detective, applied for a warrant against Stanley Smith, brother of the fugitive, and Elizabeth Husher, who was released from the jail last Saturday. Both are charged with aiding Smith to escape. They have not been arrested.

It is alleged that the Husher woman, while a prisoner in the jail, passed several spoons to Smith. From these Smith wrought out a key with which he unlocked the door of his cell. Stanley Smith is charged with having taken his brother from Uniontown in an automobile.

The Smith family is prominent and wealthy. Smith killed his father when he learned his parent was about to marry. After, his brother-in-law, favored the marriage and also was killed by Smith. Following a sensational trial, in which Smith attempted to brain the district attorney, he was acquitted on the grounds of insanity.

HE GOT THE JACKPOT.

Poker Player Induced Police Officers to Let Him Cash a Bluff.

Lynn, Mass.—After being surprised by the police, six poker players halted the raid and requested the officers to make themselves at home until a pot was decided. The winner then called a "taxi" by phone and all went to the station. The police were searching for liquor at 377 Essex street, when they were attracted by the repeated cries of "I'll raise you."

Their entrance was not noticed by the players until an officer exclaimed, "We place you under arrest."

"All right, have a cigar," was the reply. "Sit down and amuse yourselves. You see, I have got to lose \$5 anyway, and there's a chance of winning \$50 in the pot."

The spokesman called and laid down three kings against the bluff of three other players. He collected \$22.50 and winked at the raiders.

BLOW AT FEET CRACKS HEAD.

Somersaults Man Who Knocks Out Own Underpinning.

Allentown, Pa.—Harry W. Bowersox, aged 28, a carpenter employed by George H. Hardner, in making concrete forms, found a crosspiece slightly too long for the uprights.

Disregarding his foreman, he took a sledge to hammer it into position while standing on it.

Bowersox hit too hard and knocked the heavy timber from under himself, falling on his head sixteen feet down, the shock fracturing his skull.

The timber fell on top of him and broke his arms in addition. There is little hope for his recovery.

VOLIVA, INDICTED, GIVES BOND

Overseer of Zion City and Others Held for Election Frauds.

Chicago—Overseer William Glen Voliva of Zion City and about one hundred others of the 190 indicted by the special grand jury in the recent Zion City election fraud charges, appeared in the Circuit court at Waukegan yesterday morning and furnished bonds which ranged from \$500 to \$4000. Attorney George Field made a motion to quash all the indictments and arguments will be made later. Several Zion City people went on Voliva's bond. State's Attorney Dady of Lake county insisted that each bondsman swear as to the amount of property he owned.

SPOKANE BOY FALLS 50 FEET ONTO ROCKS; DEAD

Spokane, Wash.—Plunging headlong over a 50 foot precipice to the rocks in the river here this morning, Frances Kennedy, aged 14, sustained injuries from which he died a few minutes later in the Emergency hospital. The boy was terribly mutilated, striking the jagged rocks on his head and face. He was playing with a younger brother on the river bank.

OPPOSE LIMITATION OF WASHINGTON SALOONS

Washington, D. C.—The District of Columbia commissioners have gone on record against the bill introduced by Senator Works, of California, to limit the number of saloons in the District to one hundred, and to confine them to business streets. The commission recently forwarded to congress an adverse report on the bill. The members think that the passage of the bill would create a monopoly that might prove prejudicial to the proper enforcement of the excise laws and that it would greatly increase the profits of the saloonists who were favored and materially diminish the revenues of the District of Columbia.

Gives to Famine Sufferers.

Vienna—Charles R. Crane of Chicago, appointed minister to China by President Taft and recalled when en route to his post, has given \$100,000 to relieve famine conditions among the Albanians.

Eleven Are Stabbed.

Muskogee, Okla.—Eleven men were stabbed in a fight over a girl at a country dance near here.

WHEAT AT ATHENA READY FOR HARVEST

Athens, Ore., July 7.—Farmers in this vicinity are beginning to cut the hay around their grain, thus making ready for the combines to enter the fields. It is freely asserted by the farmers here that this is a banner year for wheat.

There are a great number of farms that will yield fifty to sixty bushels of wheat to the acre. A great deal of wheat hay is weighing four tons to the acre.

Harvest this year promises to be a speedy one as there is a great sentiment among the wheat growers in favor of not only prompt harvest but prompt sales of the crop, provided the prices are at all reasonable.

Few farmers here still have their last year's crop and their experience is going to be a strong argument in favor of selling on the first market.

UNABLE TO READ OWN FATE.

"Palms," "Psychics" and "Mediums" Afoul of Banishment Order.

Atlantic City—So busy were they in forecasting the future and removing "spells" for gullible visitors during the past few weeks that the "palms," "psychics," "gypsies" and "mediums" who had leased desirable quarters along the boardwalk, were unable to forecast today's action of Chief of Police Woodruff, who issued an edict that all must close up shop at once and leave the city. Police men carrying these instructions invaded the "parlors" of these dealers in the future late this afternoon, and left in their wake a trail of desolation and woe.

"Why didn't you let me know before I had leased this place for the season?" moaned Mme. Vera, before whose quarters is displayed a sign informing the public that to her the future is an open book.

"You should have known without being told," responded the unfeeling policeman. "You have been fooling the public long enough. Now take a dose of your own medicine."

The action of Chief Woodruff was taken because of an unusually large number of applications that have been received in the past few days from this class of money-getters, who invade the resort at the beginning of each season and depart late in the fall heavily laden with their spoils.

IS UMBRELLA A WEAPON.

Question is Put Up to District Attorney at Baker.

Baker, Ore.—Whether or not an umbrella is a dangerous weapon within the law is the question that has been put before District Attorney Levens to answer by Justice of the Peace Motley. Two men by the name of Anderson beat Jake Cannady with an umbrella and were sentenced to 10 days in jail for assault and battery. The victim swore to a complaint charging assault with a dangerous weapon. The justice wants to know if the charge can be made to stand. The district attorney has replied that the law does not consider an umbrella a weapon as far as the decisions of the courts show.

ABYSSINIA TRADE REVIEWED.

American Consul Reports Closing Contracts for Cotton Goods.

Washington.—American trade in Abyssinia is being revived, according to dispatches received at the State Department from Consul Guy R. Love, at Adis Ababa. The consul reports the closing of contracts for the sale of cotton sheetings to the value of \$750,000 by the representatives of an American firm. The goods will be sent in shipments extending over a period of three years.

Another American firm recently opened agencies at Dire Dawa, Harar, and Adis Ababa, Consul Love reports. The company will buy Abyssinian skins and hides, and sell American cotton sheetings.

The United States once possessed a large share of the Abyssinian trade. In recent years, however, it has been declining in favor of European exporters, who have sought the business with more energy than American exporters.

BOLT KILLS SIXTEEN STEERS.

Not a Mark Left on One of Herd Under Big Tree.

York, Pa.—A single bolt of lightning in a heavy electrical storm in southern York county, killed sixteen head of steers on the farm of H. Clay Whiteford, near Delta.

The animals had huddled under a tree for shelter and were found lying dead as though each had been struck with a hammer, there being no mark of injury upon their bodies.

In the same storm lightning struck a tree near the stable at Prospect, in which Joseph Pyle kept his horse. After the storm the horse was found dead.
