

DR. WILEY WORRIES ADMINISTRATION

POSSIBLE POLITICAL EFFECT NOW BEING CONSIDERED

Investigating Committee Learns Many Things That Trust Dominated Officials Had Heretofore Kept Under Cover—Republicans Scared.

Washington, D. C., Aug. 21.—Friends of the administration are giving unmistakable signs of worry over the possible political effect of the Wilson-Wiley-McCabe feud. Before the Moss investigating committee took it up it was apparent that the public was overwhelmingly in favor of the doughty doctor as against the wily solicitor and with the evidence anything like even between them Dr. Wiley would be sustained by public opinion. Little testimony had been taken before the majority of the committee was convinced of three facts: first, that Dr. Wiley was guilty of any infraction of law in connection with the appointment of Dr. Rusby as pharmacognosist, there were plenty of precedents for his action, created by Secretary Wilson and Solicitor McCabe; second, that if Dr. Wiley had erred he had done so on the side of the people and not on the side of the food-dopers; and third that if he lost his position there would be a howl from the American people that

could be heard around the world. Incidentally, the testimony showed that for some years Dr. Wiley had been completely shorn of power in connection with the administration of the pure food act. The committee was therefore ready to report exonerating Dr. Wiley a few days after it began its investigation, but it was on the track of too much interesting material.

"Doc" Wiley is a Hoosier, and "back home" they think a heap of him. He set Indiana right on pure food before he left there thirty years ago to work for the government. Indiana glories in what is probably the best food law in the country. Certain manufacturers, seeking to force on the Hoosiers foods their health authorities have condemned, have tried to upset the laws and have it declared unconstitutional. To assist them the department of agriculture loaned these manufacturers such witnesses as they desired, including the members of the famous Remsen board, the department paying the expenses. The state of Indiana had to furnish its own witnesses and was put to all the expense and trouble possible by the department of agriculture. These facts are percolating through the minds of the Indiana taxpayers and voters and they are getting "all hot up," and the longer the rumpus continues the hotter they are getting.

At least that is about the substance of a letter addressed to the president by an Indiana republican of considerable prominence, who believes the Wiley-Wilson-McCabe row is calculated to result disastrously on his party unless speedily and satisfactorily settled.

er, in which a man named Sullivan was killed, eight mountaineers organized themselves into a band of white-caps, went on horseback to the home of Dan Whittenberg, who it is alleged, had given lodging to the revenue officers. The outlaws entered his house at 2 o'clock, took Whittenberg away from his wife and children, and carrying him out in his own yard whipped him almost to death. Only a day or so before this Slato Morris of the same vicinity, who had given lodging to the officers, was shot from ambush while plowing in the field. Part of a load of buckshot entered his body, one striking him in the face.

Before arriving at the home of Whittenberg the night riders visited his father, Pete Whittenberg, and threatened him. While they were beating him, Whittenberg recognized the entire band, some of them by their voices, others by their horses. When he had sufficiently recovered from his terrible experience, Whittenberg swore out warrants against feight suspects. When the case was called for trial a few days ago Whittenberg failed to appear and it was alleged that he had been threatened by the night riders, so the cases were dismissed, but the criminal court, which meets in October, will investigate the matter thoroughly.

ARMY CAPTAIN FOUND DEAD.

Frank T. Thornton was under arrest in quarters. Seattle.—Captain Frank T. Thornton, commanding the Sixty-third company, United States Coast artillery, was found dead in his quarters at Ford Worden. Death had apparently been due to an overdose of bromidol. On a partly empty bottle of the drug, which officers say Thornton had used to check an attack of insomnia.

Captain Thornton was under arrest in his quarters at the time of his death for some alleged infraction of military discipline. When he failed to appear for breakfast his quarters were searched and the body was found.

Captain Thornton, who was only recently promoted to a captaincy, was transferred here from the Presidio, San Francisco, six months ago. He was born in Indiana 33 years ago and saw service in the Philippines.

Tacoma.—After floating for nearly two hours in the waters of the Sound Paul Brookes and George Botts, of Tacoma were rescued from drowning when the launch Radium, owned by Brookes, was destroyed by fire off Flaming Bay. The Radium was off Duwamish bay, coming from Deep Moton, when she suddenly burst into flames off near the engine. The fire evidently originated from the back fire of the engine. The burning launch attracted the attention of a man named Hoy and one of his daughters, who came to their assistance in a row boat after Brookes and Botts had with life preservers been nearly two hours in the cold waters. The Radium was valued at \$1400 and was insured for about \$500.
