NORTHWEST NOTES

Fruit Land Brings Good Price.
Freewater, Ore.—Walter Shaw of Pleasant View has sold 15 acres of fruit land for \$4500.

Pomeroy Women on Jury.
Pomeroy, Wash.—Miss Mary Stember and Miss Mayme Montis are the first women in the county to be drawn on the jury.

Convicted of Selling Booze.
Pomeroy, Wash.—Messrs. Helper and Bru, proprietors of the Pomeroy hotel, were convicted of bootlegging and were fined \$50 and costs. Their supply of liquor will be destroyed.

Blast Kills Levi George.
Fornie, B. C.—Levi George, about 36 years old, who was working on the new government wagon road near Corbin, was killed by a premature discharge of a blast.

Captures Smuggled Opium.
Bellingham, Wash.—Immigration Officer Farris, of Custer, 20 miles northwest of this city, captured 35 pounds of smuggled opium, valued at \$1500, along with John Marcus of Portland, Ore., who admitted bringing the drug across the boundary.

Mule Kicks St. John Farmer.
St. John, Wash.—Ray Fitzgerald, a prominent rancher living five miles north of town, was kicked in the head by a mule. His scalp and flesh under his eye and eyelid were torn from the bone and several stitches were taken.

Hand Torn by Threshing Machine.
Reardan, Wash.—While Fred Creed, who was employed with Andrew Gray's threshing outfit, was walking on the separator, he slipped, catching his right hand in the clutch and tearing it badly. The injured man was brought to town. It will be some time before he can use his hand.

Youth Attempts Suicide.
Walla Walla.—With a bullet hole in his breast, Elmer Gwinn, a prominent young man of this city, lies at the point of death, the victim of an attempt to commit suicide. Physicians hold out little hope for his recovery. The cause of his action cannot be learned. The shooting occurred at the Gwinn residence on Main street.

Hospital at Walla Walla.
Walla Walla.—Plans for the erection here of a large modern hospital by the Sisters of Providence to supersede the present St. Mary's hospital will be completed upon the arrival here of Mother Provincial Jean of Vancouver, B. C., who is expected tomorrow. For several days Mother Julian has been in the city developing the plan.

Hen Hovers Mess of Cats.
Rogold, Wash.—D. M. Holt has a hen that has developed a peculiar maternal instinct. Recently, upon the arrival of half a dozen kittens, morn in the manger where she was sitting, she promptly left her eggs and took possession of the kittens, hovering and clucking to them as though they were chickens. At meal time Mr. Holt has to come to the assistance of the mother cat and drive the hen away.

Sue Deputy and Game Warden.
North Yakima, Wash.—Alleging that they had been subjected to ridicule, injured in credit and feelings, and compelled to spend two days away from their business, Joseph Kohle and Ernest Fear have each brought suit for \$250 and costs against James Wright, deputy sheriff and game warden, who arrested them at Lake Keechelus on August 8 for an alleged violation of the state game laws. Kohle and Fear were acquitted on trial.

O. A. C. Boy in British Columbia.
Oregon Agricultural College, Corvallis, Ore.—C. C. Clark, Portland, a graduate of the Oregon Agricultural College in 1907, is superintendent of the large holdings of the British Columbia Land and Water company at Kamloops, B. C., 350 acres of which is planted to fruit. Mr. Clark is a planted to fruit. After taking graduate work at the college, Mr. Clark became horticulturist for the Department of Agriculture, British Columbia, a position which he resigned to go to Kamloops.

Death Rate Decreases.
North Yakima, Wash.—As a direct result of the sanitation campaign carried on in this city this year, the death rate for the first eight and a half months has fallen from 18.64 per thousand to 15.26, says a report of the County and City Health Officer, Dr. Thomas Tetreau. The most noticeable decrease has been in the death rate from cholera infantum, which has decreased 60 per cent, in typhoid fever, which has been reduced to a minimum.

STANDS ON HER HEAD.

Joy Party Has High Jinks; Costs Her Husband \$200.

Kansas City, Mo., Sept. 16.—H. W. Wickliff, a wealthy Oklahoma merchant, gave a little drinking and dancing party on a Chicago, Rock Island and Pacific railroad train coming into Kansas City late at night. It cost him \$200 in the South City Court in Kansas City, Kan., next morning.

Wickliff pleaded guilty to charges of drinking on a train and disturbing the peace. Fifteen persons, who were passengers in the same car Wickliff and two women companions occupied, remained over in Kansas City to appear against him.

Thomas May, a Rock Island policeman, had Wickliff arrested.

"The man and the two women, one of whom he said was his wife, were cutting up on the train." May said. "Then Wickliff produced a revolver and fired a shot through a window of the car. The other passengers began to feel uncomfortable. Then the man picked up one of the women and stood her on her head on the floor of the car. She was in scant lingerie. Everyone became offended except the woman, who simply laughed when turned right way up again."

Wickliff made no denial. All he did was hurry the proceedings so he could pay his fine and get away. He told officers that the woman who stood on her head in the car was his wife.

WEDS HEIRESS, BUT MUST SERVE OUT ARMY TERM.

General Wood Refuses to Accept Resignation of Lieutenant Rumbough.

Washington, Sept. 16.—When General Wood, chief of staff, refused to accept the resignation of Second Lieutenant Stanley M. Rumbough, Fifteenth cavalry, he cruelly interfered with Cupid's arrangements by which the officer is to become the husband of Miss Colgate, a New York heiress.

More than this General Wood has indicated a disposition to prevent the use of the army as a matrimonial bureau. He insists that after officers have been educated at West Point they owe the government at least four years' service and that even then they will not be released merely to capture an heiress.

It is understood pressure from influential quarters has been brought to bear on the war department to bring about the acceptance of the resignation of Lieutenant Rumbough. Some of the officers at the department had approved it, but when it reached General Wood it was turned down in a most emphatic manner.

The lieutenant was given a leave of three months, with permission to apply for an extension. This, General Wood thinks, is sufficient for a honeymoon, and after that time the officer must return to Fort Myer where he is stationed, and get into service.

Lieutenant Rumbough is a splendid horseman and an efficient officer. The fact that he will have a large income through his matrimonial alliance, in the opinion of General Wood, does not relieve him of his duty to the army.
