#### SUSPECT CANNED HORSE.

Health Authorities Investigating Report from New Jersey.

Trenton, N. J.—Inspectors reporting that the government was watching operations in producing "canned horse" for food consumption, Dr. Wiley, chief of the chemistry bureau of the United States department of agriculture, who began an investigation, turned the matter over to the New Jersey health authorities, because so long as the suspect did not continue to export the horse flesh the government has no jurisdiction.

The state board of health instructed the attorney general to proceed against a firm at Kearney, N. J., for violations of the state food and drug law and the slaughter house license act.

The state board says it has evidence that the most insanitary conditions prevailed at the establishment and that the carcasses of diseased and emaciated horses were packed for the Holland trade.

#### WIFE MUSN'T BE SPANKED.

#### Though Woman Deserves Punishment, Law Forbids Husband Doing It.

Los Angeles.—A man is not justified in spanking his wife, even if she deserves it, according to a decision on file in Justice Young's court. In rendering the decision Justice Young fined E. W. Payne \$5.

Payne had pleaded guilty to the charge of having spanked his wife, but pleaded justification.

"No matter how much she deserved to be spanked, the law doesn't permit of your taking a hand in the matter," said the justice.

Then he ordered Payne to pay the fine.

#### CARRIES WOMAN, ILL, FIFTY MILES ON HORSE

#### Motor Car Breaks Down and Immigration Official Rides on Toward Distant Hospital.

Denver.—On the last leg of a journey on which he is rushing his sister-in-law, Mrs. George G. Schenck, to Cheyenne for an operation by which it is hoped to save her life, and fifty miles of which was made on horseback with the woman in his arms, Ray W. Schenck, Immigration Commissioner of Wyoming, left here a few nights ago.

Mrs. Schenck became ill on the Schenck ranch, near Sun Dance, Wyo., fifty miles from a railroad. It was decided to take her to a Cheyenne hospital, and the journey was commenced in an automobile, which broke down soon after leaving the ranch.

Mr. Schenck completed the trip to the railroad on horseback.

#### THAW TO STAY IN ASYLUM.

#### Will Not be Released, Says Head of Mattewan.

Newburgh, N. Y.—Persistent reports that Harry Thaw's release from the Mattewan asylum is expected within

the next three months are denied by Dr. James V. May, superintendent of the institution.

"I can state most positively that Thaw will not be released before January 1, nor for some time after," said Dr. May.

The superintendent would give no opinion on the sanity of Thaw. He said that Thaw's attorneys have forbidden their client to submit to any examination by asylum or outside persons, and it is almost impossible to determine the exact condition of his mind. "But I do say that as far as I know there is no great change in Thaw's mental condition," he said.

A scene depicting a bad boy who was sorry for a wrong act preyed on the mind of young Austin, who, as soon as the show was over bought a ticket for Belleville. He told his parents the reason for his return and was ready to take his medicine. Later he went out on the street to visit a chum and was picked up by detectives and locked up.

The boy confessed in court to embezzlement and was held for the grand jury's action.
