RECENT RECORD PRICE BROKEN

HEIFERS SELL AT \$5.40 AT NORTH PORTLAND

Another Big Run of Cattle Marks Opening Day of Week—Sheep Receipts Light and Market Unchanged—Wheat Market Reactionary.

(From Monday's Journal.) One lot of extra fancy speyed heifers that came from Metolius sold at \$5.40 in the stockyards this afternoon, breaking all recent records. The shipment was brought in by George Dixon and Jack Hunt. The extraordinary price was due to quality. General cattle situation showed practically no change.

There was another big run of cattle in the North Portland yards, Montana contributing six loads, while there were liberal offerings from Idaho. Totals for the day were 632 head compared with 518 last Monday. Market for cattle is still feeling the effects of the former liberal offerings.

There was a very heavy showing of supplies in the swine trade and therefore the wants of the trade are quite well taken care of. Notwithstanding this, some extra good stuff sold at an advance of 5c over last Saturday's average, \$6.70 being obtained in several instances.

Total offerings in the swine division were 700 head, and all came from the home territory. Determination of Pacific northwest packers to cut out further shipments from the Missouri river section comes at a time when there is the greatest offering of home stuff. A week ago today the run was 113 head.

There was a mixed tone abroad but cables were as a rule lower. Argentina news favored the bear side, if any favoritism was shown and this affected the early trade.
