MOROS PUT UP STUBBORN FIGHT ON STEEP SIDES OF VOLCANO

Captain Taylor Nichols of the Philippine Scouts Among Those Who Are Killed in Battle.

OUTLAW CHIEF IS DEAD

Believed That Leader of Rebellious Moros Met His End in Engagement—Fought Started Wednesday—No Pierce Battle Since American Occupation Says Report.

Washington, June 13.—A thrilling story of a fierce battle at the crater of a volcano with the Moros in which Captain Taylor Nichols of the Philippine scouts and three others were killed is contained in fragmentary reports to the war department from Manila.

The engagement started Wednesday. The captain was killed yesterday.

"No fiercer battle since the American occupation," cabled general Pershing. Retreating under fire of the Americans the Moros took refuge in their forts and trenches in the precipitous sides of the volcano. The Americans drove the tribesmen from their position. The native loss is unknown. It is reported that Amil, the outlaw chief is among the killed.

General Bell cabled that Major Shaw commanded the right wing and Captain Nichols the left. He said the fight was an incident to the disarmament policy of the government against the Moros. The situation left war as the sole alternative.

Amil with a small following was the only Moro who refused to submit. The Moros generally desire disarmament but under the circumstances it was unjust to disarm some and let others retain their arms.

STEAMER ON ROCKS

WIRELESS MESSAGE SAYS PASSENGERS ARE ALL SAFE

Vessel Yukon of the Alaska Coast Company Grounds on Island at Night—No Details Yet Received of Accident—Revenue Cutter Is on Way to the Rescue.

Unalaska, June 13.—A wireless message received at the army station here states the steamer Yukon of the Alaska coast company, enroute to the Bering Sea from Seattle, is ashore on Unimak island. All the passengers are reported safe. The vessel went on the rocks Wednesday night. No details have been received. The revenue cutter Tacoma is en route to the rescue.

WILL GET REWARD.

Portion of Money for Killing Outlaw Tornow Must Be Paid Lathrop Relatives.

Aberdeen, June 13.—Notice was given today that a portion of the reward to be paid Giles Quimby for killing John Tornow, must be paid relatives of Lathrop, who was killed in the last battle with the outlaw. An attorney for the Lathrop heirs said unless this is done he would secure an injunction preventing the county paying Quimby.

MAN KILLED AT THE DALLES FOUND TO HAVE BEEN CECIL PETTIJOHN; IDENTIFICATION IS MADE TODAY

The Dalles, Ore., June 13.—(Special)—The man killed here Tuesday was positively identified today as Cecil Pettijohn of Dayton, Wash., when a half brother of the dead man, Tom Pettijohn, arrived and viewed the body.

According to Tom Pettijohn, the slain man lived for some time in California with his mother but through an estrangement left her and came to Oregon. The half brother said today that so far as he knew Cecil was never subject to attacks of insanity and cannot account for the man's strange escape on Tuesday when he held settlers in this neighborhood in extreme terror. According to the sheriff, Cecil Pettijohn acted as a perfectly sane man up to the time he started on his desperado campaign.

Tom Pettijohn made arrangements today to take the body to Dayton for burial.

RAIN IS BENEFICIAL

MEANS SEVERAL THOUSANDS OF DOLLARS TO FARMERS

.77 Inches of Rain Falls Here and Assures Harvesters of Good Crop—Rain Has Been General Over the Inland Empire—Only Thing to Suffer Has Been Hay.

.77 Inches of Rain. According to the rain gauge at the home of E. F. Averill, local weather observer, the rainfall last night and up until noon today amounted to .77 inches, or slightly over three-fourths of an inch.

To Umatilla county the heavy rainfall last night and today has been extremely beneficial and will mean many thousands of dollars to the farmers of the county. This is the opinion frequently expressed today by farmers, grain buyers and others familiar with conditions. Though the crop was not exactly in need of further moisture at this time the rainfall is beneficial nevertheless and is taken as being a guarantee of a good crop, providing of course hot winds do not come later.

Seemingly the rain has been general all over the inland empire. It rained hard all over Umatilla county and as far north as the Waiilatpu country. If not farther. A heavy rain also fell at Pasco last night.

In this county the rain has been particularly beneficial to farmers in the Pilot Rock country and in the lightland sections in the northwestern part of the county. The wheat in the Adams-Athena district and upon the reservation was not in need of moisture and in some cases damage has been inflicted. However, this is small compared with the benefits that will accrue and furthermore a good crop in the main wheat belt is always assured.

The only complaint against the rain comes from farmers who have hay cut in the field. They may suffer some loss unless bright weather comes soon.

That is the perplexing question which local officials are trying to solve. The dead highwayman was identified over the telephone Tuesday night as Cecil Pettijohn by Miss Bessie McCullough of Echo, from whom the desperado had received several love letters, though the misadvent did not show the name to whom they had been addressed. ROSE SHOW TO BE PERMANENT FEATURE HERE

SENTIMENT UNANIMOUS

Citizens of Pendleton Enthusied Over First Annual Event—Will Raise More Roses—Display Is Pleasant Surprise to Hundreds—Excellent Program.

So thoroughly successful was the rose show held here yesterday that the event is to be made a permanent feature hereafter and there are indications that next year's show will be far superior to the one just held. So far no definite action towards making the event a regular affair has been taken but sentiment among the members of the organization is practically unanimous for such action.

Already the benefits of the exhibit have appeared in the form of resolutions by many people to raise more roses. If the present spirit continues there will be a wholesale business in rose bushes here this fall and next spring. Though Pendleton raises many roses now there will be more and better roses hereafter, judging from the enthusiasm manifested yesterday.

Incidentally, the rose show yesterday was an eye opener for many. Very few people realized so many roses were grown here and such expressions as this were heard on every hand: "I never dreamed Pendleton was raising so many and such beautiful roses."

At the Eagle-Woodman hall last evening the program was carried out as announced save that the speaker from Milton was not in attendance. Dr. I. U. Temple presided and several musical numbers were given, all of which were well appreciated.

During the evening thousands visited the hall and viewed the roses on exhibit. The entire lower floor of the hall and the balcony were literally packed all during the evening despite the fact many of those who came remained but a short time.

It is probable that next year a small admission fee will be charged so as to provide money for financing the festival without the necessity of a subscription list.

STRAWBERRY DAY HELD AT MILTON

Large Crowd Expected at Annual Event—Horse Show Held in Connection—Many Fine Stock Will Be Exhibited—Prizes Will Be Awarded—Addresses on Program.

Milton, Ore., June 13.—(Special)—Today is Milton's annual big celebration, Strawberry Day and Horse Show. Many visitors are expected from Walla Walla and other nearby cities to help make the affair a success. The commercial club of Walla Walla will run the usual excursion.

Cups valued at \$400 will be offered the winners in the different classes of horses shown and the entries indicate that some of the best stock in the valley will be shown.

Instead of giving free as in former years, strawberries this year will be sold for a nominal price. This has been decided upon because of the heavy expense to Milton boosters in getting the show ready. There will be plenty of strawberries and the price will be low enough so that everybody may have all they like to eat.

One of the features of the program of the day will be an address upon the "Dairy Interests" by Dr. James Withycombe of the Oregon Agricultural college. The complete program for the day will be as follows:

AVIATOR KILLED.

Tries "Joy Ride" in the Clouds—Machine Catches Fire and Falls 200 Feet.

Lima, O., June 13.—Andrew Drew pupil of Orville Wright volplaned to death here yesterday afternoon in a blazing biplane.

Drew was killed as a result of a desire to take "just a little joy ride"—his last words to his partner—in a machine which he had not thoroughly tested.

He fell 200 feet, his burning machine falling like a torch hurled from the sky. He was dead when his partner and several men pulled his body from the wreckage.

HUERTA'S RULE IS WEAK AND IS READY TO FALL

ARMY IN POOR SHAPE

First Authentic Account of Conditions in Mexico is Received From an Eye-witness of the Battles—Federal Soldiers Completely Routed by the Rebels.

San Diego, June 13.—Bringing probably the first authentic information of the true situation confronting Huerta and the hopelessness of his administration with an eye witness account of the battle of Santa Rosa, May 9, Royal C. Stephens arrived today. The accounts heretofore have been censured. The outcome was the utter route of the federals, trapped in a pocket of the hills and picked off by Sonora state troops and Yaquis.

Most of the federal soldiers were released prisoners and forced into the army and were ready to desert. They were incensed when they learned they were to fight not only against the Yaquis. The losses were estimated at 1000 to 1200 out of a 2000 force. The Huerta army is in bad shape, commanded by cadets of 16. Guaymas and Palma are the only federal strongholds before the capital. They cannot hold out. The rebels next move will be Mexico City.

MARTIAL LAW ENDS

BELIEVED TO BE ADMISSION MINERS' RIGHTS VIOLATED

Governor Hatfield of West Virginia Issues Proclamation—Senate Committee Investigating Conditions Expected to Report Authorities Failed to Guard Miners.

Charleston, W. Va., June 13.—Martial law which for months existed in the West Virginia coal fields ceased today by proclamation of Governor Hatfield. The senate sub-committee viewed the action as an admission that the constitutional rights of the miners had been violated.

The inquisitors expect to report that the state authorities did not safeguard the rights of the miners, although the charge that miners interfered with mail delivery at the company stores was substantiated.

Major Davis denied charges that he refused to allow the miners to remain at the depot to get goods shipped there. He admitted he fined miners for refusing to obey camp orders. Congressman Davis testified that feeling was so high as to make it impossible for either the miners or the operators to get a fair trial. He said he believed martial law was necessary.

Officials of the United Mine Workers appeared in the federal court to answer indictments charging violation of the Sherman law. They are accused of conspiring against the coal operators of other states and against the operators of West Virginia. Major Lacey, of Iowa, appearing for John P. White, president of the miners.

The first attack in the indictment will be a demurrer to be filed immediately. It will also be a question if the court has jurisdiction, the defendants contending the indictments are the result of an organized conspiracy of West Virginia operators to wreck the miners' organization.

Issue Threatens Union Union officials admit the issue threatens the existence of the labor union. They agreed to carry the case to the supreme court. No definite action has been taken in the case. The real fight will come in the fall. The United States attorney consented to ask the judge to fix bonds for each indicted man at \$1000. An eastern company said it will furnish the bonds before tomorrow.

Senator Borah cross-examined Avis, who admitted the prosecutor did not attempt to secure indictments against the men accused of the crime. He asked the military tribunal to handle the situation. Avis declared his disbelief that the grand jury would have indicted any responsible for murders, riots or destruction of property. He insisted the state did not get justice because of bias.

Avis failed to explain how both sides could get justice from a commission entirely of men favoring the state.

FRUIT GROWERS MUST PAY FREIGHT RATES IN ADVANCE

Seattle, June 13.—Fruit growers throughout the northwest are being notified by transportation companies that no shipments will be forwarded unless freight is paid in advance or guaranteed by responsible persons or a bank. This action is said to be due to the fact that last season large amounts of fruits did not bring enough in the market to pay the expenses of transportation. The roads will take no chances this season.

REPORT TO SENATE RECOMMENDS THAT WOMEN BE GIVEN BALLOT

KING CANCELS PARTY FEARING SUFFRAGISTS

London, June 13.—Fear of suffragette violence caused the king to cancel his arrangements for a garden party planned at Windsor Castle June 21. The invitations were all ready to mail when it was semi-officially admitted they were cancelled by the king's personal order.

PREVENTS A SUICIDE

WISE CLERK GIVES GIRL ONLY HARMLESS MIXTURES

Love Affair Believed Cause of 20 Year Old Dora Bellinski Attempting to End Life—But Hospital Physicians Find She Is Not Dying—Thought Was Poison.

San Francisco, June 13.—Because a drug clerk was "wise," Dora Bellinski, 20, only has a sore stomach instead of a place in a coffin. She was found apparently dying with two vials labeled morphine and strychnine beside her. The girl's father thought her gone. Hospital attaches washed her stomach and learned afterward the clerk gave her harmless mixtures. Her father's frowns on a love affair are declared the cause of the attempted suicide.

MONEY RAISED FOR CITY'S BIG FOURTH

MOB HANGS NEGRO.

Black Accused of Murder of 16 Year Old Girl Meets Violent Death at End of a Rope.

Oklahoma, June 13.—Hanged to a cottonwood tree, his body riddled with bullets, then saturated with kerosene and burned was the fate of Bennie Simmons, a negro, at Anadarko. He was accused of the murder of Susie Church, 16, at Cogar. A mob stormed the jail and carried Simmons to the outskirts where he was strung up.

KILLS FINANCIER.

Slayer Says He Is "Glad He Killed Him"—Quarrel Over Stock Believed Cause.

New Orleans, June 13.—Miche Ziblich, a local oyster king and director of two mining concerns, shot and killed George Margarette, president of two companies. They quarreled over payment of stock. "Margarette was a frenzied financier," said the slayer. "I am glad I killed him."

Favors Amendment to the Constitution Granting Equal Suffrage Throughout the Nation.

COMMITTEE ADOPTS IT

Report Vigorously Urges That Women be Allowed to Vote—Declares That Suffrage is Justified—Committee Not Inclined to Discuss Equality of Sexes.

Washington, June 13.—Senator Ashurst of Arizona, presented the report of the senate suffrage committee today, recommending the passage of Senator Chamberlain's resolution for a constitutional amendment enfranchising the women.

The report vigorously urged votes for women. It declared suffrage was justified by every test the students of government had set down for the enfranchisement of any class of citizens. "We don't feel called on," says the report, "to discuss even if debatable, the question of the equality of the sexes from an intellectual standpoint."

Catron was the only committee-man voting against the report, those favoring it were Thomas, Ashurst, Owen, Hollis, Ransdell, Clapp, Jones and Sutherland.

"The government is strong or weak, capable or deficient, according to the people controlling and making up the government. That the granting of the elective franchise to women would add to the strength and efficiency, the justness and fairness of the country, we don't doubt," concluded the report.

WIDOWS SEEKING PENSION SHOULD CONFORM TO THIS

Judge Maloney Rules That Personal Application Must Be Made As This Course Will Eliminate Attorney's Fees—Will Be Better Able to Judge Applicant Also.

That widow women with children who desire to take advantage of the recently enacted widow's pension law must make application in person to the county judge, and not through lawyers, is the ruling of County Judge J. W. Maloney. This action is taken by the judge with the view to eliminating attorneys' fees in such cases and for the further reason that when personal application is made for pensions the judge has better opportunity to learn of the merits of the case at hand. If at any time there should be a case where it is impossible for the mother of children to make personal application for her pension a special agent will be sent to see her and ascertain the facts about her case.

Under the law adopted by the last legislature a woman whose husband is dead or is an inmate of a state institution or by reason of physical or mental disease is wholly unable to work is entitled to aid under the new law. However, a woman who is a widow through divorce is not entitled to such aid nor may aid be secured if the widow has sufficient property for her support without working or if the child or children has or have incomes sufficient for living purposes. A pension of \$10 per month is given for a child under 16 years of age and when there are several children under that age \$10 a month is paid for the first child and \$7 50 a month for each additional child. The children must live with the mother in order to secure advantage of this act as one of the prime purposes of the law is to keep homes intact.
