Couch of Brownell and A. E. McCormack, all of Cheyenne, Harvey McCrea of Pendleton and Jack Freiz of Mulhall, Okla. Mrs. Wiggs, Casey Jones, Pin Ears, Red Cross, Speedball, Wiggle, Whistling Annie, Bearcat, Butter Creek and Sealion will be their mounts and the old reliable Long Tom, Lightfoot and one or two others of the worst buckers will be reserved for the finals between the last three.

### CHIEF OF POLICE OF PASCO MISSING

PASCO, Wash., Sept. 13.—Chief of Police Tom Caudle, who was arrested last week and charged with assault in the first degree, failed to appear at the time set for his arraignment in the superior court and a bench warrant was issued for him. About two weeks ago Caudle became intoxicated and proceeded to shoot up the Annex bar in wild west fashion, putting a bullet through the cash register, breaking a plate glass window and doing other minor damages. Later in the day he held up J. F. Sullivan, manager of the Pasco Drug company, who was eating in a cafe, and informed Sullivan that he was going to "shoot his can off." But Sullivan succeeded in talking him out of the shooting idea.

The whereabouts of Caudle are unknown at the present time. His bondsmen, C. M. Barr and Charles Godfrey, probably will be called upon to make good the bond of \$500 which was required of Caudle. Sheriff Hays asserts that he has some knowledge of the location of Caudle and thinks he can effect an arrest shortly.

### "BIG TIM" SULLIVAN IS FOUND KILLED

NEW YORK, Sept. 13.—Representative Timothy J. Sullivan, known to thousands as "Big Tim," is dead. His body, badly mangled, was found beside the railroad tracks at Pelham bay. He disappeared from his home August 31, and it is believed he met death that same day.

### SENATOR BANKHEAD 70 TODAY

WASHINGTON, Sept. 13.—Friends and colleagues of Senator John H. Bankhead of Alabama today congratulated the southern statesman on completing the seventieth life milestone. Senator Bankhead is a veteran of the civil war. He suffered three serious wounds as a soldier in the confederate army. He is a farmer when at home, and describes himself in the congressional directory as "self educated." He has been in public life since 1870.

**Show Indians to Be Protected.**  
WASHINGTON, Sept. 13.—Rights of the Indians with the Buffalo Bill Wild West Show, which stranded in Colorado, will be protected by the federal government in the bankruptcy proceedings begun at Trenton, N. J. Attorney General McReynolds instructed J. Warren Davis, United States attorney at Trenton, to look after the interests of the wards of the government.

### WILL INVESTIGATE PULLMAN METHODS

SAN FRANCISCO, Sept. 13.—The Pullman company has been called on carpet by the California railroad commission, which issued an order to the company to appear November 19 and explain its "practices, rules and regulations." Complaints against the mode of operation have been made from time to time with the commission, and the present order was made by the board of its own volition. It wants to know something about certain of the happenings in the management of the sleepers.

Rates will not figure in this inquiry but otherwise the investigation will be a broad one. Among the things which the commission desires to know are these:

To what extent the Pullman company depends on the tips given by passengers to porters as a means of paying the porters a living wage? Why it is that the upper berths are paid when not occupied? Why it is that passengers are frequently told that "there are no lower left" and the next morning on climbing down the ladder out of an upper berth frequently are confronted with a long line of lowers that are not occupied and have not been? Why it is that berths are so frequently sold more than once? What rules govern the porters in making the berths at night and why it is that a passenger can not get them made when wanted? This is only the beginning of the investigation that will be undertaken. Every rule, regulation and practice of the company is to be turned over and officers of the company questioned.

NEW YORK, Sept. 13.—Basing his identification on a birthmark on the shoulder, Francis Day, a real estate broker of Brooklyn, is positive that the decapitated body of the young woman found at Cliff Side is that of his sister, Antoinette Day, 22. The police are inclined to accept the identification. Day told of his sister's acquaintance with a young physician who graduated two years ago from the Long Island college of physician and surgeons. In August, Day declared, members of the family learned that Antoinette was facing motherhood. Two days before finding the body his sister disappeared. The police are searching for the physician.

### KLEIN WILL NOT REMOVE OFFICERS WHO DO DUTY

NEW YORK, Sept. 13.—Acting Mayor Adolph Klein who ascended to his office at the decease of Wm. J. Gaynor on board the liner Baltic, announced today that he would not remove a single city officer who does his duty, despite the fact that Gaynor was a democrat and Klein a republican. Klein would not say whether he would accept the mayoralty on the Gaynor ticket but admitted that his sudden promotion had aroused his political ambition.
