NEWS OF FARM AND RANGE

FIRST WOOL SALE PILOT ROCK MAY 21

BUYERS NOW SEEK EASTERN OREGON WOOL WITH LITTLE SUCCESS.

Representative of Koshlands Now in Lake County—Condition of Eastern Market Still Strong With Stocks Low.

If present arrangements are adhered to the eastern Oregon wool sale days will start at Pilot Rock on Thursday May 21 with a sale at Echo the following day and a sale in Pendleton Saturday, May 23.

As arranged by the woolbuyers the following are the sales days at the different points for the coming season:

- Shaniko—Thursday, June 4, Friday, June 19, Thursday, July 9.
- Pilot Rock—Thursday, May 21, Monday, June 15.
- Echo—Friday, May 22.
- Pendleton—Saturday, May 23.

- Baker—Saturday, May 6, Thursday, July 2.
- Ontario-Vale — Monday - Tuesday, June 2, 3, 9.
- Condon—Wednesday, June 17.
- Madras—Tuesday, June 23.
- Joseph—Tuesday, June 30.
- Enterprise-Wallowa — Wednesday, July 1.
- Madras-Bend — Tuesday, July 7.

At this time there is considerable interest over the fact buyers are endeavoring to contract eastern Oregon wool in advance of the shearing season. Efforts have been made to buy wool in Baker and in Morrow counties and a report from Lake county shows that a representative of Koshland Bros. is now in that section.

The following report from Boston shows the state of the eastern wool market:

Sentiment in commercial and industrial channels remains optimistic and evidences on improving conditions accumulate. This is particularly true of wool, sales of which continue large at advancing prices. A material reduction has occurred in supplies at all seaboard markets since the opening of the year, and in some instances stocks are now scarce.

OHIO STATE CO-EDS DECIDE ON SIMPLE LIFE

COLUMBUS, Feb. 20.—The co-eds at Ohio State University have returned to the simple life. After today the first year girls will no longer have their heads in a whirl as the result of "rushing" parties. Acting under the direction of the newly established board of censorship, the Woman's Pan-Hellenic Association, a university organization, adopted these resolutions: "We will accept only the moderated forms of the standard dances, barring all conspicuous forms. We approve of simplicity of dress for formal functions and greater simplicity in rushing. There shall be one week of rushing, each sorority giving one party, the cost of which shall not in any case exceed \$50. We are resolved to do away with the expense and fuss of former years."

In anticipation of a large volume of business for the coming season of 1914, Messrs Harris & Sons, owners of the Milton Box factory, have added considerable room to their factory, and doubled the capacity of the plant over what it was able to turn out last year.

LA GRANDE BOYS WIN FROM LOCALS AFTER HARD GAME

PENDLETON HIGH CHARGES REFEREE WAS UNFAIR IN CALLING FOULS.

In a rough and hard fought game in the high school gymnasium last evening, the Pendleton high school boys were defeated by the La Grande high school quintet by a score of 15 to 19. As a result of an alleged unfairness on the part of Referee Woods of La Grande, the local players and their backers are sore to the core. Pendleton's weakness was in basket-shooting. Had the players been able to convert one of every four of their chances into a goal during the first half, they would have rolled up a lead that would have been hard to overcome.

La Grande shot the first basket but Peters soon evened up the score by a pretty shot and then put his team in the lead by another successful throw. The first half ended 7 to 6 in favor of La Grande and it was still anybody's game.

The local boys make the charge that Referee Wood refused to call fouls for roughness, holding and pushing on the part of the La Grande players but that as soon as the Pendleton players tried the same tactics, his whistle began to sound. In the last half Otto Houser went in to officiate as umpire and refused to permit the roughness of the visitors. However the high school boys claim, Woods always sounded his whistle when Houser did and made every foul called by the latter a double one. However this may be, it is certain that Woods did call many double fouls in the last half and called considerably more fouls on the Pendleton boys than the La Grande players in the first.

Peters was the brilliant star for Pendleton, scoring every one of the ten points, but he was ably assisted by Hampton at forward, Siebert at center and Russell, Straughn and Kerrick at guards. Schofield, one of the La Grande forwards, was the best point maker for them. He made eight points. Carpy, the other forward, scored six Stoddard, a guard two, and Oliver, sub-guard, two.

D, Oregon Volunteer Infantry, organized in this city during the Spanish-American war, is here today looking up his one-time comrades, many of whom he has not seen since the company was mustered out nearly 16 years ago. Mr. Wood is now living in Boise. He returned to the Philippines several years after the war with a shipment of horses and intended locating there but after eight months returned to America.

Baker Boy Gets Appointment

Irving Rand, son of Mr. and Mrs. John M. Rand of Baker, is the winner of the principalship appointment to the U. S. naval academy by Representative N. J. Sinnott. The examinations for the position were conducted in this city and in Klamath Falls under the supervision of Supt. J. S. Landers. He graded the papers without knowing whose they were and the result showed that the Baker applicant stood higher than any of the other four. One of the Klamath boys wins the position of first alternate. The successful candidate is 17 years old. Before officially receiving the appointment he must pass the entrance examinations to be held April 21.

Children Must Walk Hereafter

With the completion of the Matlock (Star) street bridge to the point where pedestrians may pass over it, the school board has decided to discontinue the services of the auto truck which has been hauling the smaller children from this side of the river to the Lincoln school. The bridge will make the school accessible to most of the children without necessitating a long walk. While the approaches of the bridge have not been completed, temporary inclines have been built so that the children will be enabled to pass over without danger.

CITY MOTOR CAR COMPANY OPENS ITS PLACE TODAY

The City Motor Car Co., David H. Nelson, proprietor, opened for business today in the reconstructed Schaefer brick block on Cottonwood street, between Court and Alta, and while there is considerable work yet to be done before everything is as planned, the company is ready now to receive cars for storage. Carpenters and painters are this afternoon putting the finishing touches to the main floor of the building.

When completed, the company will have a total floor space of 10,500 square feet. It will be divided among three different floors but an elevator will make each easily accessible. The basement and street floor will be used exclusively for the storage and display of machines, while the upper story will be used as a machine shop.

On the street floor, an office has been built as well as a reception room with toilet, hot and cold water and other accommodations for women exclusively.

3 Cent Law Invalidated

PHOENIX, Ariz., Feb. 21.—Arizona's 3-cent railroad fare law, enacted by the last legislature, is invalidated by a decision of the state supreme court, which holds that only the state corporation commission has the right to make rules or regulations governing public service corporations. Attorney General Bullard at once instructed that the railroads and other public service corporations be cited before the corporation commission, which will be asked to issue orders coincident with the displaced law.

Bill Aimed at Fashions

ANAPOLIS, Md., Feb. 21.—Representative Snowden introduced a bill in the Maryland house of delegates to prohibit the wearing by girls and women of high-heeled shoes and slit skirts and also the prohibition of such dances as the turkey trot, the bunny hug, the rango and the loop the loop.

The bill prescribes that money collected from fines for violating its provisions be used to educate girls how to dress decently.

Babies Tossed from Fire

RAYMOND, Wash., Feb. 21.—Catching his two babies as they were thrown from the burning home through a window above by his wife who then jumped and was caught by him, E. D. Knuth, who had dropped from the window, saved his family by a narrow margin when his home in Riverdale was destroyed.

JACKSON, Mich., Feb. 21.—The lower house of the Mississippi legislature adopted a resolution congratulating United States Senator Gore of Oklahoma, "upon his happy deliverance from the snares of political enemies and the triumphant vindication of his spotless name."

Senator Gore is a native of Mississippi and was at one time in the lower house of the legislature.
