There was not enough stuff available in any line at North Portland today to test the strength of the trade. There was an entire absence of hogs, no arrivals being shown in the local yards for 48 hours or since Monday when the run was disappointing.

The sharp drop in the hog market prices all through the eastern trade today indicated that killers there were getting sufficient stock to take care of their immediate orders, therefore eased up values somewhat.

This is expected to affect the local trade but just how much remains to be seen. The fact that local hog offerings are somewhat below actual requirements of killers may cause the trade there to become entirely independent of the eastern control.

At Chicago there was a loss of 15 to 20¢ in the hog market today with tops at \$9.70.

Kansas City hog market was weaker with a loss of 25¢. Tops at 9.65. Omaha hog market was weak with a similar loss. Tops at \$9.10.

Cattle Market Is Weak.

Only weakness is showing for cattle at North Portland. While there was only one load reported in the yards over night, killers have been holding a fair surplus for some time and they are trying to get these out of the way before encouraging further shipments.

At Chicago there was a weak tone in the cattle trade for the day; prices 10 to 15¢ lower.

NEW YORK, Aug. 12.—Nap Rucker, who for years has been the sensation of the Brooklyn Dodgers, has been told by his physicians that owing to the injury to his arm sustained early in the season he may never be able to pitch another game of baseball. Rucker, who came from the same team down in Georgia that bred Ty Cobb, became a member of the Brooklyn team in 1905 and has been with them ever since. His absence from the game this season has been a serious handicap to the Dodgers. Neither Rucker nor Ragon have been able to live up to the pace Rucker set.

Broomhill Crop Advice.

Austria-Hungary—Threshing has practically stopped, as the weather is unfavorable, it being wet and labor is scarce. The crop was originally placed at about 42,000,000 bushels under that of last year and even now much of the grain will not be gathered.

Russia—Crop accounts of spring wheat are very unfavorable and the disappointment is increasing as the threshing and harvesting advances. Notwithstanding reports to the contrary, it is accepted everywhere that food supplies are light and this is being further augmented by the position of all crops which are awaiting harvesting and threshing and the scarcity of labor which will result in a large percentage of the crop remaining ungathered.

Italy—Prices have advanced strongly since the beginning of the week, both for hard and soft wheat, but actual buying is limited.

WAKE UP THE PASTOR SO THEY CAN MARRY

COLORADO SPRINGS, Aug. 12.—Joycewood T. Jordan of Denver and Miss Corinne Cowgill, a Colorado Springs milliner, were married here after getting a judge and a minister out of bed.

Jordan's failure to catch an earlier train than one which arrived here shortly after midnight and a determination to be married before noon was the explanation he gave for the unusual wedding.

Jordan's determination was carried out only through courtesy of County Judge E. E. Sheldon, who, after getting up at 1 a. m. and procuring a marriage license for the pair, assisted them in getting the Rev. Samuel Garvin, pastor of the First Presbyterian church, from bed fifteen minutes later, who performed the ceremony. The couple were accompanied by Mr. and Mrs. W. R. Norris of Colorado Springs.

WIFE'S MOTHER SCORED FOR FAMILY ROW

TULSA, Ok., Aug. 12.—That a man's wife's family have no business to pay him a visit without first being invited, and should they come uninvited and not behave it is not a breach of the peace for the aggrieved husband to order them out of the house was a ruling of Municipal Judge Clark.

J. A. Allen was favored a leniently visit by his mother-in-law, who came without invitation. After they had been guests in the Allen home for some time a quarrel arose. According to Allen his relative became very abusive and he ordered them to leave in language that could not be misunderstood. Thereupon the mother-in-law had him arrested for disturbing the peace.

Allen was acquitted when the facts in the case were brought out and his unwelcome guests were roundly scolded by the court.

Seamen Will be Examined.

WASHINGTON, Aug. 13.—Seamen will be examined for admission in the United States the same as any other applicants, according to instructions the department of labor has sent to all immigration officials on the Atlantic coast. Immigration authorities will confer with steamship officials at all Atlantic ports and endeavor to obtain their full cooperation in the enforcement of the new regulations.

HEAVY ACTING MARKET FEATURE AT CHICAGO

CHICAGO, Aug. 13.—It was a heavy acting market in wheat all day with certain cash and elevator people inclined to press the selling for September. Market had a strong rebound of 1-1/4¢ from an early break of 2-1/4 to 2-1/2¢. On a second dip two hours later, the market went nearly as low as before and each dip was followed by a rather prompt rally.

Outside markets were at times weaker than Chicago. Minneapolis December price was 2-1/4¢ lower for the day. Error in the Kansas City quotations caused a flurry of selling at one time during the morning. The argument on the selling side of wheat is the absence of any reasonable chance for a revival of export business, the continued liberal run of winter wheat to this market, prediction of hedging sales against spring wheat movement in the near future and the attitude of some of the cash and export houses in putting long wheat into the market.

At Minneapolis the cash wheat premium was 1¢ less than on previous days. This was offset by flour shipments of 66,000 barrels for the day and 240 cars of wheat taken out of elevators.

Bradstreet's weekly report gave an increase of 6,138,000 bushels in United States and Canadian wheat stocks, while the amount afloat and in Europe was given as a decrease of 6,490,000 bushels. Only cash business here was 60,000 bushels to mills.

Corn proved to be the most important speculative market on the floor for the day, and the feature was the great strength displayed in the September on late trading when that month was advanced to 50 1-4¢ and closed at 80¢.

PORTLAND, Ore., Aug. 13.—Pacific northwest millers, while reporting no business in the export flour market, are quoting an advance generally of 20¢ a barrel in the price of export straight and cutoff in addition to the 20¢ advance forced in patent yesterday.

While no sales are being confirmed because of the extreme value being asked and the inability of the trade to make proper connections in a financial way, leading millers here are today firmly holding their club straight at \$3.90, with bluestem cutoff at \$4 generally.

From the present indications it looks as if this price on export, while considered high by the orient at this time, will really look cheap to all within a short time owing to the upward swing of prices in the wheat market.

Although only nominal business is reported, as high as 86¢ is reported bid for club wheat in the interior, basis tidewater track delivery. This is an advance of 1-2 to 1¢ a bushel over the previous bids made by the same parties.

Patent flour business is beginning to show an increase. Since the advance of 20¢ a barrel was named yesterday there has been much more inclination among buyers to take hold, especially as further advances are not only likely but probable.
