Marriage License Issued.

During the past two weeks the number of Indian women on the reservation has diminished greatly. Many have gone into the hills in search of huckleberries, the crop of which is unusually short this year, and many others have been migrating to the Yakima country to assist in the harvest of hops.

Kelly May Become Federal.

Pitcher Ed Kelly, formerly of Walla Walla, and now with Seattle, may get a berth in the Federal league next season, report having it that he has received three offers from clubs of that organization. He was given a tryout with Boston last spring and, when turned back to the Northwest, had offers from two Federal clubs.

Attorneys Sue Mrs. White-Orey.

Will M. Peterson and R. L. Ballard, who have acted as attorneys for Mrs. Jean C. White-Orey and her husband, James O'Rey, in their recent cases in police court, today filed suit against them for \$150 alleged to be due on a note and had her residence property attached. Learning that the two were planning to leave the city on the afternoon N. P. train, they filed the suit this morning and secured personal service upon them before they departed for Seattle.

Howard Judge at Round-up Again.

C. F. Howard, who has acted as one of the judges at the last two Round-ups, will act in the same capacity this year, the directors having just concluded negotiations with him. Howard is noted as one of the best judges of cowboy horsemanship in the world, his long experience as a stockman and his years of connection with Buffalo Bill's wild west show giving him an intimate knowledge of the sport. He is a popular judge with the cowboys also and none of his decisions at the last two Round-ups have been questioned. The Round-up counts itself fortunate in securing his services again. His home is in Pattierville, Colo.

Arrested for Misrepresentation.

Representing himself to be a special agent of Governor West, James B. Gerton of this city, sent to the penitentiary two years ago on a charge of forgery, was yesterday arrested in La Grande by Sheriff Hug and is being held there until word is received from the governor. Gerton is said to have attempted to extort money from several citizens of Cove and La Grande. He told a number of stories, one of them being that he was engaged with Sheriff Hug in a clean-up campaign.

Gerton was arrested here on January 6, 1912, on a charge of forgery, having forged the name of a prominent attorney to a note which he sold to a well known lady. On January 8 he pleaded guilty and was sentenced to the penitentiary from two to 15 years but Judge Phelps granted an application for parole. On November 6 he was rearrested, however, when he secured a gun and threatened to kill a young lady with whom he was infatuated and his parole was cancelled. He was taken to the penitentiary on November 8.

Released on Bail.

Milt Anderson of Helix arrested in connection with the recent holdup near that town, was today released on \$750 bail.

Wayne Chapman, who has been spending the summer on his father's sheep ranch near Lehman Springs, left on No. 17 today en route to Palo Alto, California, to re-enter Stanford university the fall term of which institution opens September 3. He will be a sophomore this year.

Funeral of Mrs. Walker.

Many friends of the deceased gathered at the Baptist church this afternoon at 2:30 to attend the funeral of Mrs. Horace Walker of Stanford, formerly of this city, who died Wednesday after a lingering illness. Interment was made in Olney cemetery.

Completing Echo Building.

James Upton, local contractor, left this morning for Echo where he will complete the construction work of a concrete business building for Bert Mullins. The building will be used as a barber shop.

Clarence Pierce Better.

Clarence Pierce, son of Mr. and Mrs. Ben Pierce, of 591 Maple street, who has been seriously ill for the past several months at the home of his parents is again able to be up and about the street. Mr. Pierce expects to leave soon for the North Powder country on a visit with friends.

Cowboy Fined for Fighting.

Jack Joyce, well known buckaroo, was this morning fined \$10 for assaulting Elmer Turner and the case against the latter was dismissed this morning when it was shown that Joyce was the aggressor. Turner, a police officer, had arrested Joyce once who harbored a grudge against him for it.

City Without Gas.

Due to a break in the gas main of the Pacific Power and Light Co. plant, the city has been without gas this afternoon. The break occurred near the corner of Webb and Thompson streets. The leakage was fast from 6 o'clock this morning and by noon there was practically no pressure. The company has had a force at work all day repairing in a manner which will prevent a repetition of the accident and expects to give consumers gas by supper time. The accident to the gas plant explains the delay in the publication of the East Oregonian.

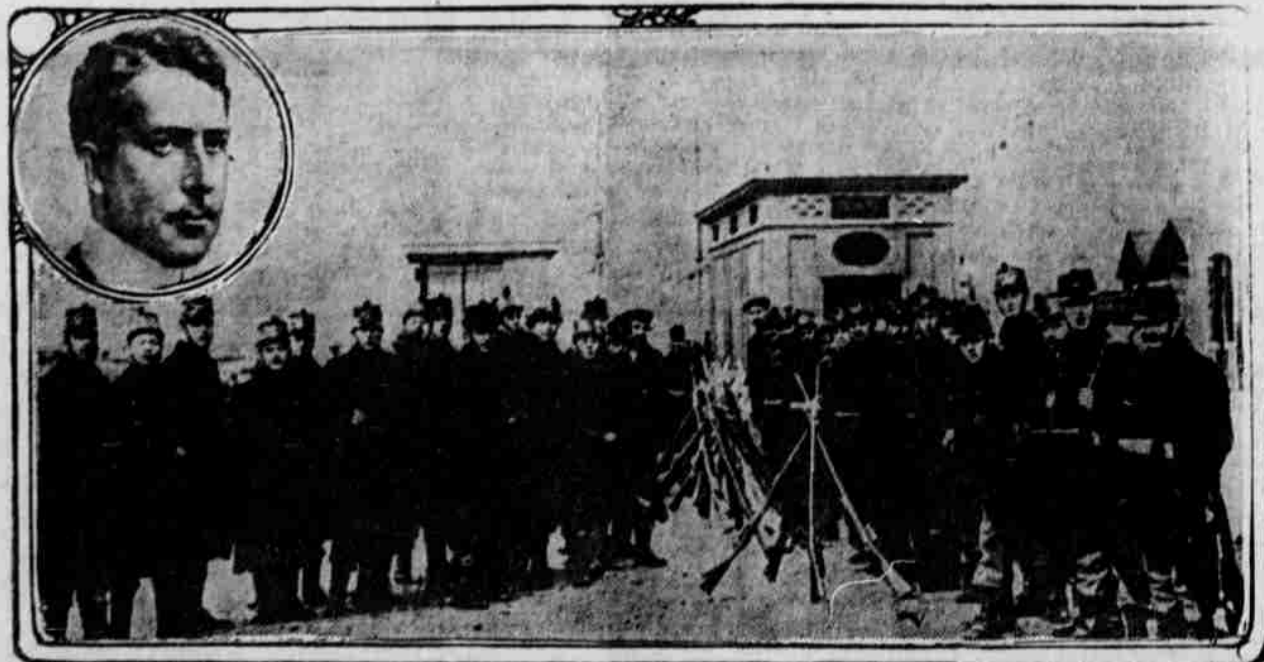

Library News

At a recent meeting of the library board it was voted to use one hundred dollars toward binding the accumulated files of magazines. So far it has been very difficult to keep the separate magazine numbers in good shape for quick reference as they have been on open shelves where all readers could get at them and, if selected, were hard to find again.

During this week nearly all the time of the library staff has been spent in making up the volumes ready for the bindery. It is found that several numbers of some of the periodicals are missing, and will be needed before certain of the volumes can be bound.

It is not surprising that those issues have occurred during the period of years covered and with this abundant material. From now on, the volumes will be sent for binding twice each year which will greatly reduce such losses.

There are no books more needed in high school and club reference

study than files of bound magazines and it is expected that such study will be much facilitated during the coming winter.

Usually the public library offers lists of new books for its readers, over thirteen hundred having been added to the library so far this year. 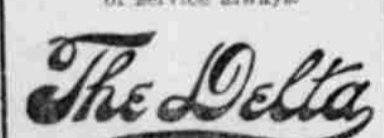
