CHICAGO WHEAT RISES

CHICAGO, Oct. 14.—Wheat options closed with an advance of 3-4c for December and 7-8c for May. At the opening December was unchanged and May 1-2c better than Monday.

Shipments of wheat from North America this week totaled 8,225,000 bushels, corn 235,000 bushels and oats 1,241,000 bushels.

Broomhall called the following from Liverpool regarding foreign conditions:
Austria-Hungary—The import duties on all grains have been suspended, and the use of corn by distillers is forbidden. Prices for all commodities are very bullish and advancing steadily.

France—Much of the harvest in the war zone has not been gathered. Preparation for the new crop is very slow, and holders of wheat continue to sell freely, fearing further invasion.

Russia—Weather is unfavorable over a large area, and crop preparation further interfered with. Labor and horses continue scarce. Closing of Dardanelles has eliminated shipments.

Argentina—Weather is fine, and wheat is making satisfactory progress.
